In consideration of HOUSE BILL 2240 RELATING TO THE OFFICE OF HAWAIIAN AFFAIRS

The Department of Land and Natural Resources (Department) does not take a position on House Bill 2240 which proposes the transfer of the functions and duties of the Department's State Historic Preservation Division (SHPD) relating to Hawaiian burial sites to the Office of Hawaiian Affairs (OHA) and instead, defers to OHA on the feasibility of this matter. Should the measure be enacted, the Department stands ready to work with OHA to ensure a smooth transition of the burial site functions of the Department to OHA.

The Department notes that currently the Culture and History Branch of SHPD reviews burials treatment plans, genealogies and staffs the burial council. It also participates in 106 consultation and is responsible for outreach and education under our Federal grant. The Department requests that it be allowed to maintain positions in this Branch so as to meet our federal requirements.

The Department recommends the following changes to the bill to clarify the roles of the Department and OHA:

- Page 15, line 8—clarify who has responsibility for the inventory of Native Hawaiian remains. The Department prefers this responsibility go to OHA to be consistent.
- SECTION 12, Inadvertent burials. This section need to clarify who has responsibility for the initial call, and determines jurisdiction.
- The Department suggests that a section on rulemaking for OHA be added.

- (1) The bill uses the term "of native Hawaiian origin" at p. 5, ln. 19-21, p. 8, ln 8-11, p. 9, ln. 7-9, p. 10, ln. 14-15, p. 11, ln.5-7, and p. 19, ln.13-15, but does not set forth a definition of the term "of native Hawaiian origin." To eliminate confusion, a definition of that term should be included.
- (2) The bill uses the term "prehistoric or historic burial site that may be associated with the native Hawaiian people" at p. 6, ln. 19-22. As with the concern set forth in paragraph 1, above, the term "associated with the native Hawaiian people" is not defined. To eliminate confusion, a definition of that term should be included. In addition, it is unclear whether the use of the term "associated with the native Hawaiian people," as opposed to the term "of native Hawaiian origin," has any significance.

The Kawaihapai Ohana is recognized as a Native Hawaiian Organization (NHO) by the Department of Interior (DOI). Part of its Kuleana (mission statement) is to Malama Iwi Kupuna with an emphasis on the Northwest Coastline of Waialua Moku encompassing the Ahupua'a of Kamananui, Mokule'ia, Kikahi, Auku'u, Kawaihapai, Kealia and Ka'ena.

The Kawaihapai Ohana opposes HB 2240. The problem's regarding the State Historic Preservation Council (SHPD) is internal and now striving to get back on track. A major setback is the lack of funding SHPD receives especially this legislative session due to furloughs and therefore, adequate filling of positions can't be accomplished which puts a great load on personnel resulting in back logs.

The State Historic Preservation Division (SHPD) has made some progress and reinterment of Iwi Kupuna have occurred in a timely manner with a much more inclusive participation from Lineal and Cultural Descendants whereas it wasn't.

The Native Hawaiian Historic Preservation Council (NHHPC) is an advisory group that provides the *Board of Trustees* regarding cultural matters and has a time frame of at least 3-4 meetings before an agenda item is passed. I'm sure many of us wouldn't like this delay be added on to the *Iwi Kupuna* waiting for reinterment.

Although the intent of HB 2240 was done in good intent, my overall view will have to oppose HB 2240. Mahalo nui loa.

Dear Chair Carroll, Vice Chair Shimabukuro and Members of the House Hawaiian Affairs Committee:

I am presently the Chair of the Maui/Lanai Islands Burial Council and have been for the last 3 years. I have been a member of the Council since its creation in 1990 and prior to that involved with the Burials of Honokahua. Because of what happened at Honokahua, the Burial Law was created.

Since the Lingle administration came into office, new directors and personal were hired in the Historic Preservation Division. The quality of service dropped and many burials were overlooked and ignored because the administrators failed administer the law. At a Burial Council meeting here on Maui, Nancy McMann, and the Assistance Administrator of the Burial Sites Program admitted that "the Historic Preservation "Is broken".

I truly support this bill because OHA would be the proper agency to handle this Hawaiian Cultural issue and the program would get the proper funding to protect and preserve our lwi 'Kupuna.
