Thank you for the opportunity to provide testimony on this bill which would make provisions for the transient homeless to return home.

I need to STRONGLY OPPOSE this bill and offer comments for consideration. The issue is sending back the "transient" homeless who at one point sought the idea of coming to Hawaii for our climate not realizing that the cost of living here is not attractive as most US continental states are.

#### RELATING TO THE HOMELESS

House Bill No. 2280 adds a new section to Chapter 184, Hawaii Revised Statutes, to establish a Return-to-Home Program for the homeless, creates the Parks for Homeless special fund within the State treasury, and appropriates \$100,000 from the special fund to pay for program costs and the hiring of necessary staff.

As a matter of general policy, this department does not support the creation of any special fund which does not meet the requirements of Section 37-52.3 of the Hawaii Revised Statutes. Special or revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. It is difficult to determine whether the fund will be self-sustaining.

Furthermore, given the State's current financial situation, it does not appear fiscally prudent to create a program to expend funds to pay for the homeless to be returned to their families in other states.

In consideration of HOUSE BILL 2280 RELATING TO THE HOMELESS

House Bill 2280 would establish a return-to-home program for the homeless. The Department of Land and Natural Resources (Department) comments are limited to SECTION 2 and defers to the appropriate agencies on all other parts of the bill. The Department does not support the establishment of a Parks For Homeless Special Fund within Chapter 184, Hawaii Revised Statutes (HRS).

Chapter 184, HRS, relates to State Parks and Recreation Areas. State parks are areas of historic interest or immense scenic beauty. Given that they are visited by approximately 6 million tourists per year, the Department does not think state parks are appropriate places to house the homeless. As such, the Department believes the State needs to increase resources to better manage the existing parks under our control, and the Department has launched an ambitious effort to do so under the Recreational Renaissance initiative.

Good Morning Chair Rida Cabanilla, Vice Chair Pono Chong and members of Housing Committee,

My name is Netra Halperin. I have worked extensively as a social worker on Maui. The purpose of the return to home program is to assist homeless people from other states voluntarily return to home. This isn't meant to solve the entire homeless problem in the state of Hawaii, only the specific population that came to Hawaii with dreams of Hula girls serving Mai Thais on the beach and has then encountered the harsh reality of homelessness in Hawaii. It is meant for the out-of-state homeless that already have family, friends or other support services in the place where they are requesting transport to. This program will work with homeless services, local airlines and charter companies to obtain tickets. It will get participants ready for travel and also follow up one month later. This will cost between \$400 and \$600 per person. On the other hand it now costs the State of Hawaii between \$30,000 and \$35,000 per year, per homeless person in services, which include extensive hospital stays and medical care, shelter, food and social and other support services. This doesn't even include children incurring developmental delays with later costs. This bill would save the state of Hawaii thousands of dollars and much unnecessary suffering.
