TESTIMONY BY GEORGINA K. KAWAMURA DIRECTOR, DEPARTMENT OF BUDGET AND FINANCE STATE OF HAWAII TO THE HOUSE COMMITTEE ON AGRICULTURE ON HOUSE BILL NO. 2294

RELATING TO AGRICULTURE

House Bill No. 2294 1) changes the designation of the pest inspection, quarantine, and eradication service fee from a service fee to a service tax; 2) designates the Department of Taxation to collect the tax; 3) repeals the certification services revolving fund, permit revolving fund, and micro-organism import certification revolving fund; and 4) diverts fees currently deposited into the aforementioned revolving funds and transfers the three revolving fund balances as of June 30, 2010, into the pest inspection, quarantine, and eradication special fund. This bill does not include an appropriation. As such, no additional expenditures can be made from the pest inspection, quarantine, and eradication special fund and no general fund expenditures are supplanted.

We oppose this bill. As a matter of general policy, this department does not support any special fund which does not meet the requirements of Section 37-52.3 of the Hawaii Revised Statutes. Special or revolving funds should: 1) reflect a clear nexus between the benefits sought and charges made upon the users or beneficiaries of the program; 2) provide an appropriate means of financing for the program or activity; and 3) demonstrate the capacity to be financially self-sustaining. It is difficult to determine whether the pest inspection, quarantine, and eradication special fund would meet these criteria with the amendments made in House Bill No. 2294.
