

Aloha Chair, Vice Chair and committee members,

My name is Sophina Placencia the executive director of Waianae Community Outreach a non-profit agency contracted with the HPHA Homeless Branch Administration to provide homeless outreach and emergency shelter services to individuals and families who are currently experiencing homelessness or at risk of becoming homeless with preference to the Leeward coast communities. Currently as this testimony is being submitted, I have the honor of participating in several conferences on the mainland which targets the homeless population. With that said, I'm OPPOSING this bill and offer comments.

What should be said is, there are several agencies that currently use the housing first model to deal with clients who have types of mental disorders. There is one program who utilizes a version of the 'housing first' model for the homeless community in general which is the agency I represent. The only component that is lacking from that model is the permanency of residents, as they have only 6 - 8 months to be transitioned to either transitional shelters, supportive or affordable housing.

This is a little bit of history that I've learned from the programs in Utah on the housing first model. Mind you the gentleman who created the first Housing First model in New York has worked closely with Utah to get their 3 programs running.

The Housing First Model was meant to create a better flow in services for those unsheltered who were accessing services either through emergency or transitional programs. It solely focuses on the chronically homeless, individuals who have had multiple episodes of homelessness, which are majorly men though some women make up the chronically homeless population. Studies have shown that in shelters prior to using the housing first models, a small

percentage 14% of individuals were responsible for staying longer in shelters and using more than 50% of - due to length and amounts of episodes of homelessness (i.e. more case management time, hospital stays, emergency room visits, jail times, etc.) versus average individual who experiences an unfortunate life event that simply requires a little 'get back on your feet' time. As this small percentage was tracked over a period, the number after a 5 year study, showed this small percentage of individuals accounted for 64% bed use of the shelter systems and resources. (Study of the Road Home Shelter, Salt Lake City, UT) By opening up the bed space occupied by a 'chronically homeless' individual and placing them into a 'Housing First' modeled shelter, 1st created a better flow for those who needed the 'get back on your feet' time in accessing shelter and services then 2nd created a stable and safe environment for those individuals identified as 'chronically homeless'.

The Housing First Programs serving the 'chronically homeless' have experienced less than a 15% (death or extreme circumstance that required termination) turnover rate vs. 60-80% for those in the system temporarily. The Housing First Modeled Program is a supportive permanent housing program in which the clients have the ability to access services when they are ready while providing them with a safe environment by having secured access to shelter, facility being monitored 24hrs, and case management and classes being provided on site. In addition surrounding business and homes have not experience higher number of crimes nor higher nuisances as these programs provide an atmosphere much like that of a gated community in which an individual can remain indoors as there are places to reflect, be entertained, cook, and sleep.

#### TESTIMONY TO THE HOUSE COMMITTEE ON HOUSING

#### **HOUSE BILL 2318 – RELATING TO THE HOMELESS**

My name is Francine Aona Kenyon and I am a deaf advocate. I have dealt with many deaf and hard of hearing people who are homeless and jobless.

I support the intent of the House Bill 2318, Relating to the Homeless, that establishes a 5-year housing first pilot program to be developed by the Hawaii public housing authority and the Department of Human Services for homeless individuals who are chronically addicted or mentally ill.

Per Section 1, Lines 11 to 15, "homeless individuals, especially the chronically homeless, those with disabilities that include addictions and mental illnesses, are extremely fragile." Is a chronically homeless individual a homeless person who has an addiction or mental illness, or both? What about people who are deaf or hard of hearing and homeless? Would they be covered under this bill?

If I had known about all the legislative bills on Homelessness, I would have fought for the rights of deaf and hard of hearing people who have been homeless for over 15 years. The real problem is the shortage of homelessness shelters to serve all the people who are homeless whether they have a disability or not.

This bill seems somewhat neglecting the needs of people who are deaf and hard of hearing and homeless. They are now one of the targeted populations in emergency preparedness. Hurricane Katrina displaced thousands of deaf and hard of hearing people and they became homeless. Also, do you remember the World Trade Center in New York? During the attack no one assisted deaf and hard of hearing people get to safety? Many of the homeless deaf people in Hawaii have migrated to the mainland where there are better opportunities and now have their own homes and financial security.

Most important of all, a deaf member of my church has been homeless for a month and has encountered other deaf and hard of hearing people who are homeless and living on beaches or on the streets. Much to my shock and disbelief, he had told me those people were kicked out of their families' homes because they are UNWANTED by their families and relatives. That is sad.

Please amend the bill to apply to ALL people with disabilities, not only those with addictions or mentally illness so that individuals who are deaf and hard of hearing will be included.

Thank you for the opportunity to testify.

#### RELATING TO THE HOMELESS

Chair Cabanilla and committee members, thank you for allowing me to testify on H.B. 2318. The Department of Accounting and General Services has concerns about this bill because it will require funds to implement that are not in the Administration's supplemental budget. Currently, all homeless programs are operating at their limits. It would be disadvantageous to the State to add the program this bill proposes if it means that some of the existing homeless programs must be reduced or eliminated.

I also note that this bill would establish a "Parks for homeless special fund under Chapter 184, HRS. If moneys in this special fund are not used for State parks, they are misplaced. If the moneys are used for "housing first" costs, which include rent subsidies and services, they should not come from a "parks for homeless special fund". In any case, the costs of the program this bill proposes are not included in the administration's budget.

If the moneys for this bill could obtained without affecting other programs in the Administration's budget a recommended change in the "housing first" process would be to have assertive encouragement of treatment and compliance on the part of residents.

In consideration of HOUSE BILL 2318 RELATING TO THE HOMELESS

House Bill 2318 would establish a five-year housing first pilot program to address the chronically homeless population. The Department of Land and Natural Resources (Department) comments are limited to SECTION 2 and defers to the appropriate agencies on all other parts of the bill. The Department does not support the establishment of a Parks For Homeless Special Fund within Chapter 184, Hawaii Revised Statutes (HRS).

Chapter 184, HRS, relates to State Parks and Recreation Areas. State parks are areas of historic interest or immense scenic beauty. Given that they are visited by approximately 6 million tourists per year, the Department does not think state parks are appropriate places to house the homeless. As such, the Department believes the State needs to increase resources to better manage the existing parks under our control, and the Department has launched an ambitious effort to do so under the Recreational Renaissance initiative.
