Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to comment on House Bill No. 2393. The purpose of this bill is to establish an agricultural product processing incentive program to assist producers in processing agricultural products grown in the state.

The Hawaii Department of Agriculture (HDOA) opposes this measure as we believe that this is not the appropriate time to create a new program and to further reduce state revenues by providing generous tax credits which exceed those provided for other established agricultural initiatives including Important Agricultural Lands.

It is unclear at this time how many producers would benefit or would be encouraged to establish an agricultural product processing operation and whether the anticipated annual fees will offset the loss in tax revenue or even pay for program expenses.

HB 2393 RELATING TO AGRICULTURE

Chair Tsuji and Members of the Committee:

Hawaii Farm Bureau Federation on behalf of our farmer and ranch families and organizations support HB 2393 establishing an agricultural product processing incentive program.

One of Hawaii agriculture's major shortcoming is the lack of value added processing. Most farmers on the mainland have value added products that can be produced from off grade or surplus products. This provides an additional revenue source that helps increase farm/ranch viability.

A major reason has been the small size of our farms. Value added production often involves major capital investments beyond the reach of our smaller farmers. Additionally many of our farmers and ranchers are just that ...they farm and ranch. Value added processing is beyond their capacity. Opportunities lie in partnerships with other small businesses. In these cases, these operations may be in industrial areas or other non-agricultural areas. Most of the State is within an Enterprise Zone. However, most populated areas, including business districts fall outside of the Zone. This measure seeks to incentivize agricultural value added ventures by providing businesses with the same EZ benefits even if they are not within the zone.

HFBF believes this is a worthwhile means to bring investment into agricultural value added ventures and strongly supports the measure.
