HB 2410 RELATING TO AGRICULTURE

Chairs Tsuji and McKelvey, Vice Chairs Wooley and Choy, and Members of the Committees:

My name is Andrew Hashimoto, and I serve as Dean and Director of the UH Mānoa College of Tropical Agriculture and Human Resources (CTAHR). I am presenting testimony on behalf of Virginia Hinshaw, Chancellor of the University of Hawaii at Manoa (UHM).

HB 448 proposes to establish an agriculture working group to assess agricultural issues in the State to improve the agricultural industry, specifically to establish an agriculture working group to assess the vertical integration of the food industry in the State. The head of the working group is named as the Dean and Director of CTAHR, and the bill names five other participants, including the chairperson the Board of Agriculture or representative, the Executive Director of the Agribusiness Development Corporation or designee, a representative of the Hawai'i Farm Bureau Federation, an agricultural economist, and any other representative from the agricultural industry, to be selected by a majority of the working group.

The University of Hawai'i at Mānoa supports the intent of the bill to assist and improve the agricultural industry, but opposes the bill because it provides no resources for data collection, analyses, and recommendations. All of the participants named in the bill are likewise financially strapped and understaffed, and cannot fulfill the intent of this bill without additional resources. We estimate that the cost for this effort would be \$50,000.

HB 2410: RELATING TO AGRICULTURE

Chair Tsuji, Chair McKelvey and Members of the Committees:

Hawaii Farm Bureau Federation on behalf of our farmer and ranch families and organizations support HB2410, establishing a working group to assess agricultural issues in the State to improve the agricultural industry.

One of Hawaii agriculture's major shortcoming is the lack of value added processing. Most farmers on the mainland have value added products that can be produced from off grade or surplus products. This provides an additional revenue source that helps increase farm/ranch viability.

A major reason has been the small size of our farms. Value added production often involves major capital investments beyond the reach of our smaller farmers. This effort to identify processing opportunities comes at a critical time when farmers need the additional revenue that could be achieved.

To achieve true vertical integration as suggested, it is important that representatives of the food manufacturers and retail market be part of the planning process. It is only with their true by-in that this vision can be realized.

HFBF is also concerned that this is an unfunded mandate. We recognize the importance of the issue but most of the organizations identified are already struggling with budget cuts and reductions in staff. A pragmatic discussion of how the intent of this measure can be achieved along with identification of resources needed should occur as part of the decision making process.

HFBF strongly urges your support of the measure after consideration of the concerns expressed in this testimony. It is a worthwhile project that will contribute to increasing the viability of Hawaii's agriculture.


