Aloha Honorable Committee Members;

HB2410 is an important link in improving local food self-sufficiency. The bill calls for the formation of an agriculture working group established at the University of Hawaii to assess the vertical integration of the food industry in the State, more specifically the development of agricultural products and processing plants. The Taro Security and Purity Task Force 2010 Report to the Legislature also outlines the need for improved supports for small-scale poi and value-added processing facilities. That report also strongly advocates for an improved relationship with the University of Hawaii, Department of Agriculture and other agriculture decision-making bodies, as well as better representation for taro growers in agriculture development discussions. I urge that this bill not be limited to naming the conventional list of agriculture partners of the past, but create the potential for great success by the inclusion in the named core group of new partners who can bring a fresh perspectives and broader representation to the table.

I support HB2410 with the following amendments:

As a member of the Taro Task Force (submitting testimony as an individual), I strongly recommend that the named members of the working group also include: 1. the Chair, or its representative, of the Taro Security and Purity Task Force as an unrepresented but critical partner in the state's food self-sufficiency efforts; and as a group established and recognized by the legislature as representing the taro farming community; and 2. the Chair of the Hawaii Farmers Union. In Maui County, both the HFU and the HFB are at the table in dialogues about the future of food and farming. The HFU rerpesents many small farmers across the state who are not represented by the Hawaii Farm Bureau but are an important link in local food production and processing.
