In Consideration Of HOUSE BILL 2480 RELATING TO HISTORIC PLACES

House Bill 2480 requires the State Historic Preservation Division (SHPD) of the Department of Land and Natural Resources (Department) to report on the state and historical significance of an archaeological site if inadvertently destroyed. In addition to the bill being redundant, the Department has concerns that this bill may infringe on the trights of private property owners.

The proposed new section to Chapter 6E, Hawaii Revised Statutes (HRS), regarding the inadvertent destruction of archaeological sites is redundant as oral history already takes precedence if scientific evidence is not available. Furthermore, if members of an Aha Moku would like to participate in a site visit, there is nothing to prevent them from doing so. However, issues of liability and availability will need to be addressed. Currently, SHPD will often call the Office of Hawaiian Affairs (OHA) for the initial visit and then invite community members if additional site visits are necessary or requested. OHA is also free to make its own recommendations.

The proposed amendment provided in SECTION 3 to Section 6E-2, HRS, would seem to limit archaeological sites to pre-historic native Hawaiian sites. The Department believes this is too limiting. For example, cane and pineapple era ditches are considered archaeological sites. Often cane era structures also incorporate earlier Hawaiian engineering. These items, along with artifacts from Hawaii's many cultures would seem to be excluded from the definition of an "archaeological site" or "archaeological feature."

The proposed amendment in SECTION 4, after item (2) would seem to take away the ability of a land owner to demolish an archaeological site on the Hawaii or National Register. While the Department is not arguing for the destruction of Register listed sites, the Department notes that

Federal law allows for the demolition of registered sites, and Hawaii law has followed national law. The Department also fears that this amendment will have a chilling effect on Historic Register nominations. Many landowners with archaeological sites do not want to list their properties for fear that the state will take away their ability to use their land.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS WITH AMENDMENTS</u> House Bill 2480 which defines an archaeological site or archaeological feature, requires the historic preservation division of DLNR to report on the state and historical significance of an archaeological site if inadvertently destroyed, and provides for penalties for willful alteration or destruction of an archaeological site or archaeological feature on the Hawaii or national register of historic places.

Under current and existing historic preservation law in Hawai'i, there is not enough protection for historical, cultural and archeological sites on private lands. Many of these cultural sites are the last vestiges helping to link 'ohana to their ancestors and to provide important clues and connections which enable the Native Hawaiian community to understand their past and foundation, in order to move forward to a brighter and more productive future.

A constant point of contention is the interpretation and significance assessments of cultural sites. It is important to have a Native Hawaiian input into the process where the integrity, function, and significance of historic sites are assessed to determine levels of protection and preservation. It is important to understand that sites often deemed in severe disrepair or lacking structural integrity are often still quite significant to Native Hawaiians as a source of understanding and ancestral connections.

OHA would proposed that line 17 of the bill be amended to read "such as an aha moku or the Office of Hawaiian Affairs."

HB2480 seeks to help correct the unbalance which has led to the wanton destruction of thousands of historic places, wahi pana and the unique cultural heritage which makes Hawai'i unlike any other place in the world. Thank you for this opportunity to testify.


In addition to the wording of the bill as it stands, I am hopeful that the spirit of this bill will carry forth to make property owners and developers more educated in our culture and not depend solely on their hired archaeological firms to make determinations and conclusions. The cultural input is essential and should work hand in hand with science instead of making the science of archaeology the primary source of knowledge. Much of what we know about our history has been gleaned from a small number of writings. Majority of our history and customs has yet to be translated and interpreted. I believe a much different view will be acknowledged when that is accomplished. However, we must give time for these interpretations to be done and in the meantime move forward cautiously and with preservation and protection as the sole driving force.

I urge the Hawaiian Affairs Committee to vote for this bill.
