House Bill 2488 would increase by 10%, the Conveyance Tax on the sale of luxury homes over \$700,000 to finance the purchase and maintenance of state parks to serve the homeless. The Department of Land and Natural Resources (Department) does not support the acquisition of additional land in state parks for the purpose of this bill.

The Department believes the State needs to increase resources to better manage the existing parks under our control, and the Department has launched an ambitious effort to do so under the Recreational Renaissance initiative. State parks are areas of historic interest or immense scenic beauty. Given that they are visited by approximately 6 million tourists per year, the Department does not think state parks are appropriate places to house the homeless.

The HHFDC <u>opposes</u> H.B. 2488 for the following reasons. First, we oppose the proposed increase in the conveyance tax rate in this bill, especially in light of the fact that the rate was already increased this past year. Second, and more importantly, we are concerned that section 4 of this bill, which proposes that 10 percent of conveyance taxes collected on properties at least \$700,000 in value will detrimentally impact the dedicated revenue stream to the Rental Housing Trust Fund (RHTF).

The RHTF provides "equity gap" low-interest loans or grants to qualified owners and developers constructing affordable rental housing units. The RHTF's sole dedicated financing source is a share of the conveyance tax. At the current conveyance tax rate, we anticipate that the RHTF will receive approximately \$6,000,000 in FY 2010. Unfortunately, it would take at least \$10,000,000 in available funds to fully leverage the State's annual per capita allocation of Federal Low-Income Housing Tax Credits. We are very concerned that additional allocation of conveyance tax revenues to other programs, no matter how worthy, will adversely impact our ability to finance much-needed permanent rental housing for low-income families.

This measure, among other things, increases the conveyance tax on the sale of "luxury" homes over \$700,000 to finance the purchase and maintenance of state parks to serve the homeless.

The Department of Taxation (Department) opposes this measure as an unwarranted tax increase.

### I. THE ISSUE OF PROVIDING HOMELESS SERVICES IS IMPORTANT.

The Department recognizes that providing shelter and services to the homeless is an important issue; however these priorities and projects must be budgeted and prioritized just like every other state expenditure through the use of general funds rather than earmarks and diversions of tax revenues.

### II. OPPOSED TO INCREASING THE CONVEYANCE TAX

The Department is opposed to the conveyance tax increase in this measure because ultimately the increase will merely make property prices more expensive. Taxes such as the conveyance tax will be recovered through the sales price of the property. This will not help in alleviating the already high real property prices in Hawaii.

Moreover, the Department is very concerned with the characterization that a \$700,000 home in Hawaii is somehow "luxurious." It is the Department's understanding that the average single family home in Hawaii costs well over \$600,000. This measure has the effect of unnecessarily impacting ordinary middle-class Hawaii residents struggling to make ends meet. The \$1,000,000 level would be more appropriate.

My name is Jim Tollefson, President of the Chamber of Commerce of Hawaii. The Chamber of Commerce of Hawaii works on behalf of its members and the entire business community to:

- Improve the state's economic climate
- Help businesses thrive

### The Chamber opposes H.B. No. 2488.

The bill proposes to amend Chapter 247-2 HRS by amending the basis and rate of tax imposed in the conveyance tax. The result would be an increase of 10% in the conveyance tax on the sale of homes over \$700,000 to finance the purchase and maintenance of state parks to serve the homeless.

Each year there are various innovative attempts to increase revenues to the State or counties through various fees, exactions and taxes. As the economy continues to deteriorate and tax revenues shrink, there is an inverse relationship in the number of proposals to increase government revenues.

The conveyance tax has been a convenient mechanism in the past to raise revenues perhaps due to the fact there is no organized representative for future prospective buyers of real estate. The conveyance tax should be limited to what it is intended for, which is to cover the cost of recording sales transactions for real estate in Hawaii. There is no rational nexus for the conveyance tax to be used for:

- 1. Acquisition and maintenance of natural resource lands;
- 2. Deposits into the state's Rental Housing Trust fund; and,
- 3. Acquisition and Maintenance of lands in the State's Natural Reserve Areas.

Currently, 55% to 60% of the conveyance tax goes to these programs with the remaining 40% to 45% going to the general fund from which a portion is appropriated to the Bureau of Conveyance.

If these public purposes, as well as the new purpose proposed in this bill, are "priorities" then perhaps existing government funded programs that are not priorities should be eliminated and funds reorganized around the new government priorities. A real priority should be to either efficientize the Bureau of Conveyances and Land Court system or to privatize their activities. Land Court recording delays can now be six months or more. The increased economic activity generated by prompt recordation of subdivisions and other conveyances would act to increase employment in our community and to reduce the number of homeless. This would be a more rational and reasonable public policy decision than simply increasing the conveyance tax to be used for unrelated purposes.

We strongly oppose HB 2488.

BRIEF SUMMARY: Amends HRS section 247-2 to propose the following conveyance tax rates for properties (eligible for a home exemption as well as all non-residential property):

Rate Per \$100	Property Value
\$ .20	\$ 600,000 but less than \$700,000
.22	\$ 700,000 but less than \$1,000,000
.33	\$1,000,000 but less than \$2,000,000
.55	\$2,000,000 but less than \$4,000,000
.77	\$4,000,000 but less than \$6,000,000
.99	\$6,000,000 but less than \$10,000,000; and
1.10	\$10,000,000 and greater.

Proposes the following conveyance tax rates for residential properties ineligible for a home exemption:

Rate Per \$100	Property Value
\$ .25	\$ 600,000 but less than \$700,000
.28	\$ 700,000 but less than \$1,000,000
.44	\$1,000,000 but less than \$2,000,000
.66	\$2,000,000 but less than \$4,000,000
.94	\$4,000,000 but less than \$6,000,000
1.21	\$6,000,000 but less than \$10,000,000; and
1.38	\$10,000,000 and greater

Amends HRS section 247-7 to provide that 10% of conveyance taxes collected under the above rates for properties valued at \$700,000 or over shall be deposited into the parks for homeless special fund before any of the other dispositions are made.

Adds a new section to HRS chapter 184 to establish a parks for homeless special fund into which shall be deposited the designated portion of the conveyance tax. The fund shall be administered by the finance department of any county with a population greater than 500,000 that receives funds under this section, and shall be used to acquire, convert, or maintain parks under the jurisdiction of the department to service the homeless, including providing open structures or shelters to protect park users from the wind and rain, providing basic services such as showers, toilets, drinking fountains, coin-operated washers and dryers, lockers, and providing accommodations for overnight camping, one shopping cart per person for personal possessions, and not more than one small pet.

EFFECTIVE DATE: Upon approval

STAFF COMMENTS: The proposed measure increases the conveyance tax on properties valued at \$700,000 or over, and establishes a parks for homeless special fund which shall be used to transform areas of parks into shelters for the homeless. While the measure proposes another tap of the conveyance tax revenues, it should be noted that as with any earmarking, the legislature will be giving their stamp of approval for another "automatic funding" mechanism for the particular program - the parks for homeless special fund. It should be noted that while funds would be diverted to the fund without any legislative intervention, they will also avoid legislative scrutiny, and it will be difficult to ascertain the effectiveness of the program. It would also be difficult to ascertain whether or not the fund has too little or too much revenue.

Further, while this measure also proposes to increase the conveyance tax rates, it should be remembered that the conveyance tax is one of the least dependable sources upon which to rely for funding with collections rising and falling with the fortunes of the real estate market. Any amount collected under this tax will depend on activity in the real estate market. As the housing market slows down, revenues may not be sufficient to meet the expectations of the fund. If the additional revenues are not sufficient or another "important" program needs funding, will the conveyance tax be increased to generate even more revenue?

While the conveyance tax increase appears to target properties valued at \$700,000, it should be remembered that this schedule also applies to non-residential properties covering everything from a mom and pop supermarket in Waialua to the Ala Moana Shopping Center to the car repair shop in Kaka'ako to the farm lot in Waimanalo. Thus, this proposal makes it even more expensive to do business in Hawaii. At a time when other committees of the legislature are hearing legislation to spur economic activity, this measure does just the opposite. And where do these legislators believe the purchasers of these properties will find the resources to pay these additional funds? Or in the case of businesses, they will have to either charge higher prices for the goods and services they produce or keep their production costs in control which in many cases means paying their employees less.

Moreover, the sponsors of this particular bill probably have never purchased their own home as they seem to believe that those who can afford to purchase a \$600,000 single family are the truly wealthy and capable of withstanding another jerk with a higher conveyance tax. On Oahu, the median price of a single family home has bounced back and forth over the \$600,000 mark. Families purchasing new homes in the Kapolei and Ewa area are paying in the high \$500 thousand range or more. Given the high tax burden already imposed on Hawaii residents, this proposal is arrogant to assume that more money can be extracted from the economy to pay for another state program which obviously has been given little thought insofar as solutions. Thus, this measure represents another grab for money which lawmakers believe will "solve" the homeless problem while truly not understanding the economic crisis that has caused so many to be homeless.

If the legislature deems that the provision of homeless shelters is of such a high priority, then it should maintain the accountability for these funds by appropriating the funds as it does with other programs. Earmarking revenues merely absolves elected officials from setting priorities. When the legislature dipped into housing special funds to maintain funding for programs like education and social services, that was poor tax policy. So, for example, because the housing market slowed in 2008, the rental housing trust fund realized only \$21 million in FY 2008 as compared to the \$23 million it received in the

prior year. If asked, housing officials would probably say that is not enough to carry out their mandate, thus the program is underfunded. If the money were appropriated, lawmakers could then evaluate the real or actual needs of this particular program.

If the legislature deems any of the programs for which conveyance tax revenues are earmarked to be such a high priority, then it should maintain the accountability for these funds by appropriating the funds as it does with other programs. When general fund revenues wane, will elected officials once more dip into special funds or repeal this earmarking or in the alternative raise taxes? Earmarking revenues restricts the flexibility in utilizing these revenues. This measure underscores the unwillingness of legislators to be held accountable for their actions.

Aloha Chair Cabanilla, Chair Ito and Members of the Joint Committees:

I am Craig Hirai, a member of the Subcommittee on Taxation and Finance, here to testify on behalf of the Hawai'i Association of REALTORS® ("HAR"), the voice of real estate in Hawai'i, and its 8,800 members in Hawai'i. HAR **opposes** H.B. 2488 which increases by 10% the Conveyance Tax on sales of real property over \$700,000 to finance the purchase and maintenance of parks to serve the homeless on Oahu.

As proposed, the Conveyance Tax increase will apply to the conveyance of multi-family rentals, land for residential subdivisions, mixed-income and multi-use properties, commercial properties, resort properties, and agricultural lands, as well as condominium and single-family homes. HAR believes that, while the parks for homeless special fund may have value, the Conveyance Tax increases set forth in H.B. 2488 will again increase the already high cost of housing, living and doing business in Hawaii.

In 2005, the Conveyance Tax was increased on 1) the sale of realty for all transfers or conveyance of realty or any interest (i.e. commercial, timeshare, agricultural, industrial, etc, and condominium or single family residence for which the purchaser is eligible for a county homeowner's exemption) and 2) the sale of a condominium or single family residence for which the purchaser is ineligible for a county homeowner's exemption.

In 2009, the Legislature increased the Conveyance Tax on 1) the sale of realty from 30 cents per \$100 (.30%) for properties over \$1,000,000 to a maximum of \$1.00 (1%) per \$100 for properties over \$10,000,000 -- an increase of over 333%, and 2) the sale of a property ineligible for a county homeowner exemption from 30 cents per \$100 to \$1.25 per \$100 (1.25%) -- an increase of over 416.66%.

Section 3 of H.B. 2488 increases the Conveyance Tax by an additional 10% across the various Conveyance Tax brackets that were just drastically increased in 2009.

The Conveyance Tax applies whether or not a property is sold at a gain or a loss and (as opposed to the Real Property Tax.) Please note also that the Conveyance Tax under H.B. 2488 has the effect of reducing the value of a \$10,000,001 commercial property to a business owner by \$138,000 (the 1.38% Conveyance Tax on the sale of property ineligible for a county homeowner's exemption).
