**HOUSE BILL NO. 2503  
RELATING TO THE ENVIRONMENT**

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to testify on House Bill No. 2503 which is an Administration proposal. The purpose of this bill is to authorize expansion of the permissible users of the Pesticides Use Revolving Fund to include personnel costs for compliance monitoring. The Hawaii Department of Agriculture (HDOA) strongly supports this measure.

Compliance monitoring surveillance is an integral part of ensuring protection of the public and the environment. Conducting actual use inspections of agricultural and non-agricultural entities is the most important component of compliance monitoring; detecting violations before they occur rather than responding to post-use complaints. Compliance monitoring also includes inspections in the marketplace, at pesticide distributors, and at the ports of entry.

Management of the Pesticides Program is challenging with the absence of a Branch Manager. While the Division Administrator has temporarily assumed the

responsibility of acting Branch Manager, more active and direct oversight is essential in assuring that the program continues in the right direction to provide services to protect the public and the environment.

The ability to fund compliance monitoring personnel including the Branch Manager through the Pesticides Use Revolving Fund will provide the Department with the flexibility to maintain services necessary to provide adequate monitoring in this important area.


**HB 2503 Relating to the Environment**

Chair Tsuji and Members of the Committee:

I am Tim Lyons, Executive Director of the Hawaii Pest Control Association which represents 98% of all the companies involved in structural pest control. We have reservations about this bill.

Actually, we do not oppose the bill and its intent in that it provides and allows for money to be expended from the Pesticides Use Revolving Fund for other than educational purposes. We do believe that proper enforcement leads to proper applications. Proper applications leads us to less problems with any of the products our members use. Our reservation is entirely based on all of Section 1. Monies paid by pest control manufacturers into the Pesticides Use Revolving Fund are mixed in with those that are of the type that are referenced in Section 1. We think it is important to note that that is not the only money that is in that fund.

We have already been "slighted" as far as educational programs go and the Department provides absolutely no educational programs for this industry. When this program was first created it was "sold" to the industry based on the fact that it would only be used for education and not for enforcement. We understand the tough times that the Department is in and therefore, we can understand the need for additional revenue measures. We would however, like to request that there be a five (5) year sunset clause so that this matter will be automatically reviewed since the money was originally intended only for education but is now needed elsewhere; in five (5) years we should look at it again to see if it is still needed or if educational programs can receive the money after all. Education and training workshops lay the very foundation of enforcement measures. If people are trained and educated properly, you will need less enforcement and it is less painful for everyone involved.

So again, while we support the intent of this bill we hope that you will clarify in the Committee Report that the efforts funded should not be used for just those in Section 1, in fact, we hope you will delete that entire section.
