HOUSE BILL NO. 255 RELATING TO AGRICULTURE

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to comment on House Bill No. 255. The purpose of this bill is to provide funding to develop an agricultural water plan for Ka'u and south Kona. The department provides the following comments relating to this bill.

The Department of Agriculture (DOA) recognizes the importance of saving the State's existing irrigation infrastructure from further deterioration. The Agricultural Water Use and Development Plan (AWUDP) was created to identify these priceless resources and determine which can be salvaged, their current and future potentials for growth, what improvements are necessary to achieve growth, and identify agricultural water need. The Ka'u system is a named system in the AWUDP for study; however, with the amount of funding obtained so far, the DOA has yet to be able to study this system in depth. An appropriation for the AWUDP, as identified in the executive budget, would lead to further investigations of the Ka'u system and its potential to contribute to diversified agriculture and we ask for your support of our budget.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> HB 255, which would direct the Department of Agriculture, in conjunction with the Agribusiness Development Corporation, to develop an agricultural water plan for Kaÿu and South Kona.

OHA understands that the intent of this bill is to generate a water plan that will beneficially affect many of our beneficiaries in this area. Not only will agricultural endeavors be enhanced by a clear understanding of the water situation in the area, but also we see that this information will be generated from a study.

This study will also generate a clearer picture of the hydrology in the area that has been and will be impacted by the recent and on-going volcanic eruption and agricultural pursuits in the area. We see this as an opportunity to assess the water quality and quantity in accordance with Hawaii Revised Statutes 174C-31 for this area. The activities required by this bill would shed light on many of the things that touch and concern our beneficiaries (not only farmers) on a regular basis.

We note that this study is solely agricultural in nature. We urge that no allocations or uses of water should be made or generated that do not flow to agricultural pursuits or lands zoned for such use.

In terms of funding, which OHA understands is tight this year, we ask if federal funds may be available such as from the noted Federal Emergency Management Agency of the Department of Homeland Security or if the study can be housed in and completed by the University of Hawai'i using graduate students under directed study of a professor.

OHA urges the Committee to PASS HB 255, taking the above considerations into account. Thank you for the opportunity to testify.

Chair Tsuji and Members of the Committee:

The Hawaii Farm Bureau on behalf of its farm and ranch families and organizations supports HB255 providing funding to address irrigation needs in the Kau District.

With the exit of sugarcane in Ka'u, many lands were left vacant. Some macadamia nut fields were there but fallow fields became the more common viewscape. Agriculture provided the one employment opportunity for this remote location. However, just as the sugarcane operation experienced low productivity times due to lack of water, these newly formed farm operations also face the same challenges. While sugarcane did not use water for irrigation, significant amounts of water was used for the milling operation and the infrastructure supporting this operation is still in place, although in need of repair. This Bill will plan the rehabilitation and restoration of these systems.

The old Kau Mountain system and the Pahala Water Shaft are still intact and would provide adequate water if repaired and connected. In the South Kona Area several studies were conducted which indicate that ground water sources maybe feasible for small farming and livestock ranching.

This Bill will provide funds to install exploratory ground water wells in the South Kona Area and to renovate the existing water tunnel system in the Kau Area. It may explore the potential for using the Pahala Water Shaft for agricultural purposes.
