Chair Taniquchi and Members of the Committee:

The Department of the Attorney General provides the following comments regarding this bill.

The purpose of this bill is to further define the offense of animal cruelty under section 711-1109, Hawaii Revised Statutes, as it relates to the tethering or restraining of dogs.

On page 2 of the bill, at lines 9-10, the phrase "in a cruel or inhumane manner" is being added to describe the prohibited tethering or restraint. This phrase is very vague and ambiguous, and probably unnecessary in light of the specific prohibitions of the subsection.

On page 2 of the bill, at lines 15-16, the bill prohibits the use of "a tether or chain that weighs more than ten percent of the weight of the dog tethered." At line 19, the bill prohibits tethering of a dog under the age of two months. Both of these prohibitions will be very difficult to enforce. A person who observes a tethered dog cannot know the weight of the dog and tether unless the person is carrying a scale and is able to weigh each of them separately. The person would then have to calculate the ten percent limit. With respect to the prohibition based on the age of the dog, it would be very difficult for a person to know the age of the dog, and difficult to prove it in court beyond a reasonable doubt.

Chair Taniguchi, Vice Chair Takamine and Members of the Senate Committee on Judiciary and Government Operations:

On behalf of our more than 26,000 supporters in Hawaii, the Hawaiian Humane Society greatly appreciates the opportunity to comment on HB 2724 HD1 Relating to Offenses Against Public Order.

We strongly support the intent of HB 2724 HD1 which would expand the definition of tethering and establish key requirements by which a person would be held accountable for cruelty to animals if found in violation.

However, we respectfully request that language be added to HB 2724 HD1 that is currently in SB 2877 regarding property lines. In SB 2877 (1d), there is important language that makes it illegal to use a tether or chain that allows the dog to reach within five feet of the property line. Research shows that tethering is both an animal welfare and public safety issue. This provision is particularly related to public safety and the language regarding the property line is critical. However, this language is omitted from the House version of the bill entirely. We request that the language from SB 2877 (1d) therefore be included in HB 2724 HD 1.

There were two changes made to the original HB 2724 bill that we would like to recommend be returned to the originally proposed language:

- the minimum age of dog that is allowed to be tethered to be increased from 8 weeks to six months of age.
- that the tether be required to be at least five times the length of the dog and at least 10 feet long.

The Hawaiian Humane Society strongly supports the intent of this important bill and strongly supports its passage with the recommended change.

# HB 2724 HD1R ELATING TO OFFENCES AGAINST THE PUBLIC ORDER

Chairman Taniguchi and Members of the Committee:

My name is AlanG ottlieb, and I am the President of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC)i s the Statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council would like to offer comments on HB 2724 HD1.

While the intent of this bill in its original language was to prevent harm to pet dogs and the public by not allowing dogs to be tethered except under certain limited circumstances, it did not take into account the practical practice by Hawaii's farm and ranch families of using working dogs for their operations. The original bill could criminalize certain practices that enable working dogs to learn their trade and stay safe. These practices include relatively short tethers, for short periods of time and the use of tethers on dogs younger than six months of age. For that reason, we suggested certain language to the House which would alleviate our concerns, and they have inserted that language in HD 1. If that new language is removed, we would strongly oppose this bill.

We in the Livestock industry are very sensitive to Animal Cruelty Issues. We are also very sensitive about groups of people who do not believe anyone should be allowed to eat food derived from animals, or own pets or ride horses. Many times, these groupsg et their foot in the door with legislation by grossly exaggerating an issue or using an example of one bad actor that all would agree should be stopped. Some of these radical animal activists do not want people to eat meat or poultry. We believe that people should have the right to *not* be vegetarians. The Hawaii Cattlemen's Council has developed and our members have adopted standards for Ethical Practices and the safe and humane treatment of animals. We work with veterinarians and leading animal welfare experts, constantly improving what we do and how we do it. Livestock producers would not benefit from mistreating their animals.

Thank you for giving us the opportunity to testify on this important matter.
