- Department's Position: The Department of Health is sensitive to the State's economic situation;
- 2 however, we oppose HB2887 HD1 which eliminates the Tobacco Settlement Special Fund portion to the
- 3 Tobacco Prevention and Control Trust Fund.
- 4 Fiscal Implications: The Tobacco Prevention and Control Trust Fund (TPCTF) would be without any
- 5 new revenue from the Tobacco Settlement Special Fund (TSSF) through June, 30, 2015, which is
- 6 projected to be \$3 million to \$3.7 million dollars a year or roughly about \$16.7 million for the five year
- 7 period.
- 8 Purpose and Justification: The Department of Health (DOH) is very concerned about further erosion
- 9 of the TSSF for public health purposes. The historic master tobacco settlement by 46 state attorneys
- 10 generals was to recoup costs and to stanch the continued health and economic cost of tobacco in their
- states. In 1999 the Hawaii Legislature passed Act 304 and provided 25% of the TSSF to establish the
- 12 TPCTF. 25% was also designated to the DOH for health promotion and disease prevention programs.
- As of the 2009 legislative session, the public health portion of the funding has been eroded to 21.5%:
- 14 6.5% for the TPCTF, and 15% for the DOH. The majority of the settlement money or 78.5% that comes

- from the profit of the tobacco industry companies now goes to the General Fund, University of Hawaii
- 2 medical school, and the Emergency and Budget Reserve Fund (see Tables 1 and 2).

Table 1. July 1, 1999- June 30, 2001 Distribution





Table 2. July 1, 2009 to June 30, 2015 Distribution

The TPCTF has been well used. The smoking prevalence for youth decreased 54% from 1999 to

- 2007 (27.9% in 1999 to 12.8% in 2007). The smoking prevalence for adults decreased 14% from 2000
- to 2007 (19.7% in 2000 to 17% in 2007). By 2008, the smoking prevalence for adults went down to
- 8 15.2%. In the same time period Hawaii saw a 28% decrease in heart disease deaths and 36% decrease in
- 9 deaths due to strokes.

From calendar years 2000 to 2009 \$40,000,000 of the TPCTF has been used to develop a

comprehensive program to address tobacco prevention and control that follows the Centers for Disease

- Control and Prevention recommendations. The Tobacco Prevention and Control Advisory Board in
- January 21, 2010 voted to support the comprehensive framework that includes the components of: 1)
- state and community interventions, 2) health communications interventions, 3) cessation interventions,
- 15 4) surveillance and evaluation, and 5) administration and management. The reduction of yearly revenue
 - while spending and diminishing the principal of the TPCTF will severely undermine the ability to
- 17 continue the public health efforts of reducing the burden of tobacco in our state.

House Bill 2887 HD1 also proposes to transfer any interest earnings from the TSSF to the

General Fund and to reduce the portion that goes to the Tobacco Enforcement Fund from \$350,000 to

- \$250,000. Transfer of the interest earnings from special funds is already in place through Act 79 that
- 2 passed in the 2009 Session. While the Department cannot speak to the expenditures of the fund that is
- 3 statutorily designated to the Office of the Attorney General, we are concerned about any reduction in
- 4 efforts to diminish the capacity needed to remain vigilant to keep the settling parties in compliance with
- 5 the master tobacco settlement agreement. We respectfully request this measure be held.

According to the STATE OF HAWAII, DEPARTMENT OF HEALTH REPORT TO THE 2007 LEGISLATURE PURSUANT TO ACT 178, SECTION 25, SESSION LAWS OF HAWAII 2005, REQUIRING THE DEPARTMENT OF HEALTH TO PREPARE A YEARLY DETAILED PROGRESS REPORT ON THE STATUS OF THE HEALTHY HAWAII INITIATIVE AND TO IDENTIFY THE IMPACT ON ANY ASPECT OF THE HEALTHY HAWAII INITIATIVE SUCCESS DUE TO THE REALLOCATION OF FUNDS FROM THE TOBACCO SETTLEMENT FUND TO THE HEALTHY START PURCHASE OF SERVICE CONTRACTS funds were allocated as follows:

"Act 304, SLH 1999 created the Tobacco Settlement Special Fund (TSSF) to receive and hold Hawaii's tobacco settlement revenue payments. In addition, Act 304, SLH 1999 placed the special fund under the purview of the Department of Health (DOH) and outlined how the tobacco settlement money was to be directed. Codified as Chapter 328L, HRS, the statute has been amended four times since its inception and now specifies that the TSSF be allocated as follows:

☑ 24.5% to the Emergency and Budget Reserve Fund:

■ 35.0% to the Department of Health for chronic disease prevention-oriented public health programs, with up to 10% of total revenue for children's health insurance programs;

2 12.5% to the Tobacco Prevention and Control Trust Fund;

■ 28.0% to the University of Hawaii to pay debt service on revenue bonds to support the construction of the Kakaako campus medical school and bioresearch center."

I do not believe that the best interest of the people is served by reducing the the distribution from the Hawaii tobacco settlement special fund to the tobacco enforcement special fund; or suspending the distribution of moneys from the Hawaii tobacco settlement special fund to the Hawaii tobacco prevention and control trust fund. This is available as a direct result of the negative impact of ciagarette smoking. I believe that suspending these funds for any period of time would be detrimental to the program and the communities well being. Additionally, based on the above informaion 24.5% of the funds from this settlement

have already been marked as "Emergency and Budget Reserve Funds". If the amount required exceeds this allocation then perhaps the problem requires more than the bandaid solutions that HB 2887 is offering. I suggest that for a change we look at the root cause of the States current budget crisis working from within to fix those deficits; thereby reducing associated spending and improving efficiency. Robbing Peter to pay Paul isn't the solution.

My name is V. Pualani Enos, and I am the Executive Director of Hui Malama Learning Center on Maui.

Hui Malama provides middle school, high school, and GED programs as well as tutoring and other supplemental educational programs to students K-12 who are enrolled in public or private school. Our programs are designed to inspire, nurture, and empower students to pursue career opportunities that bolster our islands' economy. To do this, we address the whole person, not just academics and work. This includes guiding students to making healthy choices. Tobacco prevention and cessation has been a key component to this work.

Over the past seven years, funding from the Tobacco Prevention and Control Trust Funds has enabled us to integrate tobacco-free policies, practices and programming, which in turn encourages and supports our youth, their friends, and families to be tobacco-free. We offer media and communications programs that create messaging with tobacco-free norms and policies. We also offered cessation classes for our students and those closest to them to address their tobacco use. We have consistently and rigorously evaluated and monitored our programs to realize successful outcomes. We have seen significant positive results in our students – and their friends and families – due to the resources made available through the Tobacco Trust Fund.

But, there is still much work to be done. Hui Malama is concerned that lawmakers are looking to cut funding. Nationally, cuts to tobacco control have resulted in reversal in progress made against tobacco use. We must continue to guide and support the health of our youth in order to save millions of dollars in health care in the future. Community programs including Hui Malama are dependent on the type of Tobacco funding that existed when the Trust was initially disseminated to the states.

How will we offer the types of tobacco prevention programs we currently provide without funding from the Tobacco Trust Fund? We have sought other funding for our successful tobacco prevention and cessation efforts. Other funders and private donors have not devoted monies to tobacco prevention and treatment because they are under the impression that all Tobacco Trust Money is dedicated to these efforts. Without this funding, all of us in tobacco control and the programs and relationships built over time would be gone. Consistent funding has also allowed us to learn from and coordinate our efforts with other likeminded organizations across the state to leverage resources and innovate our services to ensure that experiences for our youth are shaped by current research findings and technological developments—so that we can best help our youth become and stay tobacco-free.

We've taken the knowledge gained and lessons learned from work in Tobacco Prevention and Cessation to develop and expand our services in other areas and other topics. Thus, the Tobacco Prevention and Control Trust Fund has had a long-lasting and broader impact on helping our youth to develop protective factors and develop healthy living habits far beyond what was ever expected. To take away funding for critical programs in tobacco prevention at a time when health and human services, education and other resources are being cut

would significantly harm youth who are already especially vulnerable. If we fail to prepare our youth for the future, who can we expect to lead us in the future – especially when we ourselves already struggle to find solutions to the economic, health and environmental problems that plague us today.

Economists in Hawaii have warned that budget cuts which result in the elimination of critical health and human services and education programs will have a long-standing negative impacts on our future economic health. In conversations with many community members in Maui, many of us prefer the idea of slight increase in taxes and even furloughs so that the economic crisis can be shared among all of us without eliminating what we have all recognized as critical services for community members most in need. While neither option are appealing on their own, they are preferred to the dire consequences that will result from desecrating programs that the entire community has come to rely upon to ensure safety and basic needs for all.

Please hold HB 2887 HD 1 in Committee. Our youth need the kind of and their families' physical and financial health are at stake.
