Subject: House Bill 2901, HD2 (HSCR571-10) Relating to Procurement

Thank you for the opportunity to submit testimony on HB 2901, HD2, Relating to Procurement.

The Board of Water Supply, City and County of Honolulu (BWS) opposes this bill. As currently drafted, this bill requires the purchasing agency to pay a stipend to up to four (4) unsuccessful offerors that have submitted technically-responsive proposals. This mandatory stipend would increase the cost of the project, and in some cases, would serve to discourage procuring agencies from utilizing the design-build method of procurement.

The BWS respectfully opposes HB 2901, HD 2, and requests that the bill be amended to either omit the stipend or to allow chief procurement officers or heads of the purchasing agency discretion as to whether to provide a stipend to unsuccessful offerors when utilizing a design-build procurement process.

I am testifying in support for House Bill 2901, HD. 1, Relating to Procurement, on behalf of the Hawaii Section of the American Society of Civil Engineers.

The American Society of Civil Engineers was established in 1852 and is the oldest professional engineering organization in the United States. The Hawaii Section of ASCE was established in 1937 and is comprised of more than 1,000 civil engineers from both the public and private sectors of our state.

At the national level, the ASCE Board of Direction adopted a policy strongly supporting the two-phase process for design-build contracts for the competitive selection of construction services. A copy of the policy statement adopted on April 24, 2007 is attached.

The traditional method of construction has been the three-step design-bid-build process. In the last decade, the design-build (DB) method of contracting has been increasing steadily. Since 1982, the volume of domestic DB contracts nationwide has grown from \$6 billion to \$56 billion and now represents 23 percent of the nonresidential U.S. market. Both private and public owners are using this method to accrue savings in both costs and time by streamlining the project delivery process. In Hawaii the federal government has been the leading advocate of DB and report savings in time and cost on their projects.

ASCE urges the DB process require the qualifications-based selection process for DB team. In addition, reimbursement for the consultants' cost for the preparation of proposals should be required from the owner. These features are contained in HB 2901, HD 1.

Thank you for the opportunity to testify on this measure. I urge your passage of HB 2901, HD 1 and would be happy to respond to any questions you may have.

The American Council of Engineering Companies of Hawaii (ACEC Hawaii), representing 65 consulting engineering firms and 1,320 employees, strongly supports HB 2901, Relating to Procurement. The design-build process is increasingly being used by State and County agencies for the procurement of design and construction services. Design-build teams consist of one team of designers/builders, and provide quicker delivery of projects that benefit from the collaboration of designers and builders.

Many engineering firms – particularly our small local firms – simply cannot afford to pursue design-build opportunities due to the high cost of preparing the proposal. As a result, the State may not get the most qualified applicant. This bill will help resolve the problem by introducing two important components to the design-build procurement process: (1) two-step selection and (2) stipend.

Two-Step Selection

The first step of the proposed two-step design-build procurement process will require a request for qualifications (RFQ) specifically related to the proposed project. A selection committee then selects a "short-list" (no less than three) of the most qualified teams and they proceed to the second proposal stage. The second step requires substantial design effort to prepare design concepts. Each team prepares a price proposal (RFP) for the unique concept.

Stipend

A stipend shall be provided to the losing short-listed firms. The stipend amount shall be determined by the agency's procurement officer on a project-by-project basis.

We firmly believe this bill will improve the design-build procurement process, resulting in a better product and increased competition.

Consideration for a qualifications based selection (QBS) of a design builder should be considered for smaller projects (for example under \$15 million). The QBS is one of the two methods endorsed by the Design Build Institute of America, the other being the best value price based method described in HB2901. QBS design build procurements have been successfully used in states like Florida and Arizona. The benefit is that for smaller projects QBS offers a very timely and cost effective procurement process and would allow for the implementation of a Progressive Design Build approach, which has proved very beneficial to owners. The Progressive Design Build approach is best described in literature from The Water Design Build Council.



My name is Daniel Chun, Government Affairs Chair of the American Institute of Architects (AIA), speaking in **SUPPORT OFTHE INTENT** of HB 2901 HD2.

I am a licensed architect with over 30 years of practice experience. I have managed my small business in Hawaii for nearly the same amount of time. I have direct past experience in state design-build procurement being a team member for the following requests for proposals: University of Hawaii Stan Sheriff Center, the Hawaii Convention Center, the Kapolei State Office Building, the State Judiciary Public Information Center.

I have "won" only one of these, which is considered a good average. I have "lost" three of these competitions with the resulting increase in my small business overhead operating costs. House Bill 2901 HD 2 remedies some of the more onerous aspects of design-build procurement in the following ways:

- Requires a two-phase process beginning with qualifications based selection or QBS criteria.

The "HB 2901 HD-2 Relating to Procurement" Bill has a two part process for the procurement of the Design Build construction. The first part of the process is the qualification phase where an agency selects the best qualified teams. The second part of the process is the short listed teams that will be allowed to compete in the time consuming and costly proposal phase by developing the scope of work, cost proposals, and construction schedules. The two part process is to reduce costs for the industry and to respond to the requests for design-build proposals to encourage the well qualified design-builders to participate by raising their chances of success and reduce cost to the agency that reviews the proposals.

Thank you for the opportunity to voice my opinion on this important matter. As we all know, Design Build has been embraced by the Federal Government and has evolved into a viable method of implementing projects on a fast track basis. While my personal preference is the traditional Design – Bid – Build process, as our industry has been focusing on perfecting this model over the past 100 years, I also acknowledge Design Build as the future due to myriad factors.

If Design Build project selection is based only on price, then there is an inherent conflict since a firm price can only be given if the scope is determined. Meaning, when an architect or engineer has not defined the scope with a set of drawings and specifications then the Contractor has to guess. In a Design Build process, sometimes only 30% of the drawings may be provided so there is a lot of guesswork. If there is a way to qualify Contractors and their architect or engineer then there is higher probability that the scope will be better defined and a firm price can be attained with a higher quality project.
