PURPOSE: The purpose of H.B. 2978 is to create a uniform set of regulations concerning home and community-based residential care homes. It repeals current provisions relating to adult residential care homes (ARCHs) and expanded adult residential care homes (EARCHs) currently under the purview of the Department of Health (DOH), and combines them with the provisions for community care foster family homes (CCFFHs) under the purview of the Department of Human Services (DHS.)

<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) must respectfully oppose this bill. Given the State's current fiscal constraints, with a budget shortfall of \$1.23

billion for the biennium, now is not the right time to propose sweeping inter-departmental organizational changes without knowing the fiscal and personnel impacts.

DHS is not in a position to divert our reduced staff or resources for the new duties. Now, more than ever, we need to focus our energy and efforts on our current core functions.

Along with any statutory changes made by the Legislature, the corresponding Hawaii Administrative Rules for both DOH and DHS will have to be repealed or amended so as not to be in conflict with the State statutes. This is a long process which would not necessarily ensure the health, safety and welfare of individuals placed in these homes.



H.B. 2978, RELATING TO CARE HOMES

Testimony of Chiyome Leinaala Fukino, M.D. Director of Health February 4, 2010

- Department's Position: The department respectfully but strongly OPPOSES this bill as currently
- 2 drafted.
- 3 Fiscal Implications: The fiscal impact cannot be readily quantified but is likely to be significant to
- 4 implement.
- 5 **Purpose and Justification:** The purpose of the bill is unclear. It reassigns a key DOH function of
- 6 licensing of adult residential care homes (ARCH) to another department in stark contrast to a 2002 State
- Auditor's Report. In December 2002 the state auditor, Marion Higa, provided a report to the governor
- 8 and the legislature titled "Study To Determine the Appropriate State Agency To Oversee the Regulation
- 9 of Adult Residential Care Homes and Adult Foster Homes." (Report No. 02-22) The study was
- conducted pursuant to Senate Concurrent Resolution No. 37, Senate Draft 1, of the 2002 Regular
- Session. The resolution requested the Auditor to determine the appropriate state agency to oversee both
- the funding and regulation of adult residential care homes and adult foster homes. She concluded that
- the DOH "is the more appropriate agency to regulate adult residential care homes and adult foster
- homes" but she acknowledged that an overlap of responsibilities for adult foster homes was sufficient
- for DHS to maintain its oversight (page 22). In short, she recommended "that the Departments of

- 1 Health and Human Services continue to regulate adult residential care homes and adult foster homes,
- 2 respectively."
- Moreover, the licensing of healthcare facilities requires clinical and medical expertise that
- 4 traditionally is housed within the DOH. The DOH employs professional registered nurses, dietitians,
- 5 and occupational therapists who conduct thorough and direct oversight and monitoring of ARCHs
- 6 through a schedule of announced and unannounced onsite visits and complaint investigations. The DOH
- 7 professionals provide training and consultative advice to care home operators. The department also
- 8 reviews and approves training modules for care and nutrition coursework for caregivers and the
- 9 department will soon provide an in depth orientation of the licensing rules as a way to improve a care
- 10 home operator's license application and so that all currently licensed operators are more acutely aware
- of the licensing rules. This is a significant difference that the department provides that positively adds to
- maintaining and improving the quality of care for ARCH residents.
- As a result, this bill's proposal to move the ARCH licensing functions away from the DOH
- appears to be unnecessary at best and unwise at worst.

Page 41 Line 11 relative to the review board. representation from a licensed case management agency and the managed care organizations is required if the review board is to be credible.

Page 41 relating to CMA's reporting to the review board, CMA's currently report to two managed care organizations, DHS and CTA. It is not appropriate to mandate CMA's to report to this review board as well.

This additional NA is for consumer protection purposes. Having an additional NA will assure safety and better care for clients and patients


For these reasons, AFHA strongly supports HB 2978.

To Representative Ryan Yamane and Representative John Mizuno, Co-Chairs and Members of the Health and Human Services Committee:

My name is Myriam Tabaniag, President of the Alliance of Residential Care Administrators (ARCA) and also the Pres. and Owner of two carehomes here in Hawaii.

I strongly support HB 2978.

On behalf of the carehome industry, what we, as caregivers would really want and desire as the outcome of this bill is the standardization of patient/resident referral system from hospitals, long-term care facilities, agencies, etc.

At the present time, there are many residents/clients that are inappropriately placed in both foster homes and care homes.

For the health and safety of any resident looking for placement in a community-based facility or nursing home, admission to the licensed or certified home or nursing home should be based primarily on the nature and extent of the resident's needs and the licensee's or primary care giver's expertise and capabilities of providing the appropriate care. We ask that there be a consistency in the discharge and referral system from hospitals, long-term care facilities, home health agencies, etc. We could only accomplish appropriate placement of residents by the standardization of the discharge and referral system.
