My name is Diana Bethel, and I am writing to express my strong support for HB 413, which establishes a state RDAP (Residential Drug Abuse Program) Reintegration Program similar to the successful federal program.

The RDAP treatment programs offer inmates classes, but the program created by HB 413 enables inmates to reinforce and apply their learning in a supportive environment before being released into the community.

A business plan that maps out the details of operation and financial considerations of the program has been developed by a team from the UH Shidler College of Business. This program has been created with a great deal of thought and careful adoption of elements from similar programs at the federal level.

Hawaii should adopt and benefit from the innovative programs that have been successful elsewhere. Please support HB 413 and help give released inmates a better chance at reintegrating successfully into their communities.
