Department's Position: The department appreciates the intent of this bill as a worthwhile concept, but
 must respectfully oppose it as currently drafted.

3 Fiscal Implications: Significant human resources would be required to be nearly fully dedicated over

4 an extended period of time to plan, coordinate, monitor, assess, and prepare and submit reports. The

5 dollar costs are unquantified but no funding is currently available.

6 **Purpose and Justification:** At the bill's heart is an attempt to encourage business and economic

7 development within the medical arena that would require a thorough, professional and working

8 knowledge of matters beyond the professional expertise of the Department of Health. Among these

9 professional knowledge requirements are land use and zoning issues; building construction and

10 occupancy requirements; fire safety requirements; county permitting processes; the ability to certify

11 whether every aspect of the business is exempt from the payment of GET, such as cafeteria sales,

12 parking garage revenue, retail pharmacy business operations and revenue, lease rent income from land

13 or building space; the ability to perform a thorough financial audit according to acceptable accounting

14 principles and practices to determine gross proceeds from the business(es) located within the enterprise

LINDA LINGLE GOVERNOR OF HAWAII zone; and the professional expertise to determine a broader business benefit derived from the enterprise
zone in a manner to determine the merits of the pilot project and its applicability to expand or establish
enterprise zones elsewhere in the state. Other states and municipalities have created and expanded their

their public health departments.

This measure seeks to create "Medical Enterprise Zones," which operate similar to the existing Enterprise Zones administered by the Department of Business, Economic Development & Tourism.

The Department of Taxation (Department) takes <u>no position</u> on this measure; however must <u>oppose the revenue loss</u> anticipated by this measure.

NOT FACTORED INTO EXECUTIVE BUDGET

The Department initially points out that this legislation has not been factored into the Executive Budget and has not been prioritized as a means of tax relief this legislative session. The Department cannot support the tax provision in this measure because it is not factored into the budget. The Department must be cognizant of the biennium budget and financial plan. This measure has not been factored into either. Given the forecasted decrease in revenue projections, this measure would add to the budget shortfall.

REVENUE IMPACT

The tax component of this measure will result in the following revenue losses:

- \$306,000 in FY2010;
- \$510,000 in FY2010:
- \$510,000 in FY2012;
- \$714,000 in FY2013; and
- \$1,267,500 in FY2014.

INTRODUCED BY: McKelvey, Carroll, Manahan, Souki, and 3 Democrats

BRIEF SUMMARY: Adds a new chapter to the HRS to establish a pilot medical enterprise zone in West Maui. The governing body of the county of Maui shall transmit to the director of health by November 30, 2009, a description of a proposed location in West Maui. The director of health shall designate the proposed area as a medical enterprise zone for seven years.

A medical or research facility may be eligible to be designated a qualified business if the facility: (1) begins the operation of a medical or research facility within a medical enterprise zone; (2) during each taxable year has at least____per cent of its medical enterprise zone establishment's gross receipts attributable to its operation within the medical enterprise zone; (3) increases its average annual number of full-time medical or research professional employees by at least____ per cent by the end of its first tax year of participation; and (4) during each subsequent taxable year at least maintains that higher level of employment for medical or research professional employees.

Requires each qualified business in the zone shall annually complete and submit to the department of health information necessary to determine whether the medical or research facility qualifies or continues to qualify as a qualified business. If the department determines that the medical or research facility qualifies as a qualified business, the department shall approve the completed form and forward copies of the completed and approved form to the department of taxation and the governing body of the county.

The department of health shall certify annually to the department of taxation the applicability of the tax credit provided in this chapter for a qualified business against any income taxes imposed under title 14 that are due the state. The credit shall be: (1) eighty per cent of the tax due for the first taxable year that the business qualifies as a qualified business; (2) seventy per cent of the tax due for the second taxable year that the business qualifies as a qualified business; (3) sixty per cent of the tax due in the third taxable year that the business qualifies as a qualified business; (4) fifty per cent of the tax due in the fourth taxable year that the business qualifies as a qualified business; (5) forty per cent of the tax due in the fifth taxable year that the business qualifies as a qualified business; (6) thirty per cent of the tax due in the sixth taxable year that the business qualifies as a qualified business; (7) twenty per cent of the tax due in the sixth taxable year that the business qualifies as a qualified business; (6) thirty per cent of the tax due in the sixth taxable year that the business qualifies as a qualified business; (6) thirty per cent of the tax due in the sixth taxable year that the business qualifies as a qualified business; (6) thirty per cent of the tax due in the sixth taxable year that the business qualifies as a qualified business; (7) twenty per cent of the tax due in the sixth taxable year that the business qualifies as a qualified business; and (7) twenty per cent of the tax due in the sixth taxable seventh year that the business qualifies as a qualified business.

If a partnership is eligible for a tax credit under this section, each partner shall be eligible for the tax credit provided for in this section on the partner's income tax return in proportion to the partner's income tax liability from the partnership. Any qualified business earning taxable income from the provision of the qualified business' services, both within and without the medical enterprise zone, shall allocate and apportion its taxable income attributable to that provision of services. Tax credits provided for in this section shall only apply to taxable income of a qualified business attributable to the services provided

within the medical enterprise zone.

In addition to any tax credit authorized under this section, a qualified business shall be entitled to a tax credit against any taxes due the state in an amount equal to a percentage of unemployment taxes paid pursuant to chapter 383. The amount of the credit shall be equal to: (1) eighty per cent of the unemployment taxes paid for during the first taxable year that the business qualifies as a qualified business; (2) seventy per cent of the unemployment taxes paid for the second year that the business qualifies as a qualified business; (3) sixty per cent of the unemployment taxes paid for the third year that the business qualifies as a qualified business; (4) fifty per cent of the unemployment taxes paid for the fourth year that the business qualifies as a qualified business; (5) forty per cent of the unemployment taxes paid for the fifth year that the business qualifies as a qualified business; (6) thirty per cent of the unemployment taxes paid for the sixth year that the business qualifies as a qualified business; (7) twenty per cent of the unemployment taxes paid for the sixth year that the business qualifies as a qualified business; and (7) twenty per cent of the unemployment taxes paid for the sixth year that the business qualifies as a qualified business. These tax credits shall only apply to the unemployment tax paid on employees employed at the qualified business' establishment or establishments located within the medical enterprise zone.

The department of health shall certify annually to the department of taxation that any qualified business is exempt from the payment of general excise taxes on the gross proceeds from the provision of medical or research services. The department shall also certify annually to the department of taxation that any qualified business is exempt from the use tax for purchases by the qualified business. The gross proceeds received by a contractor licensed under chapter 444 shall be exempt from the general excise tax for construction within a medical enterprise zone performed for a qualified business within a medical enterprise zone performed for a period not to exceed seven years after the effective date of this act.

Allows any county to propose local incentives, including: (1) reduction of permit fees; (2) reduction of user fees; and (3) reduction of real property taxes. A county may also propose measures for regulatory flexibility including but not limited to: (1) special zoning districts; (2) permit process reform; (3) exemptions from local ordinances; and (4) other public incentives proposed in the locality's application, which shall be binding upon the locality upon designation of the medical enterprise zone.

Upon designation of the area as a medical enterprise zone, the proposals for regulatory flexibility, tax incentives, and other public incentives specified in this chapter shall be binding upon the governing body of the county to the extent and for a period of seven years. If the governing body of the county is unable or unwilling to provide any of the incentives or other incentives acceptable to the department, and the department has not adopted rules that supersede inconsistent ordinances and rules relating to the use, zoning, planning, and development of land and construction in a medical enterprise zone, then the medical enterprise zone shall terminate. Qualified businesses located in the medical enterprise zone shall be eligible to receive the state tax incentives provided by this chapter even though the zone designation has terminated.

Directs the department of health, in consultation with the department of taxation, to submit a written report to the legislature by December 31 of each year beginning in 2010, regarding the implementation of the pilot medical enterprise zone in West Maui, including an evaluation of the success or failure of the pilot medical enterprise zone to fulfill its intended purpose.

HB 553 - Continued

This act shall be repealed on February 28, 2017.

EFFECTIVE DATE: Upon approval

STAFF COMMENTS: This measure proposes to establish a medical enterprise zone in West Maui. In an enterprise zone, businesses are attracted and encouraged to relocate to the zone through tax incentives, bonds, and other appropriate measures. Businesses located in an enterprise zone may claim a credit against taxes paid, including unemployment taxes, for a period of seven years and also allows the sale of items sold by such businesses to be exempt from the general excise tax.

While it appears that it is the intent of the legislature to encourage new and existing businesses to expand their employment bases and increase their marketing territories, enterprise zones merely exacerbate what is already considered a poor climate in which to do business. Singling out businesses for preferential treatment merely confers preferences for those businesses at the expense of all other taxpayers.

Concurrent efforts must be made to improve Hawaii's business climate to enhance the economic prospects for all businesses. Enterprise zones are merely an abdication of government's responsibility to create a nurturing and supportive business climate so that all businesses can thrive in Hawaii and provide the jobs the people of Hawaii need. In this case, it is the provision of medical care in rural communities of the state and in this case specifically West Maui.

As the legislature has learned in recent years, the hurdles to the provision of quality health care in rural areas of the state go far beyond financial challenges that these tax incentives would seem to attempt to abate. Medical tort reform, provision of adequate support staff and the high cost of medical infrastructure are but a few of the issues facing the provision of medical care in rural communities.

Finally, while this proposal attempts to provide oversight to the administration of the tax incentives, one must ask the question of who pays for this oversight? This is an additional cost that will be incurred by both the department of taxation and the department of health. Thus, the incentive does not come free of costs in addition to the lost revenues.

Instead of expanding the enterprise zone program, the program should be repealed in favor of across-theboard tax relief for all businesses in Hawaii. For example, the consultant to the 2007 Tax Review Commission suggested that all business-to-business transactions be exempt from the general excise tax as a means of reducing not only the cost of doing business in Hawaii but the overall cost of living.

Indeed, has there been a comprehensive evaluation of the program and do lawmakers know exactly how much enterprise zone businesses have benefitted and whether or not they have created the jobs promised when the program was first established?

I strongly support a West Maui Medical Hospital and like many of us who live in or around Kaanapali, have had to make the dreaded "midnight" run to Kahului in fear for someone's life.

It happened when our dear 74-year-old friend suffered incredibly from an obstructed bowel due to prior colon cancer treatments that had become infected by the time it reached an acute stage. It nearly killed him. Surgery was scheduled for late in the night and I drove his fearful wife to the hospital, who at her husband's urgent request asked that she not attempt to drive the pali alone. Fortunately, the pali was clear, but our eyes were not and our nerves were on constant edge. We feared our own anxieties might cause even more problems but we made it safely and so too did he through his surgery. We drove back to the West Side at around 4:15 AM, tired and weary, drained and without emotion. Things could have gone seriously wrong for all of us.

The pali is dark late at night and at 4:15 AM because there are no highway lights. Please establish a medical zone in West Maui so that those who need urgent care can recieve it and the added dangers of driving to Kahului day or night are eliminated.

The state of Hawaii is in health care crisis. The viability of state sup ported health care through hospitals and other facilities is in question. HB 353, a bill to set up a pilot medical enterprise zone in West Maui, perhaps as a model for other zones on other islands, offers a creative alternative that could materially assist bringing health care to a high standard of excellence throughout the Hawaiian islands.

West Maui, with its 60,000 residents, commuters and visitors-- and a visitor industry that is one of the most important economic engines in the state-- at the same time is one of the most underserved areas in Hawaii with no access to prompt access acute emergency care.

Establishment of such a medical zone would accomplish three highly desirable objectives:

1. Encourage private enterprise to add state of the art health care facilities and provide a nucleus for establishment of a coterie of some of the best medical practitioners in the land who would be attracted and be encouraged to practice medicine here within a climate of excellence.

2. Provide an important economic stimulus to the area and the state in these dire economic times through the addition of new facilities that would create hundreds of construction and medical care jobs to reduce reliance on tourism as a source of revenues.

3. Help provide a critical mass of services. A health care facility can be financially viable only if it can generate sufficient revenues not only to support institutions but also to support physicians and medical personnel to a high economic standard.

Establishment of substantial health care enterprises would help supply this critical mass.

One of the biggest challenges state legislators have is to understand the needs of our entire island state. Representatives from Oahu have good access to medical care and facilities and may find it hard to understand the sub-standard care available on some of the so-called Neighbor islands. At the same time, representatives from outer islands may not fully understand the issues or dynamics of populous Oahu.

Every legislator needs to step up to the challenge of understanding and meeting the needs of all the people in our state. A medical enterprise zone may not be needed in Oahu. But it is certainly needed in an underserved area like Maui to jump-start long and badly needed improvements.

To legislators with good access to medical care who may not fully understand the difference between care on Oahu and outer islands, I would ask these questions:

Would you move your family and your elderly relatives to West Maui where acute emergency care is more than an hour away over a single two-lane road over the Pali? Or would you take the advice of a knowledgeable health care expert from the mainland that told me last year. " If I lived in West Maui, I'd buy a plane. In a health care emergency, I'd be out of there."

It is these attitudes and these conditions that need redress. By supporting a pilot enterprise zone on Maui, you as legislators would be among the first to take the concrete steps needed to protect, enhance, and preserve life here. Maybe Maui does not need to be No Ka Oil in health care, but we at least need parity.

It would be a feather in the cap of every legislator if this billed received support ant passage.

The emergency staff performed several tests and at 2am decided to admit him. I still needed to drive back to Lahaina at 3 in the morning.
