Chair Manahan, Vice Chair Tokioka and Members of the House Committee on Tourism, Culture and International Affairs.

The Department of Business, Economic Development and Tourism appreciates the intent

of HB 649, which transfers funds from the tourism special fund for conservation and restoration

projects in east Maui, but cannot support this bill.

HB 649 increases the amount of tourism special funds from \$1 million to \$1.5 million that have to be used for natural resource parks and trails and adds that a portion of those dollars be used on east Maui projects for elimination of invasive species, restoration of instream flows, and additional DLNR conservation and resources enforcement positions.

We do not support the designation of tourism special funds for particular projects or programs because we firmly believe that it ties the hands of the tourism authority and its board to develop initiatives and appropriate funds based on priorities that have been established due to strategic plans and market and economic conditions of the time.

Therefore, while we believe there is a need to protect our environment, we humbly ask that this bill be held and that you allow the authority's board to operate in the best interest of the people of Hawai'i and the visitor industry.

Testimony of Lloyd Unebasami Interim President and Chief Executive Officer Hawai'i Tourism Authority on H.B. 649 Relating to Natural Resources

The Hawai'i Tourism Authority (HTA) strongly opposes H.B. 649 which provides for the transfer of transient accommodations tax (TAT) revenues from the Tourism Special Fund (TSF) to East Maui projects such as elimination of invasive species, restoration of instream flows, and conservation enforcement positions.

The HTA would like to provide the following information:

- The TSF was created to carry out the purposes in Chapter 201B, HRS which directs HTA to promote, market and develop the state's tourism industry as well as develop a long-range plan for tourism. As such, in 2004, the HTA, in collaboration with community, industry and government sectors, developed the Hawai'i Tourism Strategic Plan (TSP) which identifies nine initiatives needed to ensure a long-term and sustainable visitor industry: Access, Communications & Outreach, Hawaiian Culture, Marketing, Natural Resources, Research & Planning, Safety & Security, Tourism Product Development and Workforce Development. The TSP provides the overall framework upon which the HTA develops its programs and allocates resources for all of the nine initiatives within its annual budget.
- The Pest Inspection, Quarantine, and Eradication Fund was established for the eradication of pests that are detected. The Commission on Water Resource Management is responsible for the establishing the instream flow program and carrying out its programs with funds from the Water Resource Management Fund. Conservation and resources enforcement positions are funded by the Legislature under LNR405 from a variety of general, special, revolving, and federal funds. H.B. 649 seems primarily to serve as a means to provide funding for East Maui projects and there is no clear nexus between the source of funding and the programs.

The HTA believes that TAT revenues should not be diverted from its programs such as product development and marketing, which are important for Hawai'i in preserving and enhancing the visitor industry, which is the most significant driver of the state's economy. The HTA believes that H.B. 649 should be held. Thank you for the opportunity to offer these comments. 000100 Council Chair Danny A. Mateo

TESTIMONY OF MURRAY TOWILL PRESIDENT HAWAI'I HOTEL & LODGING ASSOCIATION February 7, 2009 RE: HB 649 Relating to Natural Resources

Good morning Chair Manahan and members of the House Committee on Tourism, Culture & International Affairs. I am Murray Towill, President of the Hawai`i Hotel & Lodging Association.

The Hawai'i Hotel & Lodging Association is a statewide association of hotels, condominiums, timeshare companies, management firms, suppliers, and other related firms and individuals. Our membership includes over 170 hotels representing over 47,300 rooms. Our hotel members range from the 2,523 rooms of the Hilton Hawaiian Village to the 4 rooms of the Bougainvillea Bed & Breakfast on the Big Island.

The Hawai'i Hotel & Lodging Association does not support HB 649 Relating to Natural Resources. This bill would mandate that the Hawaii Tourism Authority ("HTA") dedicate funds to the Department of Land & Natural Resources ("DLNR") for East Maui projects. While the proposed projects are desirable, we do not believe funding from the Tourism Special Fund should be earmarked for these projects.

Currently, \$2 million is provided to the DLNR and other organizations for natural resource enhancement. It seems appropriate for the identified activities to be evaluated in that funding process rather than mandate additional funds be set aside.

We are especially concerned about earmarking additional funds from the Tourism Fund due to the current economic crisis confronting Hawaii. Due to falling visitor arrivals and expenditures, HTA's revenue is falling and thus HTA's emphasis should be on seeking ways to stimulate the economy and attract additional visitors.

We urge you to hold this bill. Mahalo again for this opportunity to testify.
