HOUSE BILL NO. 663 RELATING TO AGRICULTURE

Chairperson Tsuji and Members of the Committee:

Thank you for the opportunity to provide testimony on House Bill No. 663 directing the University of Hawaii, College of Tropical Agriculture and Human Resources (UH-CTAHR) to undertake a feasibility study for the development of an animal feed industry in the State. The department believes the livestock industry is a vital part of Hawaii's food self-sufficiency future and feed is a major cost component that can determine the viability of the industry. The department supports the intent of this measure provided its passage does not impact or replace the priorities set forth in the Executive Biennium Budget for Fiscal Years 2009-2010.

We defer to UH-CTAHR as to whether they have adequate staff and resources to carry out the requirement of HB663.

HB 663 - RELATING TO AGRICULTURE

Chair Tsuji, Vice Chair Wooley, and Members of the Committee:

My name is Andrew Hashimoto, and I serve as Dean and Director of the UH Mānoa College of Tropical Agriculture and Human Resources (CTAHR).

The purpose of HB 663 is to direct the University of Hawai'i at Mānoa College of Tropical Agriculture and Human Resources to determine the feasibility of developing an animal feed industry in the State to assist the cattle, pork, dairy, and poultry industries by providing another source for animal feed as an alternative to purchasing the feed on the mainland and transporting it to Hawai'i.

The bill further directs CTAHR to provide, minimally, the approximate existing and potential future demand for animal feed in the State; present and estimated future cost of imported feed; types of crops that would be suitable; estimated cost to produce crops to meet current and future needs; estimated total acreage required; suitable and available lands, including public lands, for growing these crops; potential sources of capital that may be available to assist in the private development of an animal feed industry in the State; and other relevant information to determine the feasibility of development of an animal feed industry in the State.

We support the intent of this bill, as a viable local animal feed industry will reduce Hawai'i's dependence on imported food and will increase Hawai'i's food self-sufficiency, will strengthen and preserve agriculture for future generations as required by our State Constitution, and supports and promotes local animal and agricultural industries, all of which are in keeping with CTAHR's vision and the Governor's 2009 State of the State address initiatives. However, we are concerned about the cost implications of conducting a study of this magnitude on our limited budget and manpower resources.

My name is Lorie Farrell; I am the executive director for the Big Island Farm Bureau. We are the largest general agriculture organization in the State of Hawaii & the Big Island; representing over 650 agricultural members/producers on the Island of Hawaii & over 1600 statewide. We are unique in representing all agricultural commodities & utilize our diverse membership base to direct our policies. The Big Island Farm Bureau is comprised of the individual farm bureau chapters on the Big Island and we are directly related to the Hawaii Farm Bureau Federation and affiliated with the American Farm Bureau Federation.

We support HB663 in developing an animal feed study for the State of Hawaii; however we ask that you amend the bill; reflecting clear objectives with achievable milestones and appropriately fund the study and the implementation of the plan. The industry has little need for another plan that sits on the shelf gathering dust; whereas a plan that is implemented can help ensure a successful livestock industries in the future. As we testify today our dairy's are on the brink of extinction; we have only 1.5 dairies operating on Hawaii Island which is more than all the other Islands combined. The poultry industry has seen a huge decline on the Big Island with our largest egg producer shut down; the others are in the same downward spiral. The pork industry may be the next hardest hit. How long do we wait to support our agriculture industries sustainability? There we used that buzz word again "sustainability" in reality it means nothing if you have no producers growing your food. There is no one size fits all cure for Hawaii's agriculture sustainability but we can attack it one problem at a time with the same vision in mind. We are after all the most remote location in the United States and face unique circumstances to feed the people of Hawaii.

Chairman Tsuji and Members of the Committee:

My name is John Brooks and I am supplying this written testimony in support of House Bill 663 on behalf of the Hawaii Cattlemen's Council.

The Hawaii Cattlemen's Council, Inc. (HCC) is the statewide umbrella organization comprised of the five county level Cattlemen's Associations. Our 130+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of over 1 Million acres of land in Hawaii, 25% of the State's total land mass.

As we have all watched the demise of many segments of the Hawaii livestock industry in recent years, including poultry, dairy and the struggling hog industry, Law and policy makers have been asking the beef cattle industry what we need to be sustainable.

As the industry has reevaluated itself and the future, we have determined that one of our primary weakness has been our dependence on feed shipped in from the mainland. Whether this are feeds used in the feedlot finishing process or feeds being purchased to be provided to our animals during periods of drought, most of it has come from the mainland. There have been several attempts to establish production level feed and hay operations here in Hawaii, none of them successful. Most of these were operations "farming" a product such as alfalfa or corn.

The industry supports the intent of this bill and looks forward to working with UH-CTHAR. We also ask that funding for this project will be made available, as we would not want to negatively impact other important CTHAR work by taking funding from other projects to make this happen.

The Maui Cattlemen's Association is a non-profit organization representing small and large beef cattle producers in Maui County. Cattle producers in Maui County have always taken a practical approach to feeding their animals. There is a history of utilizing by-products from other agricultural commodities, and combining these byproducts with purchased feeds, as well as harvesting cane and other forage on a small scale basis.

With the dwindling supply of agricultural by-products in Maui County, and the increased demands on ranchers, the means of feeding animals has changed over recent years. Lacking options, producers have been forced to import feed from the mainland. The cost of this imported feed has increased significantly due to the widening demand for grains and corn for other industries, as well as the sharp increases in costs to transport feed to Hawaii.

The proposed studies could provide a wide scope of much needed information for the livestock industry, government agencies, and our public officials.
