Testimony of Chiyome Leinaala Fukino, M.D. Director of Health March 16, 2009

- 1 Department's Position: The Department of Health supports HB 710, HD 1, but suggest amending
- 2 the bill to exempt other services in addition to long term care.
- 3 Fiscal Implications: No additional expenses will be incurred by the Department of Health or the State
- 4 Health Planning and Development Agency. The proposed bill may result in reduced special fund
- 5 revenue for the State Health Planning and Development Agency due to decreased certificate of need
- 6 application fees.
- 7 **Purpose and Justification:** While the Department of Health supports and appreciates the intent of HB
- 8 710, HD 1, the Department respectfully suggests amending the bill to exempt other services in addition
- 9 to long term care as was proposed in the Administration bill on revamping the Certificate of Need
- 10 (CON) process. HB 710, HD 1, only removes long-term care facilities from the CON process, and the
- Department of Health believes that additional services should be exempted. The goal of the amendment
- is to offer a more comprehensive approach to streamlining the certificate of need process by exempting
- services from the certificate of need process where obvious need exists in our communities. By
- removing these services from the certificate of need process, the CON focuses on the most crucial
- elements of the health care delivery system. The department suggests exempting the following

- additional services: acute psychiatric beds and acute or long-term swing beds; long-term psychiatric
- beds, long-term tuberculosis beds, long-term mental retardation beds, long-term Hansen's disease beds,
- 3 long-term children's orthopedics beds, long-term rehabilitation beds, mental retardation facilities,
- 4 special treatment facilities, and care homes; outpatient clinics, ultrasound services, clinical laboratories,
- 5 pharmacies, social services, home health agencies, drug rehabilitation centers, alcohol rehabilitation
- 6 centers, recompression centers, mental health centers, family planning clinics, prenatal clinics, abortion
- 7 clinics, fixed-wing ambulances, helicopter ambulances, comprehensive outpatient rehabilitative
- 8 facilities, chronic renal dialysis centers, and hospices.

Testimony in opposition to HB 710 HD 1.

The Healthcare Association of Hawaii advocates for its member organizations that span the entire spectrum of health care, including acute care hospitals, two-thirds of the long term care beds in Hawaii, as well as home care and hospice providers. Thank you for this opportunity to testify in opposition to HB 710 HD1, which exempts long term care facilities from the certificate of need (CON) process.

CON requires certain health care providers to obtain state approval before offering certain new or expanded services. It is designed to help ensure that new services proposed by health care providers are needed for quality patient care within a particular region or community. CON prevents unnecessary duplication of services by selecting the best proposal among competing applicants who wish to provide a particular health service.

The Healthcare Association recognizes that CON is not perfect, but any changes should be initiated from within SHPDA or the Statewide Health Coordinating Council.

For the foregoing reasons, the Healthcare Association opposes HB 710 HD 1.

The Hawaii Long Term Care Association (HLTCA) opposes HB 710, HD1.

We understand and thoroughly appreciate the intent of this measure: to ensure that Hawaii has an adequate long term care infrastructure, to reduce perceived obstacles to achieving that end and to help address the hospital waitlist situation. Flowever, in all candor, what the bill proposes does nothing to assist in accomplishing any of those goals.

- 1. Of all the major facets of the long term care spectrum, only nursing facilities fall under the CON requirement. Type I and II Adult Residential Care Homes (ARCHs), Type I and II Expanded Care ARCHs, community care foster family homes and assisted living facilities all do not.
- 2. HLTCA's skilled nursing facility members account for nearly 1,700 such beds. Some facilities have been in operation for more than a half-century, some just a few years, one is yet to be built. Whether going through ground-up construction or expansion, no one has ever found the CON process to be a superfluous barrier. Having to show necessity, appropriateness, financial soundness and the ability to provide quality care to our kupuna and disabled are requirements with which our members have never had a problem. In fact, they believe it is only proper and prudent both from the perspective of preserving the integrity of Hawaii's care standards and from the standpoint of good public health policy..
- 3. What we need to focus upon, instead, are *targeted* incentives to encourage growth in specific areas of care, like addressing the very special needs of patients on our hospital waitlists -- which we are currently doing, in partnership with DHS and HAH, in working to establish a medicaid reimbursement tier that correlates to the most prevalent conditions of waitlisted patients.

For these reasons, while appreciative of its intent, we must respectfully oppose this measure. Thank you.

Comments:

My name is Anthony Lenzer. I am a Professor Emeritus of Public Health and former Director of the Center on Aging at the University of Hawaii. In the interests of full disclosure, I am also a former member of the SHPDA Windward Sub-Area Council. I wish to express some concern over the testimony of the Administration, speaking through its Department, urging elimination of a a large number of CON requirements, including the requirement for long-term care facilities. The Department offers no clear rationale for this position, which therefore seems more philosophical, i.e. along the lines of "government regulation is inherently burdensome on business, and therefore bad." The implication is that meeting the CON requirement is a major reason why more LTC facilities have not been built in Hawaii. On the other hand, there has been testimony from an industry organization that the CON requirement has not been burdensome.

It is my hope that the Committee will consider this Bill carefully before agreeing to its provisions. In particular, I hope that you will have the opportunity to review the rationale for having this requirement for LTC facilities, to see if it is still appropriate under current conditions.
