RE: H.B. 730: Relating To Cruelty to Animals

Chair Karamatsu and Members of the Committee:

This measure would repeal the current dog fighting statute and replace it with a new, more comprehensive dog fighting law. Dog fighting is not a problem in the State of Hawaii. No one has been prosecuted under our current dog fighting law. There is no demonstrated need to rewrite our current dog fighting statute. The Office of the Public Defender opposes H.B. 730.

Section 1(f) of this measure would proscribe the "knowing possession of any dog used for a fight or any device intended to enhance the animal's fighting ability." This provision would make any animal shelter, Humane Society, or individual who knowingly possesses a fighting dog in an attempt to rescue it from its previous owner guilty of a class C felony. This measure makes no distinction between the lawful ownership of a dog formerly trained for fighting and the owner of a dog currently being used for fighting, or intended to be used for fighting.

We also oppose the imposition of mandatory jail in this measure. Anyone convicted of a second or subsequent offense would be subject to five years imprisonment or probation with a mandatory thirty day jail sentence. Not all of the people present at dog or chicken fights bear the same degree of culpability, and our courts should have the discretion to sentence them accordingly. There is a significant difference between a dog trainer or owner of a fighting dog, and a non-gambling bystander who is "knowingly present" at a fight. Under this measure, both individuals would be subject to same mandatory jail sentence. Innocent family members who reside with a dog owner or trainer should not receive the same treatment as the owner or trainer. Furthermore, the progressive sentencing scheme would prohibit even a first-time offender from obtaining a deferred acceptance of guilty or no contest plea. If this measure passes, the only way for a court to grant a deferral would be to include specific language within the dog fighting law.

We oppose H.B 730. Thank you for the opportunity to comment on this bill.

Dear Honorable Chair Karamatsu,

On behalf of our 47,704 members and supporters of the Humane Society of the United States in Hawaii, I would like to thank you for this opportunity to speak in favor of H.B. 730; relating to dogfighting. The HSUS is in strong support of this bill. We thank Rep. Mizuno for his introduction of this bill and Chair Karamatsu and Committee Representatives Luke and McKelvey for their co-sponsorship of this critical crime and cruelty reduction measure.

In a recent national ranking of dogfighting laws in the states and the District of Columbia, Hawaii ranked 50<sup>th</sup> in part because it is one of only two states with no penalties for paying admission or wagering on an organized dogfight or for breeding, selling or possessing dogs with the intent to fight. This bill would also include those who use stray or stolen pets as "bait" to train dogs to fight.

The 2007 Michael Vick case sadly exposed that no community is immune from dogfighting. Tough dogfighting laws, such as the proposed, are what allowed Vick and his co-conspirators to be successfully charged and convicted. There are an estimated 40,000 people involved in dogfighting nationwide. Our organization has assisted in hundreds of animal fighting raids across the country and we are aware of numerous dogfighting suspects across Hawaii that sadly, have been active for many years.

#### Need for more comprehensive language:

Due to the clandestine nature of such activity, is extremely rare for law enforcement to catch a dogfight in progress. Even if law enforcement were to encounter a dogfight in progress, under current law only those who actually own or fight the dogs may be held accountable. The money generated by admission fees and gambling helps keep this "sport" alive. Because dogfights are illegal and therefore not widely publicized, attendees do not merely happen upon a fight; they seek it out. They are willing participants who support a criminal activity through their paid admission, wagering and attendance.

There are also many components to illegal dogfighting aside from the people who actually fight the dogs. This criminal industry is supported by people who specialize in the promoting, breeding, training, "handling" and refereeing of dogfighting matches. Most often the trainers, breeders, "handlers" and promoters are not the owner of the dogs, as was the case with Michael Vick.

### **Public Safety Issue:**

Dogs used for fighting have been bred for many generations to be dangerously aggressive toward other animals. The presence of these dogs in a community increases the risk of attacks not only

on other animals but also on people. Children are especially at risk, because their small size may cause a fighting dog to perceive a child as another animal.

#### **Associated Crimes:**

Dogfighting is also associated with other crimes such as illegal gambling, drug distribution and human violence. According to a study conducted by the Chicago Police Department, of more than 300 people arrested for crimes against animals (including dogfighting), more than 65 percent had also been arrested for battery-related violent crimes and 70 percent for illegal drugs.

## Cruelty to dogs and "bait" animals

The injuries inflicted and sustained by dogs participating in dogfights are frequently severe, even fatal. Dogs used in these "events" often die of blood loss, shock, dehydration, exhaustion, or infection hours or even days after the fight. Other animals are often sacrificed as well. Some owners train their dogs for fights using smaller animals such as cats, rabbits or small dogs. These "bait" animals are often stolen or stray pets or animals obtained through "free to good home" advertisements.

We respectfully urge your passage of HB 730 to reduce all forms of crime and create safer communities for pets and people.

The crime of dog fighting is not an isolated animal welfare issue, but an insidious underground organized crime. There is a large body of legal and empirical evidence that exposes the clandestine culture of dog fighting, and its nexus with other crimes, and community violence. Dog fighters are violent criminals that engage in a whole host of peripheral criminal activities. Many are heavily involved in organized crime, drug distribution, and they arrange the fights as a forum for gambling and drug trafficking. Law enforcement agencies throughout the nation have identified the overwhelming correlation between dog fighting and other criminal activity.

The commitment of agency resources to the apprehension of dog fighters, and those who attend dog fights, is not a sacrifice of those resources from other areas of law enforcement. On the contrary, the individuals that are apprehended are the same gang members, drug dealers, robbers, and violent criminals that the vice, narcotics, and gang units actively seek to apprehend. Dog fighting raids tend to result in mass arrests for multiple offenses whereby serious and habitual criminals, are easily apprehended.

The dogs literally bite and rip the flesh off of one another while onlookers cheer, scream, and place bets. After the fight, both dogs are critically wounded, often with massive bleeding, ruptured lungs, broken bones. When the dogs are killed after a match, they are shot, beaten, stabbed, hung, drowned, or tortured to death. The dogs that survive never see a vet, regardless of the gravity of injuries, or the amount of suffering the animals must endure.

DOG FIGHTING IS ONE OF THE MOST SERIOUS FORMS OF ANIMAL ABUSE, NOT ONLY FOR THE HEINOUS ACTS OF VIOLENCE THAT THE DOGS ENDURE DURING AND AFTER THE FIGHTS, BUT THEY LETERALLY SUFFER THEIR ENTIRE LIVES.

The dogs are chained their entire lives, without adequate food, water, or shelter. They are not socialized with humans, or other dogs. Young fighting dogs are put in sacks and beaten repeatedly, then let out of the sacks, where a bait dog, that is usually a stolen pet, with its mouth taped shut, is shown to the fighting dog, in a training exercise, to teach the fighting dog to attack the bait dog.

The victims are not only the dogs used for fighting, or the bait dogs that are brutally killed, but the communities that are morally, socially scarred by this menacing pestilence.

Even seasoned law enforcement agents are appalled by the atrocities that they encounter at dog fights, yet the children/youth that grow up exposed to it are conditioned to believe that the violence is normal, they are desensitized to the violence, and ultimately become criminalized. The routine exposure of the children to unfettered animal abuse and neglect is a major contributing factor in their later manifestation of social deviance.

Hawaii is ranked 50<sup>th</sup> in the nation in dog fighting laws because we are one of only two states with no penalties for paying admission or wagering on a dogfight. There is no penalties for breeding, selling, or possessing dogs with the intent to fight.

There is nothing to prohibit the use of pets, stolen, or stray, as bait to train dogs to fight.

I urge your support on HB730, not only for justice for the animals involved, but to rid the community of this menace, and for the children of Hawaii.

Dogs used for fighting have been bred for many generations to be dangerously aggressive toward other animals and may pose a threat to public safety.

I think we need to pass this bill to prohibit dog fighting and also the use of stray or stolen pets as "bait" to train dogs to fight.

Dogfighting is associated with other crimes such as illegal gambling, drug distribution and human violence. Please support HB 730 to reduce cruelty, crime and protect pets and public safety.
