The Department of Transportation (DOT) **strongly opposes** this bill. This bill will establish an office of disaster preparedness (Office) to be headed by a director, and a disaster preparedness commission (Commission), to assist the director in developing a comprehensive disaster preparedness plan. This bill further proposes that both the Office and the Commission be within the DOT. The DOT objects to this bill for the following reasons.

Disaster preparedness is currently within the purview of the State Civil Defense Division of the Department of Defense. Creating another agency to be responsible for disaster preparedness will duplicate the State Civil Defense Division's role and cause public confusion. The duplication of effort between the State Civil Defense Division and the proposed Office will also be an unnecessary waste of our limited resources.

There is also the cost and expense of creating and staffing this new Office and Commission.

Finally, the responsibilities of this proposed Office and Commission are outside the purview, authority, and resources of the DOT. While the DOT has always been an active partner in preparing for disasters, there is no good reason for housing the Office and Commission within the DOT.

For these reasons, we oppose this bill and respectfully ask that this bill be held in committee.

Purpose: Establishes the Office of Disaster Preparedness and a Disaster Preparedness Commission to develop a disaster preparedness plan for Hawaii that includes the identification of hazards and hazard impact zones, disaster mitigation policies, requirements, and incentives, and best responses. Appropriates funds. Effective July 1, 2020.

Judiciary's Position:

The Judiciary does not take a position on this bill but offers these comments for the Committee's consideration.

If this measure goes forward, the Judiciary requests that House Bill No. 990, H.D. 1 be amended to include one additional member to the Disaster Preparedness Commission, to be appointed by the Chief Justice of the Supreme Court for the following reasons:

- Disaster preparedness efforts aim to minimize harm and maintain or restore routines and functions of civil society. But even the most thorough and prescient plan will fall short if it does not reach across jurisdictions and agencies.
- There are numerous agencies, organizations, and interagency partnerships that are all responsible for different, and not necessarily distinct, components of emergencies. Therefore, planning considerations for disaster preparedness should consider the responsibilities of federal, state, and local authorities that are required to help prevent, respond, and recover from an emergency.
- To optimize preparedness, the Commission established by this bill will need to have a comprehensive understanding of the other sector's roles, responsibilities, legal authorities, and assets that relate to emergency responses. The Judiciary, as the third branch of government, should be represented on the Commission to help safeguard individual liberties and preserve the rule of law.

For example, during pandemic emergencies, courts may issue orders authorizing certain actions or affirm orders issued by public health or law enforcement to protect the public's well being. An operational court system ensures that courts are available to serve as guardians of liberty and protectors of the rule of law – even if face-to-face interactions become difficult or impossible. This information is critical to designing and implementing a plan that incorporates the "all hazards" approach as outlined in the bill.

Having a Judiciary member on the Commission will not only strengthen preparation efforts but also bridge the gap that has separated past emergency preparedness planning and policies by ensuring that all key members who have a strong interest and duty in protecting the public's health and safety are represented.

Chair Espero, Chair English and members of the Committees, my name is Alison Powers, Executive Director of Hawaii Insurers Council. Hawaii Insurers Council is a non-profit trade association of property and casualty insurance companies licensed to do business in Hawaii. Member companies underwrite approximately 60% of all property and casualty insurance premiums in the state.

Hawaii Insurers Council supports the intent of H.B. 990, HD1. Hawaii Insurers Council believes it is prudent for the state to have a disaster preparedness plan in place before the next disaster occurs.

In addition, we do offer the following comments:

The inclusion of "human-caused catastrophes" in the definition of "disaster" appears to include acts of terrorism, which could possibly conflict with Homeland Security laws. If it is the intent of the committee to include disaster preparedness for some human-caused

catastrophes, but not acts of terrorism, then acts of terrorism should be specifically excluded in the definition of "disaster."

Hawaii Insurers Council also suggests that "fire" be replaced with "wildfire" under the definition of "natural hazard" because it is more closely aligned with extraordinary situations.
