Chair Hanohano and Committee members:

I am Major General Bob Lee, Director of Civil Defense, State Department of Defense. I am providing written testimony in opposition to House Concurrent Resolution 130 because we believe that an analysis and report on the installation of transfer switches at gasoline stations will require funding support and more time to complete.

We recognize that the proposed resolution addresses an important step in disaster preparedness but funding and more time are needed to conduct a survey, analysis, and to prepare a credible report.

At a minimum, we recommend that the resolution be amended requesting that the Civil Defense Division report its findings and recommendation to the Legislature not later than twenty days prior to the convening of the Regular Session of 2012.

Thank you for the opportunity to provide written testimony that opposes this resolution.
