Aloha my name is Flor Martinez a radio broadcaster for 35 years and a retired employee from Department of Foreign Affairs; I strongly support the intent of H.C.R. 148, HR 87. This bill will allow the government to charge Federated States of Micronesia for services being rendered to its people residing in Hawaii. The Compact of Free Association Act of 1985, Public Law 99-239, has given the Federated States of Micronesia and its people sovereignty and financial settlement and entitlement to migrate to USA freely without difficulty of securing immigration and travel documents, Hawaii being the closest in proximity to Micronesia has been the chosen destination. The Micronesians in Hawaii encountered many challenges in several areas, such as language barriers, culture differences and many social aspects causing them difficulties in assimilating with the mainstream and unable to be self sufficient.
