Chair Marcus Oshiro, Vice Chair Marilyn Lee, and members of the Finance Committee:

Thank you for hearing HCR 161 HD1 proposed. I testify in strong support of this measure as a fellow legislator, community member, and as a friend of the arts.

I ask for your serious consideration and support of House Concurrent Resolution 161, House Draft 1 Proposed-Requesting that Castle & Cooke Hawaii, Inc. to Release Land Designated for the Operational Development of the Oahu Arts Center. This center will not only serve our Central, Leeward, and North Shore communities but will serve as a gathering place to celebrate and promote arts and arts education for those throughout the State of Hawaii.

The development of a performing arts and arts education center is very significant for our community. An arts center in Central O'ahu will serve all segments of our population from keiki to kupuna on a daily basis in creating and enjoying all forms of art. Moreover, the development of such an arts center will protect, promote and nurture the work of local artists and our local art industry. Major partnerships with the Honolulu Symphony, the Honolulu Theater for Youth, the Honolulu Academy of Arts and other arts organizations may bring successful arts programs and major theater productions to residents of Central, Leeward, or the North Shore of O'ahu – outside of Honolulu, without having to cope with or add to the current traffic issues.

A performing arts center and arts education center like the Oahu Arts Center, is an economic development opportunity for our community. The construction and development of this arts center will create local jobs therefore allowing the arts center to serve as a means for the development of other arts-related businesses and opportunities in the area.

I strongly believe that the development of the O'ahu Arts Center in the projected location is viable and sustainable to our Central O'ahu community and the State of Hawaii, and should be supported by your adoption of House Concurrent Resolution 161. I urge your serious consideration and support of this resolution. Mahalo for this opportunity to testify.

In Opposition of HCR 161 HD1

REQUESTING CASTLE & COOKE HAWAI'I, INC. TO RELEASE LAND DESIGNATED FOR THE OPERATIONAL DEVELOPMENT OF THE O'AHU ARTS CENTER

Chair Oshiro, Vice Chair Lee and Members of the House FINANCE Committee.

I am Harry Saunders, President of Castle & Cooke Hawai'i. **We oppose HCR 161 HD1**. We respectfully submit that it would be inappropriate for the Finance Committee and the Legislature to pass or consider a resolution on this matter where (1) Castle & Cooke's conditional offer to donate land to O'ahu Arts Center (OAC) expired over a year ago, and (2) this is a contractual matter between private parties.

O'ahu Arts Center has a noble purpose of establishing an arts center in Central O'ahu, and its Board and volunteers are well intentioned. For this reason, Castle & Cooke was an early supporter of OAC, and over the years, has been one of its primary supporters in cash and in-kind donations.

Castle & Cooke conditionally offered to donate land to OAC in Mililani Mauka for development of an arts center facility, if OAC could meet planning and development milestones which ensured that a facility was feasible and would actually be constructed. Castle & Cooke completed its residential build-out of Mililani in 2008, and has an interest in ensuring that remaining vacant parcels are actually and timely developed in our master planned community for the benefit of residents.

OAC planned an \$86 million project, the first phase of which was an outdoor amphitheater. OAC was unable to meet crucial development milestones—including showing evidence of financial ability to construct and operate the facility—even after an 18-month extension. Unfortunately, OAC has not substantiated that grants and other funding have been secured and efforts to fundraise over the course of many years (including years when the Hawai'i economy was booming) did not result in a commitment of significant funds. As a result, the conditional offer to donate land expired.

Last year, OAC sought support for its project at the terminated Mililani Mauka site from the related Neighborhood Board and the City Council Planning Committee. Both declined to pass supportive resolutions. We are attaching related materials for your information.

Castle & Cooke continues to support the purposes and intent of OAC to promote the arts in Central Oʻahu. We have maintained periodic contact with OAC and have been open to discuss and consider new developments or changes in plans that provide hope for a more feasible project. We understand that prospects for fundraising and financing the ambitious OAC project will be extremely difficult for the foreseeable future, and have suggested that a central location like the Central Oʻahu Regional Park might be an appropriate location for a long-term \$86 million OAC project. Castle & Cooke previously transferred this 270-acre park to the City for public recreational purposes, and with grants and subsidies from sources like the State of Hawaiʻi, an ambitious arts project might some day become a reality in the distant future. However, under the circumstances, this resolution is inappropriate and we ask that this Committee hold the resolution.

Subject: Resolution 09-142 – Public Infrastructure Map (PIM) for the Central O'ahu Sustainable Communities Plan Area

On May 12, 2009, we received notification from the Department of Planning and Permitting (DPP) that Resolution 09-142 was introduced on April 3, 2009 proposing a PIM symbol on lands we own in Mililani. On May 19, 2009, we submitted comments to DPP (copy attached). As noted in our written comments to DPP:

If it is the Council's intent to acquire this land to construct county facilities, we are open for immediate negotiations with the City for the purchase of the site. We would oppose a PIM symbol if the City is not intending to purchase the property within a reasonable time frame, since this would interfere with our marketing and planning efforts for sale of development or the site.

We confirm that our conditional offer to the O'ahu Arts Center (OAC) relating to this land was terminated. Termination was the result of OAC's failure to show evidence of financial ability to construct and operate its project as required under this contract.

Subject: Public Infrastructure Map (PIM) Revision for Central Oahu (2009/PIM-2); Resolution 09-142

We received your May 12, 2009 notice informing us of Resolution 09-142 which proposes to revise the Central O'ahu Public Infrastructure Map ("CO PIM") by adding symbols for a government building and parking facility on property we own in Mililani Mauka, identified as TMK 9-5-002: por. 032. Your notice invites written comments on this CO PIM revision.

We understand that a PIM revision is for City planning and budgeting purposes, and does not impact a landowner's property rights including disposition of the property, except to the extent that a condemnation or other acquisition is funded and effected. We had no advance communication from the City regarding the need for or intent of the Resolution, and were not aware of the City's desire to designate this symbol on our property. However, from our perspective, it does imply that the City has an interest and a plan for funding and developing future City facilities on this property. If it is the City's intent to acquire this land in the near future for a government building and parking facility we are very open to immediately initiating discussions on the pricing and timing of such an acquisition, so as not to conflict with a potential sale to a third party. We would oppose a PIM revision if the City is not intending to fund the purchase of the property and to close the purchase within a reasonable time. Castle & Cooke is presently marketing this commercially zoned site and has interested prospective purchasers.

With respect to the O'ahu Arts Center ("OAC") we confirm that our prior conditional offer to donate three acres of these Mililani Mauka lands (portion of TMK 9-5-002: por. 032) to OAC was terminated by written notice to OAC, dated March 4, 2009, in accordance with the terms of our conditional offer letter. Termination was reaffirmed at a meeting with members of the OAC Board on May 19, 2009.

Donation of the land was explicitly conditioned on the timely satisfaction of planning, financing and development milestones, and these were not met despite a prior 18 month extension. The OAC plan submitted to us (feasibility report by Leo Daly) proposed a facility that would exceed \$86 million (with a \$31 million first phase for an outdoor amphitheater and related improvements), no plans for construction funding and possible shortfalls in revenues for operation and maintenance costs. For perspective on the scale of this ambitious project, the \$86 million estimate for the OAC project approximates the cost of a new DOE Middle School. Furthermore, an outdoor amphitheater hosting theatrical and musical concerts/events in the middle of the Mililani Mauka residential community with its high rain fall, potential weekend traffic and noise may not be the use and facility expected by the surrounding residential community for the completion of our master planned community.

Since OAC's inception in 2002, Castle & Cooke has been a primary supporter of OAC's purpose of establishing an education and performing arts facility in Central O'ahu. Over the course of many years, Castle & Cooke has made various cash donations and in-kind contributions to OAC, and has incurred various carrying costs for holding the property aside, including real property taxes. While we remain supportive of OAC's public intent and appreciative of the efforts of its board members and volunteers, it appears unrealistic that such an ambitious plan can obtain significant donations, grants or financing to be developed and operated in the foreseeable future. The downturn in the world, national and state economies has severely challenged government and all businesses, and non-profit organizations especially are experiencing unprecedented financial hardships. Even though well intended, obtaining grants, donations, or commitments for good causes are limited, difficult or near impossible in this austere economic environment. Conventional financing is also limited for this type of facility; any loan underwriting would require a detailed analysis to ensure potential revenue generation can satisfy debt service and operational and maintenance costs.

Mililani Mauka's residential development was completed in 2008. As we complete our build out of the Mililani Mauka community, we must undertake exit strategies and make alternate plans for the completion of the remaining commercial areas for the benefit of the surrounding community. It would not be prudent as a developer or fair to the surrounding master planned community to set aside and leave vacant indefinitely a large portion of this commercial area within the completed community, with the possibility that someday in the distant future an education and performing arts facility may be developed.

We have encouraged OAC to consider alternative arrangements for the siting of its ambitious plan and related improvements which allow for long-term planning and fundraising, possibly in conjunction with other compatible non-profit organizations and uses. As an example, if the City desires to participate in the development of an education and performing arts center in Central O'ahu, it may consider as more appropriate and feasible the possible use of unutilized

portions of the 270 acre Central O'ahu Regional Park which was previously transferred by Castle & Cooke to the City for public recreational purposes. The central location, large acreage and non-proximity to residences may be more appropriate for a Central O'ahu multi-purpose facility which includes OAC. A long-term timetable for fundraising and construction may be more consistent with future opportunities for funding when the economy picks up. If requested, Castle & Cooke would be willing to waive any deed restrictions which impacted use or development for such a public facility at the Central O'ahu Regional Park.

Thank you for this opportunity to provide comments on the proposed CO PIM revision. We are available to provide further clarifications and answer questions as to Castle & Cooke's comments or position on this.

I am in strong support of the release of land designated for the development of the Oahu Arts Center.

I'm a professional actress, singer, dancer and entrepreneur who grew up in Wahiawa and Mililani and was able to establish a career as a Television Actress, Professional Dancer and Broadway Performer in Los Angeles and New York. However, in order for me to gain any sort of knowledge and experience in my field, I had to leave my family here in Hawaii to pursue my goals of becoming professional dancer in Los Angeles. When I arrived on the mainland I was overwhelmed with the abundant options I had as a performer. The term "Musical Theatre" was brand new to me and I had no idea someone could actually attain a career performing on-stage eight shows a week singing and dancing, belong to a Union where your rights as a performer were protected and that by doing so you qualified for affordable medical coverage and that monies could be put aside for retirement. Needless to say there was a lot of catching up to do on my part. Had I not made that leap from my small town I would not be nearly as successful as I am today, starring on an international TV show for Disney and owning a brand new Performing Arts Studio here in Hawaii.

I feel that there is an abundance of support for athletics in our community with creation of numerous parks and pools and that the children whose interest lie within the arts are being ignored and not nurtured by those who represent them. We need to acknowledge these people, these children as vital members of our community. These are the individuals who will lead and influence all of us in the future. We need to create an environment for their talents and skills to grow and become viable for them in their future career goals, whether it be public speaking for a future lawmaker, dressmaking for a future award winning costume designer, and singing in front of a large audience for a future award winning recording artist or watching a Ballet for the first for an aspiring prima ballerina. All these opportunities can be created under the establishment of a Central Oahu Arts Center.

Central Oahu needs the Oahu Arts Center Facility, and the parking facility.

I have lived in Mililani since 1971. There has never been any facility where residents can have a venue for the performing arts. Additionally, the facility would be available for schools and other organizations to rent space to practice their arts on a regular basis. The Central Oahu area is in short supply of affordable space to practice, and teach the arts.

As a martial artist/instructor, I personally would apply to rent space in the proposed facility for two to four days per week, to train and teach martial arts to members of the community. My organization would also want to rent space in the facility to hold several martial arts tournaments and seminars annually.
