Aloha, Chair Cabanilla and members of the House of Representatives Committee on Housing. **I am submitting testimony in support of HCR 262.** 



Although there are a number of emergency and transitional shelters already in place from Kalaeloa to Ka'ena, there are numerous affordable housing developments being built, that will not be the answer for everyone who either is or has the potential of becoming homeless.
