In consideration of **HOUSE CONCURRENT RESOLUTION 9 –** URGING THE CONVENING OF A TASK FORCE TO CONSIDER THE MERITS OF CREATING IN OR NEAR HANA, MAUI, A MONUMENT TO QUEEN KA'AHUMANU IN COLLABORATIONS WITH HAWAIIAN ORGANIZATIONS, RESPECTED KUPUNA IN THE HAWAIIAN COMMUNITY, AND THE DEPARTMENT OF LAND AND NATURAL RESOURCES

House Concurrent Resolution 9 urges the convening of a task force to consider the merits of creating in or near Hana, Maui, a monument to Queen Ka'ahumanu. While the Department of Land and Natural Resources (Department) acknowledges the valued contributions of Queen Ka'ahumanu, the Department nonetheless cannot undertake an unfunded mandate or task force study as called for in this concurrent resolution, as it would detract from core public management responsibilities.

The Department's general fund appropriations have dropped over 32% in less than three (3) years. The Department's special fund revenues have also dropped over 35% in the same period. Additionally, the Department has lost over 80 positions, or more than 10% of our staff just this past year. Accordingly, the Department is unable provide the requested service on this task force.

I am in strong support of the testimony provided by 'Ahahui Ka'ahumanu, Chapter XI, on this bill, which asks the Committee to defer to the will of the community and recognize the community group that already exists and is currently working on this project, instead of creating a new task force.

I am in strong support of the intent of this Resolution, yet as noted in `Ahahui Ka`ahumanu, Chapter XI's testimony, a community group already exists that is currently working on this important initiative. I am concerned that the task force created through this resolution would undermine the work that has already been done in the community and delay completion of this project. Therefore, this resolution should be held in committee.

Conversely, it would be more appropriate to urge DLNR to work with the community on the completion of their existing project.

The Ahahui Ka'ahumanu of Honolulu, Chapter I will be 105 years old in June 2010 and our Chapter XI in Hana was 20 years old in January. We continue to carry on our traditions passed on from our founders Princess Victoria Kamamalu and Lady Lucy Kaheiheimalie Peabody.

We, therefore, support a monument to the great Kuhina Nui and Queen Ka'ahumanu. In fact, under President S. Nani Smith of the Ahahui Ka'ahumanu Hana Chapter, she and the members have been working many years to do this. They have an artist that would fashion a statue of the Queen, they have worked in the community towards placing this in the correct spot. They would not only place the statue but would be also coordinating an education program around the statue and its location and they have the full support of the community and Maui Councilman for Hana, William Medeiros.
