Purpose of Resolution: Requests the Board of Education (Board) to: (1) adopt a policy for

the integration of a pedagogy of aloha in public schools for

improved learning in the 21st Century; and (2) observe the "Decade

of Aloha" by implementing appropriate programs and activities that

promote awareness of native Hawaiian culture and encourage the

practice of a pedagogy of aloha in public schools statewide.

Board's Position:

Chairperson Takumi, Vice Chairperson Berg, and members of the

House Committee on Education, thank you for the opportunity to

testify on H.C.R. No. 167.

The Board recognizes that culturally-responsive teaching focuses on the importance of including students' cultural references in student learning. While culture is important to student learning, the Board recognizes that there is no one common cultural identity in our State. In fact, our public schools comprise students of many diverse cultures and identities, which are reflected in curricula and

pedagogy that incorporate this cultural diversity.

The Board and the Department of Education (Department) continue to look into ways to incorporate Hawaiian cultural perspectives and strategies in the public school system. There are two Board policies in particular that emphasize and support a Hawaiian education program that consists of language, culture, and history in the public schools through implementation of appropriate programs and activities that promote awareness of native Hawaiian culture. These polices are:

- (1) Board Policy 2104, "Hawaiian Education Programs Policy," which supports perpetuation of the native Hawaiian culture, history, and language as an integral part of the Hawaii Content and Performance Standards. This policy directs the Department of Education (Department) to establish organizational structures and allocate resources to create and coordinate appropriate curricula, develop performance assessment tools, and advise all Department divisions on programs related to the study of Hawaiian culture, history, and language; and
- (2) Board Policy 2105, "Hawaiian Language Immersion Program Policy," which acknowledges the importance of the Hawaiian

Language Immersion Program and the education of Hawaii's youth through the Hawaiian language and through a challenging curriculum that follows the Hawaii Content and Performance Standards.

However, the Board is aware that besides Hawaiian culture and perspectives, our public schools comprise students of many cultural backgrounds and ethnicities. Board Policy 2000, "Philosophy of Education Hawaii's Public Schools Policy," recognizes our pluralistic and multi-cultural society that students are part of, and that curricular, instructional, and assessment programs are to derive from a standards-based curriculum and research-based best practices.

The many different ethnic groups who reside in our State suggest that there are many different approaches to learning, Hawaiian culture being one of them.

The Board and Department will continue to review policies and practices to support areas that promote awareness of native Hawaiian culture within the spectrum of other cultures and best practices for learning and teaching.

By frameworking students, teachers, administrators, parents, staff and community supporters as one learning 'ohana, all participants in the learning process feel cared for, validated and needed for collective success. The key to the success of Pedagogy of Aloha is our focus on relations, relevance and rigor – in that order. Familial relations among all learning 'ohana members, strong school to home connections, dedicated staff who know the students both in and outside of school and small learning communities build strong relations. In effect, how students are treated and taught makes them feel loved and valued.

Relevance follows from an emphasis on Hawai'i's native culture, a shared desire to perpetuate that culture both inside and outside of the school and a focus on place-based, problem-based learning involving authentic community projects and issues. In other words, what students are learning makes sense to their lives and to their responsibilities as 21st century Hawai'i residents.

When students feel like someone cares about them, they begin to care about themselves – and others. Moreover when what they learn is relevant to their personal lives, when it makes sense, when it is interesting, when it is real, students want to learn. Finally when students are challenged with high expectations, when they know someone believes in them, they become

Halau Lokahi is one of the founding member schools of Na Lei Na'auao, Hawaiian Charter School Alliance, and has worked along with the 11 other Hawaiian-focused public charter schools serving over 4,000 students for the past nine years to educate Native Hawaiian students successfully, as well as non Native Hawaiian students who choose an education that focuses on indigenous culture. The integration of a pedagogy of aloha in public schools would benefit the entire system through the interface of indigenous knowledge with conventional educational practices.

The pedagogy of aloha is sorely needed, legally warranted, and would have a dramatic impact in improving the education of students throughout Hawaii. The Hawaii Constitution, Article X, Section 4 mandates Hawaii's responsibility in providing for a Hawaiian education program in the public schools, as well as the Admissions Act. Research and data collected by Kamehameha School and Kanu O Ka Aina demonstrates the benefits, in terms of increased student attendance and graduation rates, and reduced dropout rates, in contrast to other Department of Education schools.




