Thank you for this opportunity to submit testimony in strong support of Senate Bill 1014, which would appropriate funds for the Safe Haven after-school program, a Model Demonstration Program in Hawai'i County.

We know that the risk of juvenile crime, drug use, alcohol and tobacco use and sexual activity increases among older children who are left unsupervised in the after-school hours. There is also a consensus that Hawai'i County lacks positive educational and recreational activities for our youth in the after-school and evening hours.

Today there is no "A-Plus" Program for teenagers, but our schools can be a positive place for our kids even after the traditional school day ends. The Safe Haven After School Program would establish safe, structured and supervised after-school learning environments for our youth. It will allow our communities to take responsibility for our children, for our schools and for our communities' health and safety.

We ask you to help us to open our schools to our youth so they can remain there after classes end to engage in positive recreational, educational and cultural activities. Working parents, who are under all kinds of stresses today, will benefit from knowing their children are being supervised in a safe and positive environment.

We all understand these are difficult economic times, but providing positive alternatives for our youth today will pay dividends for decades to come. We owe it to our children to make the Safe Haven Model a reality.
