Chairs Ige and Nishihara, Vice Chairs Green and Galuteria, and members of the Committees.

The Department of Business, Economic Development, and Tourism (DBEDT) does not take a position on this measure. However, DBEDT would like to request an amendment to this measure to add an exemption for filming activity on Waikiki Beach. The exemption would specifically be for talent smoking in a scene being filmed on Waikiki Beach. The exemption requested is similar to the current exemption for filming activity in §328J-7 which provides an exemption for smoking in facilities owned by the State or County, in enclosed or partially enclosed places open to the public, in enclosed or partially enclosed places of employment, and in sports arenas, outdoor arenas, stadiums, and amphitheaters when the talent smoking is part of a scene being filmed by a production. DBEDT worked in conjunction with the Department of Health (DoH) to establish the administrative rules for §328J-7. DBEDT would again work with the DoH and any other affected agency to establish administrative rules for this measure.

Re: Support for SB 1050, Relating to Smoking

Thank you for the opportunity to testify in support of SB 1050 which prohibits smoking on Waikiki Beach in the shoreline area. We urge you to pass this measure out of committee.

The Coalition worked hard in 2006 to pass the Smoke-Free Law; 85% of Hawai'i residents favor the Smoke-Free Law. Tobacco-Free Big Island, one of our local coalition partners, led the movement on the Big Island to create Smoke-Free Parks and Beaches which led to the passage of Hawai'i County Ordinance 08-56 in 2008. These laws have helped to change social norms. Our young people are growing up in a Hawai'i that promotes health by ensuring children and families are protected from second-hand smoke.

The bill at hand is an opportunity to create outdoor areas for our children and families free of dangerous second-hand smoke, as well as to protect our beautiful environment. Residents and visitors will be able to spend time on Waikiki beaches without smoke interfering with their enjoyment of the water and shoreline. The law will allow many individuals who suffer from lung disease the ability, perhaps for the first time in a long time, to enjoy Waikiki's shoreline and beaches without fear or worry about asthma or an emphysema attack because of someone smoking nearby. Hawaii's beaches and ocean will be protected from cigarette-butt litter and tobacco trash.

Social research indicates that children perceive what is acceptable and what they ought to do from what they understand is a normative behavior in a community. Creating a smoke-free beach will eventually lead to a norm expectation of smoke-free beaches by children and others who use these facilities. We look forward to passage of this bill.

Dear Honorable Chairs and Senate Committee Members:

I have lived in Hawaii my entire life. I was always taught to offer hospitality to family and visitors alike. This proposed smoking ban will disenfranchise the very people who come from all over the world to relax and enjoy our island paradise. Many of our visitors are smokers not to mention the 200,000 plus smoker residents of the state. Tax paying citizens of the state will be further segregated under the above proposed new bill. There have been too many studies recently debunking the Second Hand Smoke threat. One right here from home that many of you are unaware of because the Department of Health has chosen not to share it with you. Why? Maybe they were ashamed of their inability to prove that SHS had any effect whatsoever on their cherry picked venues and minions who secretly carried out the deed of monitoring the unsuspecting businesses. Here is a quote from The Hawaii Air Quality Monitoring Assessment: Some Effects of Hawaii's Smoke Free Work and Public Places Law

"There was no evidence that partially enclosed restaurants/bars had any dangerous level of particulate matter either before or after the law; all had PM levels at 30 or much lower, below the EPA average daily limit"

Further no realistic outdoor studies have ever been done. Across the nation even indoor smoking bans are being amended to include exemptions for adult entertainment and leisure or outright thrown out altogether. The fact that this has even been put on the table is an embarrassment and shows a lack of due diligence. This is nothing less than a complete failure to research independently, while instead relying on special interest lobbying groups who are paid to sell you their rhetoric.

I encourage you to oppose the above bills for the following reasons:

- 1 The above bill is not justified by scientific evidence. They are exclusionary and based on ignorance and bigotry that has been propagated against smokers by The American Cancer Society and The Coalition for Tobacco Free Hawaii. There is no evidence to support excluding 20% of the tax paying citizens and all smoker tourists from using Waikiki Beach to their personal level and interpretation of highest and best use.
- 2 The above bill is selective targeting (no different in practical application than racial profiling) and an insinuation that every smoker is a litter bug and that they are the only offenders of the current litter laws that obviously are not being enforced. Selective targeting, selective prosecution nothing more.

I am totally opposed to SB 1050

I cannot believe that the Senate is serious in proposing this bill. The bill presents no justification nor reason for its passage. It is not proper nor logical to propose a bill without any justification. Therefore, the only conclusion I can reach is that this is a hate bill aimed against smokers.

I am very disappointed that the Senate would stoop to this level. Isn't Hawaii supposed to be the land of Aloha where we all love one another? Hawaii has sure changed since I came here 40 years ago.

I used to return to Chicago every year to attend a high school reunion. If this bill passes, you will shame Hawaii! Truly, I believe the fact that this bill is even being introduced shames Hawaii!
