 off, igniting, or discharging of fireworks easier and increase the penalties and consequences for
 convictions of fireworks violations.
- 4. Support gradually increasing random container inspections by the various federal, state and private agencies to help control the illegal importation of fireworks.

I realize and appreciate the cultural significance fireworks have and continue to play in our community; however, I feel it is imperative that we balance those values and beliefs with responsible and safe practices. The aforementioned measures would provide for the opportunity to better regulate and effectively control the use of fireworks and support the enforcement efforts of the fire departments and law enforcement agencies across our state.

RE: TESTIMONY IN SUPPORT OF SB 1059, SD2, HD1 RELATING TO FIREWORKS

Chair Karamatsu, Vice Chair Ito and Committee Members,

The American Lung Association in Hawaii strongly supports SB 1059, SD2, HD1 that allows the counties to enact or adopt more restrictive fireworks ordinances or rules than the state law. We also are not opposed to the creation of a task force which could assist in the implementation and enforcement of new county regulations. However, a task force alone would not protect the health and well-being of those living in Hawaii.

Over 175,000 people in Hawaii - or nearly 13 percent of our population – that's more than all those on Maui and Kauai combined - suffer from some type of lung disease, which is made worse by exposure to the particulate smoke from fireworks. Hawaii has the second highest rate in the nation for childhood asthma and many adults, especially the elderly, suffer from chronic lung disease including emphysema and COPD (Chronic Obstructive Pulmonary Disease). For those who struggle to breathe one night can be deadly – even people who do not have lung problems often report eye, throat and lung irritation on New Year's Eve. The situation is made even worse as people are facing more breathing problems as a result of increasing volcanic activity and vog.

With so many people experiencing breathing problems directly related to fireworks, the American Lung Association in Hawaii strongly supports this measure that will allow each county to clear the air. We receive many calls for assistance related to fireworks and some who have had to seek emergency medical treatment because of the exposure. All we are able to do is suggest that those with lung problems stay indoors with the windows and doors closed, avoid physical exertion, get plenty of rest, keep medications available should they need them and seek immediate medical help should their condition worsens. Some people find that a particle mask helps, while for others a mask makes it harder to breathe. We hear that some people flee to remote parts of the Neighbor Islands, or rent an airconditioned hotel room for the duration. However, for most of the 175,000 people these options are neither practical nor affordable.

We support this measure as an alternative to a statewide ban because we believe county leadership understand the dangers posed by fireworks in their municipalities.

Chairs & Committee Members:

We oppose SECTION 2 of the bill because it will eliminate consistency throughout the state, re -creating problems that necessitated the statewide law in the first place.

SECTION 1 is a good idea, but this should be a Working Group or Think Tank. It should not be required to submit reports, but to address issues that are common to public safety. Also, the prosecuting attorney of each county, as well as fireworks wholesalers should be included as a part of the Working Group or Think Tank group, since they are both involved in the elimination or at least reduction of illegal aerial fireworks.

We suggest that one or two meetings a year would be adequate, and that they should be between July 4th and January 1st, and that they be held at the Capitol with an appropriate State Agency chairing the group and providing a group memory that would be made available to the Legislature each year to provide updates on progress.

Comments: PLEASE SUPPORT SB1059

A recent NPR program concerning I.E.Ds. (improvised explosive devices), used effectively by the Taliban forces against our troops in Iraq and Afghanistan, cited casualty statistics as "alarming".

I'd like to point out to you that those casualty statistics were fewer in number to the casualty (injuries specifically) statistics resulting from fireworks reported by Hawaii doctors and hospitals this past New Year's season during the same period of time. Therefore I must conclude that the term "fireworks" is merely a euphemism for I.E.Ds..

They are clearly terroristic, not celebratory devices and must be controlled and preferably outlawed.

Significant amounts, and various forms of contraband continuously flow into The State of Hawaii un-inspected by appropriate government authorities.

This presents an extremely dangerous potential and actual danger to all the inhabitants of our islands; human, animal, vegetable and mineral.

Fireworks and armaments, invasive species, drugs and possibly even human trafficking to name just a few of the obvious imports.

When the shipping companies are responsible for inspecting containers, they are looking out solely for their own financial interests. Not for the public's welfare.

Containers, in fact all cargo, needs scrutiny to insure homeland security as well as the protection of the health, safety and environmental quality of life citizens are expecting from governmental agencies; be they local, State or National.

• Between December 31 through January 2, 2010, one hundred and twelve persons were injured by fireworks; seven admitted a hospital. These numbers only account for reported injuries.

• The ages of those injured by fireworks ranged from two years old to eighty two.

• More children under sixteen years old were hurt from fireworks during this time frame than the entire month of injuries from auto accidents, poisonings, and assaults combined.

• No accurate account was even attempted to account for pets and wildlife emotionally traumatized or injured as a result of fireworks.

• Forty million, two hundred fifty thousand (8050 permits X 5000 firecrackers) were discharged. This number only accounts for fireworks requiring a permit. It obviously excludes all illegal discharges.

• According to the American Lung Association, there are at least 175,000 people in Hawaii with some type of lung disease.

• On a typical day in Honolulu, particulate matter ranges from 4 to 15 micrograms per cubic meter.

• On January 1st, 2010 the particulate matter from the fireworks explosions was measured by the Health Department as high as 632 micrograms per cubic meter. Far in excess of Federal standards.

• Surely even those living beings with healthy lungs were in jeopardy. Where does the EPA stand on this matter?

• Add to all this, the property damage from fireworks caused fires, the compression impact damage to property, and hearing damage caused by the numerous bottle bomb devices that punctuated the night.

• The Secret Service was put on alert in order to protect our vacationing President Obama and his family in case they were in danger of harm from fireworks, intentionally or inadvertently .

• At a recent Neighborhood Board meeting we are told by our State Representative, Pono Chong, that all these fireworks, legal and otherwise, freely enter our port un-inspected, and they are helpless to stop it.

* What else of potential damage to our health and safety is streaming in via these uninspected container? Drugs, human trafficking and a huge variety of contraband to name just a few.

* If this isn't terrorism, a clear State and National security risk, please explain to me what is.

Plainly, all the ingredients and opportunities are omnipresent under the guise of "celebrating" the New Year and scaring away "evil" spirits through fireworks.

What could be more " evil" than the devastating effects of fireworks as outlined above?

•• In my opinion, and in the opinion of the majority of the Hawaiian Island residents, this is clearly a Home Land Security issue.

••• I implore you to immediately take every action you are empowered to use in order to mitigate, and preferably eradicate this clear, present, and continuing danger.
