Dear Chair Hee and Members of the Committee:

The Department of the Attorney General opposes this bill.

The bill provides that any "person aggrieved" by a violation of section 115-9, Hawaii Revised Statutes, has the right to bring a civil action for injunctive relief and the right to recover attorneys' fees and costs.

Chapter 115, Hawaii Revised Statutes, was originally enacted in 1974. It directed counties to purchase land for public access to the shoreline, the sea, and inland recreational areas under certain circumstances and confirmed the public's right of transit along the shorelines.

In 2004, the chapter was amended to make obstructing access a misdemeanor punishable by a fine.

The Department is concerned that the proposed private right of action is overly broad and vague. There is no standard for when a "physical, visual, or other impediment" in fact "prevents" a person from traversing a right of way, as opposed to merely making it more difficult to traverse. The term "public right of way" is defined to include roads, paths, and passages "established" by "dedication . . customary use, or open and continuous public use." The question of



whether such a right has come into existence is extremely complex. See for example, section 520-7, Hawaii Revised Statutes, which provides: "No person shall gain any rights to any land by prescription or otherwise, as a result of any usage thereof for recreational purposes."

The bill may actually end up decreasing access because it subjects persons voluntarily providing access to an increased threat of suit. In this respect, the bill conflicts with chapter 520, Hawaii Revised Statutes, which limits liability of landowners who allow others to use their property for recreational use.

It is especially troublesome that any person "bringing" such an action is entitled to an award of attorneys' fees and costs. As worded the bill does not even require the person to prevail. Experience teaches that the possibility of receiving fees and costs is a powerful inducement to litigation. This inducement will doubtless be increased by the absence of a requirement to prevail and the absence of any provision allowing a successful defendant to recover his or her fees and costs.

We respectfully request that the Committee hold this bill.

### In consideration of SENATE BILL 1088 RELATING TO PUBLIC ACCESS

Senate Bill 1088 would amend the definition in Chapter 115, Hawaii Revised Statutes (HRS), of obstruction for access to public property and creates a private right of action for persons to enforce the prohibition of obstruction. The Department of Land and Natural Resources (Department) defers to the Department of the Attorney General on the legal implications associated with the amendments that would establish a new provision to provide for civil action by aggrieved individuals.

The Department recognizes and supports authorized public access to areas that are managed for various recreational activities and that provide traditional and cultural pursuits, and the need to further public access opportunities. However, the Department would be concerned with any change in the law that may create the potential for a dramatic increase in frivolous or misguided civil actions related to unmaintained features that may not qualify legally as a "public transit area" or "public transit corridor" and that due to their condition may create public safety issues.

### TESTIMONY IN SUPPORT OF SB 1088

The Sierra Club, Hawai'i Chapter, with 5500 dues paying members statewide, strongly supports SB 1088, ensuring access to beaches and public areas is protected whenever intentional activities impinge on that access.

Hawai`i offers some of the most stunning hiking trails and beaches in the world, attracting residents and visitors alike for their beauty and challenge. Access to Hawaii's coast and mountain areas for recreational, cultural, or subsistence uses is a core value that residents have respected for generations. The mere threat of litigation would help ensure safe access along the coastline and to public inland areas and prevent abuses of Hawaii's access laws.

By ensuring that communities have the right to enforce public access, SB 1088 helps protect Hawaii's proud public access tradition. Please move this measure forward.

This bill improves enforcement of existing shoreline access protections currently provided for under Hawaii Revised Statutes sec. 115. This law was passed in 1974 because legislators recognized that "development pressures were undermining the public's right to access the shoreline and inland recreational areas." Unfortunately, today those pressures have only gotten stronger, while the ability of the Department of Land and Natural Resources to enforce these rights has gotten weaker. Passage of this bill will help to fulfill the public's right to beach access, while lessening the burden on state enforcement officers.

### Comments:

SB 1228 is important to Hawaii's commercial fishermen, especially in these tough economic times. The bill simply seeks to reaffirm the original intent of the Legislature.

After 10+ years of DOBOR administrative practice allowing transfers of commercial fishing corporations in our Small Boat Harbors, based on Hawaii Revised Statutes (HRS 200), the new DOBOR Administrator stopped allowing the practice.

Many of us believe he is wrong, and we are looking for the Legislature to confirm that, and reaffirm that all the previous administrators had correctly interpreted HRS 200, allowing the transfers. It is our feeling that the statute clearly does not prohibit transfers of commercial fishing corporations.

We believe that the language included in the statute about allowing transfers of ownership of corporations that have commercial operators (charter) permits was inserted because such corporations were considered to be of a higher order of privilege, and thus the new language was needed so that there could be a specific mechanism of imposing a transfer fee.

Since the legislature did not see a need to impose a transfer fee on commercial fishing corporations, there was no specific language included about them not being able to transfer ownership unless they pay a fee. The fact that earlier in the statute commercial fishermen are specifically allowed to incorporate, supports the conclusion that the original legislative intent in allowing them to incorporate was to give them a way of transferring ownership of their commercial fishing business and mooring permits, otherwise why would the legislature have even allowed them to incorporate in the first place?

SB1228 is intended to reaffirm legislative intent, so it is very important that it be heard and passed.

Senate Committee on Water, Land, Agriculture, and Hawaiian Affairs.

Capacity studies done in 2006 reveal that user conflicts between commercial companies and the general public are increasing as commercial operators learn to exploit loop holes in the law that city and state agencies have said they cannot enforce. The CSV consultant study concludes by calling for improved regulations on Blue Cards etc.

# The Waikiki Problem

The 1928 Waikiki Beach Agreement is a land deed agreement between the State and the shoreline hotels in Waikiki. This agreement contains specific prohibitions about commercialism on Waikiki beach where the word obstruction is used in conjunction with commercialism. On Waikiki beach the no obstruction rule is simply not enforced by DLNR because of a loop hole that DLNR officials have used over the years to exempt certain hotels from having to apply for special use permits. As long as Waikiki hotels are allowed to violate the law in this manner, DLNR will continue to treat all other areas with equal skepticism and reluctance in terms of requiring permitting and or enforcing the **no obstruction** rule. I challenge legislators to examine the Waikiki situation to see for themselves how DLNR has used faulty logic to refused to enforce the law on beach commercialism, and how this is being viewed by DLNR officials as the prototype for what is used across the state in terms of the obstruction and commercialism rule. DLNR Chairperson Peter Young, in an attempt to answer the Kailua Neighborhood Board on the question of increasing problems related to the roving commercialism, has said that the Waikiki rules regarding beach commercialism are what DLNR applys statewide. This is extremely confusing.

## A Legislative fix is needed for preventing beach obstructions

Division Administrators in DOBOR and DOCARE are responsible for enforcing commercial prohibitions on a

public beach, but because they have said they feel this rule should not be enforced in certain cases, the rule is then totally ignored everywhere. In areas for example where public access corridors are being used as staging areas for commercial kayak, wind surf, and kite schools, they too are being ignored along the same lines as the Waikiki hotels. I would request that Senators attempt to amend SB 1088 to specifically prohibit commercialism on a public beach, including public access corridor's, in order to force DLNR to enforce the rules. I realize that the law already requires permitting for commercialism on a public beach but since DLNR has not enforced this law with any consistency, I feel state Legislators should help them close the loop holes that (in their minds) make the rules unenforceable. This sort of inconsistency is responsible for the problems that roving companies are posing to State and County agencies. Last year BLNR approved a rule change proposal that essentially put the responsibility on the public for filing civil resource complaints with BLNR, further removing the enforcement responsibility from DOCARE and DOBOR in my view. This was a December 12, 2008 submittal (H-CO-submittal H1). Re: "Amending Civil Resource Violation System."

Aloha Chairman Hee and members of the Committee on Water, Land, Agriculture, and Hawaiian Affairs.

**KAHEA:** The Hawaiian-Environmental Alliance strongly supports S.B. 1088 to improve enforcement of the public's existing right to access the beach and inland recreational areas. With this bill, the Legislature will help to ensure the public's longstanding right to access, which is quickly being eroded by increasing development pressure and inadequate enforcement.

KAHEA is a network of over 6,000 concerned citizens, including kūpuna, cultural practitioners, and ocean users, working to protect Hawai'i's unique natural and cultural resources. Perpetuation of Hawai'i's unique culture is rooted in the public's ability to safely access our valuable natural resources mauka-to-makai.

SB 1088 amends Hawaiʻi Revised Statutes Section 115 to improve the ability of citizens to directly enforce the provisions of the chapter. In 1974, the Legislature recognized that "urban development, especially tourism development, is having a limiting effect on accessibility to the shorelines. ... [T]his effectively bars the general public from the beaches and results in Hawaiʻi's people being deprived of what visitors may use." 1 Thus, the Legislature passed H.B. 104 in order "to guarantee the right of public access to the sea and shorelines and transit along the shorelines." 2

In the years since the codification of HRS sec. 115, local residents have relied on this and other public access laws to successfully uphold the public's fundamental right to public access. Unfortunately, in that same timeframe, the resources available to enforce the public's rights have only waned, as the pressure of development has continued to increase. The practical result of inadequate enforcement is the erosion of the public's fundamental rights to access shorelines and inland recreational areas, despite clear legal protections to the contrary.

Adding a citizen suit provision to the law can become an important tool for upholding public's rights. In a comprehensive review of citizen suit provisions throughout the
