As you know, farm to school programs can have many interrelated positive impacts: keeping dollars and jobs in Hawai'i; providing fresh, nutritious produce to students; instilling healthy eating habits in Hawai'i's keiki, many of whom are at risk for overweight, obesity, and diabetes; supporting Hawai'i's farmers; keeping agricultural lands intact; and reducing our dependence on imported food. I am confident that the study can identify several potential sources of support for the program as well. Because there are so many benefits from farm to school, there are many different sectors that may be able to provide volunteer services, in-kind donations, information, and financial support to the program.

SB 1179, SD 1 - RELATING TO EDUCATION

Chair Kim, Vice Chair Tsutsui, and Members of the Committee:

My name is Andrew Hashimoto, and I serve as Dean and Director of the University of Hawaii at Mānoa College of Tropical Agriculture and Human Resources (CTAHR). My comments are personal and do not represent the position of the University of Hawaii or CTAHR.

The purpose of SB 1179 SD1 is to establish a farm to school policy in Chapter 302A, Hawaii Revised Statutes, to direct the University of Hawaii (UH), CTAHR, in cooperation with the Department of Agriculture (DOA), the Department of Education (DOE), and the Hawaii Farm Bureau Federation (HFBF), to convene a working group of stakeholders to consider the feasibility of establishing a farm to school program in Hawaii's public schools, appropriates funds for the feasibility study, and requires CTAHR to submit its findings and recommendations to the 2010 Legislature.

I fully support the intent of this bill, as it promotes locally grown food in schools and supports the local agricultural industry. The bill is also in keeping with the State's initiative to increase Hawaii's food self-sufficiency from the current reality of importing to Hawaii upwards of 85% of all food we consume, and relates to CTAHR's vision to actively help Hawaii diversify its economy, ensure a sustainable environment, and strengthen its communities. I am willing to help facilitate this process should the measure be passed, and to work with the DOE on issues that may impact the department's school lunch program.

Dear Senators:

Thank you for giving the public the opportunity to comment on SB 1179. With these comments, I would like to reiterate my support for SB 1179 SD1 upon its second reading.

Since the last reading of the bill and my earlier comments, parent volunteers at Sunset Beach Elementary school have helped to start a kids' farmers' market every other Friday after school. This time frame is in direct competition with Ice Cream Friday, a PTCA fundraiser. We solicit produce donations from people in the community and have the kids sell them to their classmates, parents, teachers, staff, the public, with adult supervision, of course. The response has been overwhelming. Our first market day resulted in EVERYTHING being sold. There were children standing in line to buy one starfruit, or a few tangerines instead of buying ice cream across the way. Parents also stood in a long line to buy produce for their families. This overwhelmingly positive response from the children, the school and the community shows that children will choose to eat healthy if they are presented with the opportunity to do so.

The Sunset Beach farmers' market club has decided that with the proceeds of the farmers' market, we would like to offer a healthy snack at recess for the children to continue to reinforce healthy eating. We are currently in the process of figuring out the volunteer logistics for this particular outcome of the market. We hope to have local farmers provide the fruits and vegetables. In a state like Hawai'i, with abundant sunshine, and a year round growing season, there is no reason why we should not be helping farmers sell their products to local schools, and why our children's health should not be benefiting from the proximity of farms throughout much of the state. This would alleviate the absurdity of shipping food products such long distances, contributing to higher costs, higher fuel consumption, and lower quality food because of the distances it has to travel.

As I stated in my previous testimony, farm to school programs can have many interrelated positive impacts: keeping dollars and jobs in Hawai'i; providing fresh, nutritious produce to students; instilling healthy eating habits in Hawai'i's keiki; supporting Hawai'i's farmers; keeping agricultural lands intact by preventing development; and reducing our dependence on imported food thereby moving Hawai'i towards sustainability and food security.

SB 1179 is an excellent opportunity to advance the farm to school process in Hawai'i. The feasibility study could provide much of the information and links to resources that individual school staff, the statewide educational system, farmers,

vendors, and distributors need in order to determine how to best work toward increasing the amount of fresh, locally grown produce provided in school lunches for Hawai'i's children. However, we should not stop at a feasibility study. I respectfully urge you to amend the bill to implement policies to aid in the procurement process for the DOE to be able to source produce more easily directly from Hawai'i farmers and to make sure that the 5 week school lunch calendar can be amended to include healthier alternatives within the federal guidelines.

Please support this bill and farm to school in Hawai'i.
