Title of Bill:

SB 2083 Relating to Education

Purpose of Bill:

Designates after-school and prevention programs that address bullying, sexual health issues, emotional literacy, domestic violence, civic responsibility, and healthy relationships as objectives and policies in the Hawaii state plan.

**Department's Position:** 

The Department supports SB 2083, with concerns as it is currently drafted. After-school programs are suitable to encourage educational supports of health-enhancing behaviors and inter-personal relationship skill building. However, the Legislature should be aware that after-school programs only touch a minority of public school students. If the Legislature believes prevention programs that address bullying, sexual health issues, emotional literacy, domestic violence, civic responsibility, and healthy relationships are a priority for youth education, the focus should be on improving access to Health Education classes. The Hawaii Content and Performance Standards for Health Education contain benchmarks that address all of these issues. Health Education classes reach all of Hawaii's public school students, unlike after-school programs. Therefore, the Department suggests changing the language in Section 2, Section 226-20 (b) (7), to read, "Emphasize Health Education curriculum in schools to address sexual and emotional health issues, and use after-school and prevention programs to support student knowledge and skill building in current health topics."

- I am writing in support of SB 2083 Relating to Education. This bill amends Hawaii State Policy on afterschool programs and prevention programs to reflect an emphasis on "sexual health, emotional literacy, civic responsibility, and healthy relationships."
- In Hawaii, a 2004 study found that 67% of all Chlamydia infections occurs in youths aged 15-24.1 Hawaii has the nation's 6<sup>th</sup> highest rate of Chlamydia infection.
- Hawaii has one of the lowest rates of teens reporting sexual intercourse. Of those having sex, only 54% are using condoms, which is the lowest rate of condom use in the country.
- Emphasizing sexual health education and prevention is an important step in teaching youth how to prevent pregnancy and make healthy and responsible choices when it comes to sex and relationships.
- I support the amendment proposed by Planned Parenthood of Hawaii: amend the language in Section 2, subsection (7) to read as follows:
  - Emphasize after-school programs and prevention programs in schools to address sexual and emotional health issues that are medically accurate and age appropriate and include education on abstinence, contraception, and methods of disease prevention to prevent unintended pregnancy and sexually transmitted disease, including human immunodeficiency virus.

Please amend SB 2083 and pass the bill as amended.
