Clearly a solution to end this short sighted decision to balance our budget must be found.

PHOCUSED believes the use of the Hurricane Relief Fund is a more appropriate use of state reserve funds rather than using a combination of the Hurricane Relief Funds and the Rainy Day fund. In addition, PHOCUSED believes that discussion is needed on how best to allocate other reserve funds, and respectfully offers to be part of that discussion. There is no question leadership needs to find resources to preserve essential safety net and core services, as well as the restoration of school days.



TESTIMONY OF THE UNITED PUBLIC WORKERS, LOCAL 646, ON SB 2124, RELATING TO THE HAWAII HURRICANE RELIEF FUND

SB 2124 appropriates \$50,000,000 from the Hawaii Hurricane Relief Fund (HHRF) to restore all remaining lost instructional days for the 2009-2010 school year.

Although we understand and empathize with this bill's intent, we also have a major concern. We do not believe it is right to use the HHRF restrictively to offset teacher furlough days. During the interim, the Legislature's informational briefings disclosed the devastating effects the economic downturn is having on all our public services. Yes, education is a priority, but so are our public safety, health, human services, environmental and agricultural programs.

This measure is unfair to all other state workers who have been furloughed and it would foster resentment in the workforce by pitting one group of workers against another. We are all in this together and it is going to take all of us working, sacrificing, and sharing equally to get us out of this hole.

For this reason we cannot support SB 2124 as written.
