In consideration of SENATE BILL 2169 RELATING TO SHARK FINS

Senate Bill 2169 would amend Chapter 188, Hawaii Revised Statutes, to prohibit the sale, offering for sale, trade or distribution of shark fins. The Department of Land and Natural Resources (Department) understands the rationale behind this measure to deter the needless slaughter of sharks. However, the bill contains some elements that make it unenforceable and outside of the boundaries of what the Department can address. As such, the Department cannot support this measure.

In particular, this measure does not distinguish between fresh caught shark fins from state waters over which the Department has regulatory authority, and imported dried shark fins from waters beyond state or even federal jurisdiction. As such, the measure would make it unlawful to sell imported products, which is beyond the scope of the Department's authority, and may also contravene federal trade laws.

Finally, the Department would note that it is currently legal to land whole shark carcasses taken in state waters, and that the current measure would lead to waste by prohibiting the sale of one particular part of the animal, forcing fishers to discard it. The Department sees no natural resource or economic benefits in mandating such practices.

In support of SB 2169

Aloha. Conservation Council for Hawai'i supports SB 2169, which prohibits the sale and distribution of shark fins in the State. The practice of removing fins from live sharks and throwing the sharks back into the water is wasteful and unnecessary. We have heard only 10% of the shark fins that come into the state are actually sold or consumed here, and that 90% are transported elsewhere. Therefore, this bill should not cause economic hardship on anyone here in Hawai'i.

We should not allow the sale or distribution of shark fins in our state. Nor should we wait until the federal government prohibits such fins from entering our state, or from being imported to America. Instead, we should send a strong message that we will not encourage or reward this practice in Hawai'i. Our understanding is that, although shark finning is banned in the Atlantic (including the Gulf of Mexico and Caribbean Sea), shark fins currently enter Hawai'i ports (unattached to the carcasses) because of a loophole in the federal law and a federal court interpretation in the 9th Circuit that allows the fins to be transferred from a shark-fishing boat to a boat that does not contain fishing gear. Shark fins are also imported to Hawai'i and this country via non-fishing boats, such as container ships and the like.

Please pass SB 2169. Mahalo nui loa for the opportunity to testify.

Support for the ban on shark fining in the State of Hawaii.

Sharks are being annihilated from our oceans. The World Conservation Union (IUCN) has estimated that tens of millions of sharks are finned every year. Often the shark is still alive, while its fins are hacked off with a sharp knife, leaving it in agony. The shark's finless body is then dumped overboard and, being unable to swim, it drowns or dies of starvation. Shark fining targets only 2-5% of the shark's body mass and wastes the remaining 95%.

Shark fining is illegal in the US and elsewhere, but the law is difficult to enforce. As the law stands now fishermen may land piles of fins as long as the fins weigh less than 5% of the total catch. The total catch can be other fish such as tuna.

Shark fins land much higher prices than the body due to the increased demand for shark fin soup in Asian countries. Once a shark has been "finned" it is hard to determine the identity of the species that they came from.

"A common practice is to keep all the fins they catch and fill the holds of the boat with bodies of smaller sharks," says marine ecologist Stuart Sandin of the Scripps Institution of Oceanography in La Jolla, California.

The new rule comes into effect before the June shark-fishing season in an attempt to protect badly over fished species and to give them a chance to recover. It will only protect sharks until 2012, when fisheries managers will reevaluate the stocks. Because sharks may take 15 to 20 years to mature, the rule as it stands now simply does not go far enough. http://hudsonvalleydivers.org/wordpress/category/wordpresssharks/

Dear Committee Chair and Members,

I am in strong support of SB2169 for the following reasons:

>> Shark finning is a barbaric and wasteful practice that can no longer be tolerated.

More than 100 million sharks are slaughtered per year.

- >> Shark finning steals the food for millions of people. Coastal communities that depend on sharks as their major source of protein can no longer catch sharks because fleets of long-line fishing boats have assaulted and cleaned out their waters.
- >> Shark fins alone have no nutritional value. They are merely a status symbol, a meal served to impress.

Killing sharks for fins is the same as killing rhino for their horn, groupers for their lips or elephants just for their tusks.

- >> Finning has grown into such a lucrative industry that it continues whether it is legal or not. The practice continues at a devastating rate all over the world, in even the most pristine ocean preserves.
- >> Hawaii is a distribution point for shark products. We have to take a stand with strong legislature that is simple, broad and all-inclusive.

Existing laws make enforcement very complicated. It is too easy to get away on a technicality. There are too many loopholes that make it possible for shark fins to enter and be shipped out of the state, and to be sold at the local market and restaurants.

SB2169 is a much more effective bill than House Bill HB1959, which allows fins to be landed as long as there is a corresponding amount of bodies. Who is going to check and how can it be proven where the sharks were caught?

>> With this bill we are not only doing the right thing for Hawaii and for the protection of our marine life, but we can also set an example for other states and countries to follow.

Passing this bill would put Hawaii in the forefront of shark conservation world wide, being surpassed only by the island nation of Palau, which has become the first Shark Sanctuary in the world.

>> You will find many testimonials and statements coming in from around the world. Every shark and ocean conservation group, the Humane Society, Cousteau Society etc is rooting for this bill to pass.

The world is watching to see what Hawaii and your committee is going to do with bill 2169.

Suggestion for amendment/clarification text:

I have been in contact with Shark Research Institute, the advisors for CITES in shark related issues. (Convention of International Trade of Endangered Species) The have recommended a small change in the wording of the bill to close any possible loopholes that would allow shark fin soup and other fin products to be sold or traded.

Ben Fackler, attorney for the Board of Trustees Shark Research Institute suggests the following:

The bill leaves discretion to the department to adopt rules, and rules could take a different interpretation.

If we want it to be specific here, I would recommend, at the end of clause (a), the addition of a clarifying text along the following lines "....or distribute shark fins, as defined in section 188-40.5, including, without limitation, any products or foodstuffs derived from or containing shark fin".

No one should be able to sell to a restaurant shark fins to include in a soup. (although a restaurant could in theory purchase them outside of Hawaii and ship them for its own use and thereby get around the rules without this clarifying change).
