Title of Bill:

SB 2257 SD2 RELATING TO ELECTRONIC WARRANT VOUCHERS.

Purpose of Bill:

Allows the department of education, department of accounting and general services, and the University of Hawaii to accept electronically mailed warrant vouchers for bills of materials, supplies, and incidentals as original documentation, the receipt of which authorizes payment to be made to each individual to whom the State is indebted.

**Department's Position:** 

The Department of Education strongly supports this measure. Current statutes regarding documentation for payments for goods and services do not reflect the ever-changing technological advances that are being made in business purchasing procedures. Private vendors are now using electronic/digital images of original vouchers, bills of materials, and other supporting documents. This measure proposes to update the statutory language, to allow the Department of Accounting and General Services, the University of Hawaii and the Department of Education the flexibility to accept electronically received warrant vouchers, bills of materials, invoices, and other supporting documents as original documents for validation and payment. Such improvements to the statutory language will facilitate much greater efficiency and effectiveness in processing of governmental payments to vendors for goods and services, updated to current technologies.

Please note that there is a defective date of January 1, 2099 that must be changed to make this proposed bill useful as intended to the Department, the Department of Accounting and General Services, and the University of Hawaii. The Department recommends July 1, 2010.
