TESTIMONY TO THE JOINT HOUSE COMMITTEES ON HUMAN SERVICES AND HEALTH

Senate Bill 2287 - Relating to County Zoning for Group Living Facilities

The Disability and Communication Access Board (DCAB) opposes Senate Bill 2287 that requires the counties to consider in zoning for group living facilities impacts of traffic safety and congestion, elevated noise levels, and disruption of commercial deliveries upon the residents in the surrounding area. As currently written, this bill expresses a "not in my backyard" sentiment about group living facilities for individuals who are elderly or have disabilities. When individuals reside in group living facilities, regardless of age or disability status, they do so because they cannot function or live independently and need more assistance than their families or support systems can provide. People who are elderly and disabled have the right to live in a variety of communities, and are fortunate to have facilities established in a variety of neighborhoods such as Manoa, Hawaii Kai, Kaimuki, as well as other locations on Oahu and statewide.

DCAB agrees with the suggestion proposed by the Hawaii Disability Rights Center with the approach adopted in Senate Bill 2805, SD1, and we propose a similar one be taken here. Establishing a task force, similar to that proposed in Senate Bill 2805, SD1 takes a more proactive avenue to examine issues of all parties involved. The task force could be established with the counties taking the lead rather than the Department of Health to examine issues related to group living facilities and communities, and recommend how the homes will be regulated through administrative rules rather than by amending the Hawaii Revised Statutes.

The proposed HD1 was reviewed and DCAB finds it to be consistent with the Federal Fair Housing Act and current court decisions. We have no objections to it, however we would prefer introduction of an House Concurrent Resolution to establish a task force as suggested above.
