Donovan,

Thank you for the e-mail on SB 2478. I am responding to you to express my highest level of support for this bill as both a producer and presenter of live entertainment across the US and Canada.

Our company has presented touring shows in Honolulu for many years ranging from one night events with Bill Cosby and Jim Brickman to week long and multi week engagements for shows including CATS, Stomp and Cirque Dreams. Despite our relatively good results with these shows we find ourselves constrained in our efforts to grow our Honolulu business, including a long-term desire set up a formal Broadway in Honolulu series, by the high costs of transportation, local housing, local staffing and general expenses.

Even with the supportive efforts of the local stagehands union and facility managers touring engagements in Honolulu can cost anywhere from 15% to 50% more than on the mainland. In addition to this direct cost the transportation time involved often curtails our ability to have a normal week of performances prior to or following the Honolulu play.

With the kind of assistance SB 2478 is suggesting I am absolutely confident that we would increase the number of shows we present in Honolulu and we would seriously revisit the idea of building a Broadway in Honolulu series.

Shows we are currently working to try and bring to the Honolulu market that would receive a definite boost in their likelihood of occurring include a return of the musical CATS, a first run of Disney's Beauty and the Beast, a first run of the newest show by Blue Man Group, a first run of Riverdance, a return of the magician David Copperfield and a long run of the smash hit musical – Wicked. This is not publicly available information at this point but they are shows we are working to budget for Honolulu appearances and the assistance SB 2478 anticipates would greatly enhance my ability to bring these shows and all the positive impacts they bring to the community in terms of employment, theater utilization, local restaurant and hotel business and local marketing dollars.

Please let me know if there is anything else we can do to support this important piece of legislation.

Dear Members of the Hawaii State Legislature,

I write to you today to urge you to vote in favor of <u>State Bill 2478</u>, which would provide a tax credit for the investment, transportation expenditures, and certain payroll costs associated with live musical or theatrical productions or theatrical facility infrastructure projects. This bill would positively affect Hawaii residents working in the theater and music industry such as the several hundred members of the IATSE local 665 labor union by providing them more opportunity for work as well as theatrical facilities such as the Hawaii Theatre and Maui Arts & Cultural Center which are non-profit organizations both attempting to renovate their venues.

The live music and performing arts industry has experienced phenomenal growth around the world in the past decade. Box office records are broken every year. Pollstar, a leading industry publication, estimates that box office sales in 2009 hit an estimated \$4.6 billion dollars in the United States alone, a record high. The growth in the industry has spurred two effects:

- 1) An increase in the costs of producing these events
- 2) An increase in competition by cities to attract these events which in turn has spurred modernization of facilities around the world

This bill is positive for the State because it will:

- Attract more events which will in turn provide more work for Hawaii residents working in the industry
- Assist and encourage the facilities of Hawaii to update and modernize their venues
- Increase business for other industry sectors such as tourism and construction
- 4) Ultimately increase tax revenue with the increase in overall business to the State

This bill helps Hawaii to become more competitive on the national and world stage in one of the hottest growing industries today. It also helps Hawaii businesses and residents to continue to thrive and operate in this very competitive and uncertain climate. This measure provides a tax credit for live theatrical and music performances in Hawaii.

The Department of Taxation (Department) <u>opposes</u> this measure because it is <u>outside the</u> <u>budget priorities this legislative session</u>.

The Department cannot support the tax provision in this measure because it is not factored into the budget. The Department must be cognizant of the biennium budget and financial plan. This measure has not been factored into either. Given the forecasted decrease in revenue projections, this measure would add to the budget shortfall.

The Department simply cannot support this tax credit given the other more important competing priorities for general fund revenues.

This measure will result in a revenue loss of \$60 million per year due to its cap.
