- 1 Department's Position: The Department of Health opposes this bill because of the added burdens it
- 2 imposes on the department.
- 3 Fiscal Implications: The bill imposes substantial administrative duties on the department without new
- 4 resources. The amount of added cost is uncertain, but added costs will occur.
- 5 Purpose and Justification: Effective January 1, 2011, this bill will require all businesses in the state to
- 6 charge and collect an offset fee for each disposable checkout bag it provides to its customers.
- 7 DOH generally supports the reduction of solid waste, litter, and the use of petroleum resources.
- 8 State policy already sets source reduction and recycling as the top two priorities for solid waste
- 9 management (HRS §342G-2(b)). We favor the use of reusable shopping bags and reducing plastic
- marine pollution because of its effect on wildlife.
- While this bill works towards those goals, it adds significant administrative functions to the
- 12 DOH without adding any resources to manage them. DOH will have to manage the collection of fees
- from hundreds of businesses, as well as conduct monitoring and enforcement activities, with no new

1	staff or other resources provided for by this bill. By contrast, deposit beverage container program		
2	administration and enforcement are funded by the container fees.		
3	Furthermore, the effective date of July 1, 2010, is to early for the department to attempt at a		
4	transition.

TESTIMONY IN OPPOSITION OF SENATE BILL NO. 2559 SD 2 HD1, RELATING TO ENVIRONMENTAL PROTECTION

TO THE HONORABLE REPRESENTATIVE MARCUS OSHIRO, CHAIR AND MEMBERS OF THE COMMITTEE:

My name is Donald Fujimoto, County Engineer, Department of Public Works, County of Kaua'i (County), testifying in opposition to Senate Bill (SB) 2559, which proposes that businesses in the State collect a 5 cent offset fee for each plastic or paper disposable checkout bag provided to a customer, allocates the offset fee back to businesses and the State general fund, and preempts our new County legislation to reduce the use of plastic shopping bags.

While we support prior versions of this bill which prohibited the distribution of non-biodegradable single use plastic bags and did not pre-empt the County's legislation, the current draft of this bill includes significant amendments which change the entire purpose and potential outcome of the original legislation.

Kauai County has already deliberated on this issue, received community input, and has passed the attached Kauai County Ordinance No. 885 which requires all retail establishments to provide only recyclable paper bags, biodegradable bags, and/or reusable bags to their customers. Under this law, retailers may elect to charge fees for bags which could be used to reimburse retailers for bag costs. Kauai County is ready to gather input to adopt our administrative rules for this new ordinance, which is scheduled to take effect on January 11, 2011.

There is a concern that the proposed bill conflicts with our ordinance, and does not prohibit the use of non-biodegradable single use plastic bags. These bags were specifically targeted for reduction in our ordinance because they have significant impacts on the environment, including contributing to unsightly litter; creating an additional burden on the landfill; endangering marine animals; and requiring the use of fossil fuels for manufacture.

Therefore, we humbly request your consideration to remove the preemption clause from this bill and request that you allow each county to enact legislation as appropriate. We believe such a change will help preserve the home rule that the Counties currently exercise. We thank the Committee for the opportunity to testify on this matter.

ORDINANCE NO. 885

BILL NO. 2321, Draft 2

A BILL FOR AN ORDINANCE ESTABLISHING A NEW ARTICLE 19, CHAPTER 22, KAUAT COUNTY CODE 1987, RELATING TO PLASTIC BAG REDUCTION

BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF KAUA'I, STATE OF HAWAI'I:

"SECTION 1. Findings and Purpose. The production and use of plastic checkout bags have significant impacts on the environment, including, but not limited to: contributing to unsightly litter; creating an additional burden on the landfill; contributing to potential death of marine animals through ingestion and entanglement; and requiring the use of millions of barrels of crude oil for their manufacture.

The Council of the County of Kaua'i finds and declares that to preserve the health, safety, welfare and scenic beauty of Kaua'i, the distribution of plastic bags should be regulated and prohibited.

The purpose of this legislation is to encourage customers to bring their own reusable bags when shopping. If the customer forgets to bring their own bag, or chooses not to, this ordinance does not prevent the retail establishment from providing recyclable bags for sale. This effort will lessen the negative impact on our environment caused by plastic shopping bags. Produce bags in grocery stores will still be permissible.

SECTION 2. Chapter 22, Kauai County Code 1987, is hereby amended by adding a new Article 19 to be appropriately designated and to read as follows:

ARTICLE 19. PLASTIC BAG REDUCTION

Sec. 22-19.1 Definitions.

As used in this Article, unless the content clearly requires otherwise:

"Biodegradable Bag" means a bag that (1) contains no polymers derived from fossil fuels; and (2) is intended for single use and will decompose in a natural setting at a rate comparable to other biodegradable materials such as paper, leaves, and food waste. The Department of Public Works shall promulgate rules identifying bags meeting this definition. These rules shall also set forth an application process whereby a retail establishment can obtain determination whother a bag is a biodegradable bag.

"Checkout Bag" means a bag that is provided by a retail establishment at the checkstand, cash register, point of sale or other point of departure for the purpose of transporting food or merchandise out of the establishment. Checkout bags does not include bags provided solely for produce, bulk food, or meat at a produce, bulk food or meat department within a grocery store, supermarket, produce or meat market or other similar retail establishment.

"Recyclable Paper Bag" means a bag that meets all the following requirements: (1) contains no old growth fiber; (2) is one hundred percent (100%) recyclable overall and contains a minimum of forty percent (40%) post-consumer recycled content; and (3) displays the words "Reusable" and "Recyclable" in a highly visible manner on the outside of the bag.

"Retail Establishment" means any commercial business facility that sells goods directly to the ultimate consumer, including, but not limited to, grocery stores, pharmacies, liquor stores, "mini-marts," and retail stores and vendors selling clothing, food and personal items. Retail establishments shall not include fundraisers by organizations classified under Section 501(c) of the United States Internal Revenue Code or non-incorporated community booster organizations.

"Reusable Bag" means a bag with handles that is specifically designed and manufactured for multiple reuse and is made of cloth or other machine washable fabric and/or is made of a durable material at least 2.25 millimeters thick and suitable for reuse.

Sec. 22-19.2 Mandatory Use of Recyclable Checkout Bags.

- (a) All retail establishments shall provide only the following as checkout bags to customers: recyclable paper bags, biodegradable bags and/or reusable bags.
- (b) Nothing in this ordinance shall preclude any retail establishment from offering checkout bags for sale to customers.

Sec. 22-19.3 Enforcement and Penalties.

- (a) The County Engineer or designee will have primary responsibility for enforcement of this Article through the issuance of violation notices and requests to correct or cease the violation. The County Engineer or designee is authorized to promulgate regulations and to take any and all other actions reasonably necessary to enforce this Article, including, but not limited to, entering the premises of any affected Retail Establishment to verify compliance.
- (b) Should the retail establishment fail to comply with the requirements of this Article after reasonable notice by the County Engineer or designee, the County Engineer or designee may seek administrative imposition of a fine. The owner or

legal entity holding title to the retail establishment found in violation of this Article shall be subject to civil penalties as follows: (1) \$250.00 per day for the first notice of violation, (2) \$500.00 per day for the second notice of violation within 365 days of the first notice, and \$1,000.00 per day for the third and subsequent notices of violation within 365 days of the first notice.

(c) The County Engineer or designce must afford the Retail Establishment the opportunity for hearing before a hearings officer under Hawai'i Revised Statutes Chapter 91.

Sec. 22-19.4 No Conflict with Federal or State Law.

Nothing in this Article shall be interpreted or applied so as to create any requirement, power or duty in conflict with any federal or state law.

Sec. 22-19.5 Exemptions.

Situations where compliance with the requirements of this Article would deprive a retail establishment of any rights to which it would be entitled.

SECTION 3. Severability. If any provision of this Article, or the application thereof to any person or circumstance is held invalid, the invalidity does not affect other provisions or applications of the Article which can be given effect without the invalid provision or application, and to this end the provisions of this Article are severable.

SECTION 4. This ordinance shall take effect on January 11, 2011."

To Whom It May Concern:

I serve the residents of the District of Columbia and Ward 6 on the Council of the District of Columbia, and am also the chair for the Local Government Advisory Committee for the Chesapeake Bay. Thank you for allowing me to submit comments on Hawaii SB 2559 related to the experience in the District of Columbia with similar legislation that placed a 5-cent fee on disposable bags.

As you may know, I introduced legislation in the District of Columbia last year – the Anacostia River Cleanup and Protection Act of 2009 – which was driven by a desire to create a cleaner Anacostia River and to reclaim it for our communities. Last June, the Council of the District of Columbia unanimously passed the Anacostia River Cleanup and Protection Act of 2009. It was a proud day for the District and a statement of our shared hopes for the Anacostia River.

The Anacostia River – long noted as one of America's top ten dirtiest rivers – is a little over 8 miles long. It spans Montgomery and Prince George's counties in Maryland, as well as the District of Columbia and nearly 20,000 tons of trash entering the Anacostia River each year. From the first ever comprehensive study of trash in the River, we learned that disposable plastic bags make up nearly 50% of the trash in the tributaries and more than 20% of the trash in the River's main stem.

Contrary to what many people believe, the bags are not free. Our citizens pay for trash cleanup along the rivers, pay for recycling programs, and spend millions of dollars for trash removal and disposal in landfills. These are important efforts, but they have not substantially reduced the pollution in our river. They only target the trash once it's already been created – rather than trying to reduce trash at its source.

The District's new law is doing just that: the District's 5-cent fee went into effect on January 1st of this year. Within the first few weeks, large stores reported a drop of more than 50% in their customer's carryout bag usage. In many cases, the drop was even more significant. One store owner, who was originally opposed to the initiative, recently wrote about the law's success: her customer's disposable bag use has dropped 80-90% and she is now finding significant reductions in her own overhead costs for her business.

Customers have adapted to the change quickly. The 5-cent fee has proved to be what it was intended – a price to get into your head and not your wallet. It allows the consumer to decide if they need a disposable bag. It also no longer hides the cost of a disposable bag in the goods we purchase and gives a choice to the consumer.

The Anacostia River Cleanup and Protection Act also requires a public education campaign and reusable bag distribution to residents, with emphasis on reaching low-income residents and seniors. So far, 23,560 bags have been distributed; the bags have been distributed at outreach events, through WIC for seniors and the Office of Aging, to utility assistance recipients, through Council events and at grocery stores through partnerships with the private sector, in particular CVS and Giant.

Finally, I have been impressed, even surprised, by the degree of broad constituent support for this initiative. Support comes not only from environmental leaders, but also from senior groups, soup kitchens and small businesses. They stood with us in support of the 5-cent fee because they believed all residents care about cleaning the Anacostia River and can make daily choices that impact the trash in our waterways. The social inequity of a river clogged with trash running through many of our low-income communities was cause enough to make shared action the highest priority.

We are proud of this law in the District and what it will do for the Anacostia River. I urge you to make the same choice for Hawaii.

Testimony in Support

Chair Oshiro, Vice Chair Lee and members of the Committee on Finance. On behalf of the Hawaii Audubon Society, we offer this testimony in support of SB2559, SD2, HD1, which would require businesses in the State to collect a 5 cent offset fee for each plastic or paper disposable checkout bag provided to a customer.

The Hawaii Audubon Society was founded in 1939, and is Hawaii's oldest conservation organization. The Society's primary missions are the protection of Hawaii's native birds, wildlife, and habitats, as well as, our aquatic and coastal resources. This includes preventing various types of waste including plastic bag litter from entering Hawaii's ecosystems.

A direct consequence of this waste is the deleterious impact it has on our island protected species, including the marine birds like the Short-Tailed Albatross, as well as, marine reptiles such as the Hawaiian Green Turtle. Both species often mistake plastic bags, and parts of bags, as food and ingest them.

In 2001, the United States Environmental Protection Agency estimated that somewhere between 500 billion and a trillion plastic bags are consumed worldwide each year. Millions of these plastic bags end up outside of landfills. The use of plastic bags has resulted in a dramatic increase in the amount of sacks found floating in oceans where they choke, strangle, and starve wildlife.

We would point out that governments across the world have successfully reduced plastic bag use, either through plastic bag bans, or through fees or taxes. The following countries have all taken measures to reduce their plastic bag usage in an effort to protect their precious natural resources and valuable coastlines: Ireland, China, Tanzania, Taiwan, Australia, Italy, and South Africa. Cities throughout the world have also banned plastic bags including San Francisco, Manhattan Beach, Malibu, Los Angeles, Edmunds (WA), Outer Banks (NC), District of Columbia, Mexico City, Rio de Janeiro and Mumbai. Here in our state of Hawaii, Maui and Kaua'i County passed their own bans, and the Big Island came very close.

We believe the offset fee will accomplish two things: 1) for the short term, it will raise revenues, and 2) in the long term, it will change people's behavior and curtail plastic bag waste from entering our ecosystem.

SB2559, SD1, HD1, is a well balanced, practical measure that will go a long way in improving and protecting our unique ecosystems. We would urge you to pass this bill.

Chairs & Committee Members:

We support the concept of SB 2559 SD2 HD1, as a means of encouraging consumers to reduce the use of one-way bags of both paper and plastic, degradable and compostable, by retail establishments. We are convinced it will work, based on consumer response to many of our retail grocery stores now offering customers a nickel credit for every customer bag used to carry their purchases from the store. The consumer response has been overwhelming with consumers asking that their purchases be placed in as many bags as they can justify, to maximize their return in nickels. This measure reverses the procedure, where the customer will either bring in their own bags, or ask that their purchases be placed in as few bags as possible. This however can be expected to lead to other problems, where the bags can't hold the purchase, creating an increase in damaged goods, and possible injuries, especially if the bag is very heavy.

We suggest modification of the measure to place the collection of the fee from the wholesaler or importer of the bags to eliminate a substantial amount of the cost that would be required by both retailers and government, as it would eliminate upwards to two thousand retailers from paying the fee to less than a hundred importers or suppliers paying the fee directly to the State. This would also eliminate the slow down at each check stand to determine how many bags must be charged out to the customer, and creating an audit trail for each bag sold. Retailers are advising us that for a supermarket, it will require an additional check stand to be open to address the slow down in service. This along with the accounting required will more than eat up the retailer retaining a few cents for each bag to cover their costs. The proposal we suggest would eliminate the retailer's cost, reduce time, and accomplish the same purpose, but will require consumer education.

We have precedence on this method with the glass Advance Disposal Fee that has been in effect since 1994. It was designed to simplify collection, payment, and auditing. It does this because payment is based on case lots rather than by individual items, and is at the wholesale level rather than the retail level.

§342G-82 Advance disposal fee. (a) Every glass container importer shall pay to the department an advance disposal fee. The fee shall be imposed only once on the same glass container and shall not be assessed on drinking glasses, cups, bowls, plates, ashtrays, and similar tempered glass containers. For the period beginning September 1, 1994, the fee shall be one and one-half cents per glass container. Beginning October 1, 2004, the glass advance disposal fee shall only apply to glass containers that are not glass deposit beverage containers.

- (b) The legislature shall have exclusive authority over all matters subject to this chapter.
- (c) No county shall impose or collect any assessment or fee on glass containers for the same or similar purpose that is the subject of this chapter. [L 1994, c 201, pt of §2; am L 2002, c 176, §9]

While this method would substantially reduce the administrative process by both retailers and government, it does create one challenge, in that it will require an educational program to assure that consumers are aware of the added costs.

Bags are just the beginning of addressing the issue of our landfills becoming landfulls. Just about everything we purchase is packaged. It is all one-way packaging to assure our products are safe, secure, sanitary, and un-tampered. The tens of thousands of products ranging from cereal to computers create waste. We recently submitted a brochure to Legislators with the caption "We live in an oilfield, yet we call it waste," concluding that "The Problem is the Solution."

Hawaii being a non-contiguous state, we must think out of the box, and realize that when we recycle by shipping plastic, paper, glass, and other items back to the Mainland, China, or another foreign country it cost lots of money and labor, while we continue to pay top dollar to import oil. If we can turn the thousands of tons of packaging into energy, we use energy that comes in free as packaging. Especially with plastic, shrink wrap, and polystyrene that has a Btu about double that of the coal we import to generate electricity. While Oahu has HPOWER as a Waste to Energy (WTE) facility, the Neighbor Islands do not, and must.

This measure has the dual purpose of reducing one-way bags, while generating much needed revenue for our bleeding budget that the Legislature has to balance. We have no problem with this, as we well understand what balancing a budget means for survival. We do however need to look beyond the two or three year period of our poor economy and create a law that will use these revenue to support Waste To Energy facilities in each county, once we are out of the economic crunch we are in. We are recommending that the measure be written to reflect this goal as a baseline for the future sustainability of Hawaii as a main method of reducing our reliance on oil for the generation of electricity, while addressing our landfill problems.

The HD1 version of the bill creates a 3 cent fee to the State, with 2 cents to cover the retailer's costs. We guestimate that each one cent of fee would generate upwards to \$10 million in revenue. Of course as the reduction of bags occurs, so will the revenue, which is the original intent of this proposal in the first place. With our suggestion, the retailer's portion would not be necessary, as the fees would become a part of the wholesale cost of the bags.

Chair Oshiro, Vice Chair Lee, and Members of the Committee:

Retail Merchants of Hawaii (RMH) is a not-for-profit trade organization representing 200 members and over 2,000 storefronts, and is committed to support the retail industry and business in general in Hawaii. The retail industry is one of the largest employers in the state, employing 23% of the labor force.

RMH supports the intent of SB2559, SD2, HD1, which requires businesses in the state to charge and collect a 5-cent off-set fee for each disposable checkout bag provided to a customer.

Undeniably, this proposal is a practical, viable and preferred option to an outright ban on single-use checkout bags and places the responsibility for the careless discard and misuse, or the wise re-use and management, of these items on the ultimate consumer.

Hawaii's retailers unquestionably support the broadest use of reusable tote bags as the ultimate solution for the environment, and have been proactive in providing these for our customers. However, we do know that consumers' acceptance and use of reusable bags will not be universal, affordable or practical at all times. This measure allows us to provide options as demanded by our customers.

While we remain concerned with the additional cost at the grocery level to our residents who have the least resources, we are hopeful that consumers will accept this fee as an investment in our environment rather than a burden, and embrace the usage of reusable bags.

We ask your consideration to include dry cleaner, door hanger and newspaper bags in the program in the near future. As the genesis of this legislation is concern with the impact of plastic materials on our environment, vis a vis, our oceans, marine life and landfills, we believe that these types of plastic bags have the propensity to cause the same harm as single-use checkout bags.

Thank you for your attention and for the opportunity to comment on this measure.

The American Chemistry Council (ACC) must respectfully oppose SB 2559 SD2, HD 1 that would impose a \$0.05 "offset fee" for each retail bag provided to customers by businesses.

Though we support the intent of reducing bag litter and waste, we believe that the most environmentally responsible and economically sustainable solution to addressing this issue is a comprehensive program aimed at recycling these bags so that they may be used as feedstock in the production of other products, such as new bags, pallets, containers, crates, and pipe.

Recycling policies have been recently adopted by the State of California, New York, Rhode Island, and Chicago and many voluntary initiatives are underway in other jurisdictions.

As you may know, recycling of plastic bags is growing fast in the United States. <u>In 2008 over 832 million pounds of plastic bags and wraps were recycled, representing a 28 percent increase in only a few years</u>. According to EPA data, recycling of polyethylene bags and wraps reached 12 percent in 2007.

When the City of Seattle, WA was considering a similar "bag tax" proposal, a fiscal analysis stated the city's Department of Executive Administration's (DEA) costs <u>"would also include approximately \$250,000 to DEA to administer the fee."</u>

You may also be interested in knowing that Seattle voters overwhelmingly rejected a consumer bag charge, and the California State Assembly Appropriations Committee earlier this year held two pieces of legislation (AB 68 and AB 87) that would have required certain grocers and retailers to impose a per bag consumer charge.

ACC would welcome the opportunity to partner with the State of Hawaii, the grocery and retail industry, recyclers, and other interested stakeholders to enhance and/or develop a system that effectively and efficiently helps to recycle these products. Our industry is involved in many

similar programs in California, Washington State, Illinois, and Philadelphia to name just a few and it is our view that <u>a per bag fee as proposed in SB 2559 SD 2 HD 1 is unnecessary.</u>
Furthermore, this language does not take into consideration that many consumers do not have the luxury of carrying reusable bags with them at all times. For instance, those that rely solely on public transportation may be disadvantaged as it may be difficult for them to constantly carry reusable bags.

Finally, this legislation fails to recognize that many consumers reuse their plastic bags for other household duties such as waste can liners or for pet waste. One unintended consequence of this legislation could force consumers to purchase new plastic bags to replace the retail bags they previously reused.

As stated above, ACC believes the most appropriate policy is to work collaboratively with industry, retailers, and others to promote recycling of these products instead of imposing a new charge on consumers, especially during these difficult economic times.

Aloha. Conservation Council for Hawai'i supports SB 2559 SD 2 HD 1, which requires businesses in the State to charge and collect an offset fee of five cents for each disposable checkout bag that is provided to customers.


This bill encourages more residents and visitors to use reusable bags. This would reduce the number of sea turtles and other marine wildlife that are killed or harmed by ingesting disposable plastic bags. Sea turtles ingest plastic bags, mistaking them for food, and may suffer a gruesome death. The ingested bag may get trapped in the turtle's gut, prevent food from going down, lead to absorption of toxins, and reduce the absorption of nutrients from real food. Trapped food decomposes, leaks gases into the body cavity, and causes the turtle to float. The turtle then slowly starves to death or succumbs to other secondary life-threatening conditions, such as a boat strike.

This bill would also result in reducing the number of disposable bags we use, and the energy needed to manufacture, ship, and discard them. This saves the people and the government money, and contributes to a more sustainable way of living on these islands. Americans go through more than 100 billion plastic bags each year, yet less than 5% are ever recycled. Let's make a positive change and end this wasteful practice any longer.

Dear Chair Oshiro and Committee Members.

My name is Stuart Coleman, and I am the Hawaii Coordinator of the Surfrider Foundation. With more than 4000 dues-paying members across the state, the Hawai'i Chapters of the Surfrider Foundation strongly support passage of SB2559, a bill designed to address the harms of non-biodegradable single-use plastic and paper check out bags that are degrading the environment and harming marine life. Millions of sea birds, fish, sea turtles and marine mammals die each year due to entanglement and ingestion of plastics.

This bill will encourage people to switch to reusable tote bags and improve Hawaii's natural environment. Imposing an offset fee also provides a practical and economical solution that will: 1. Encourage people to bring reusable bags and protect the environment; 2. bring revenue to the state's general fund and help local stores save money by buying fewer plastic bags; 3. help the counties cut costs in having to clean up these toxic tumbleweeds (Maui Country paid more than \$200,000 in cleanup costs.); and 4. extend the life of our landfills by years.

Governments across the world have successfully reduced plastic bag use, either through plastic bag bans or fees. Maui and Kaua'i County passed their own bans, and the Big Island came very close. The following countries and cities have all taken measures to reduce their plastic bag usage in an effort to protect their precious natural resources and valuable coastlines: Ireland, China, Tanzania, Taiwan, Australia, Italy, South Africa, San Francisco, Manhattan Beach, Malibu, Los Angeles, Edmunds (WA), Outer Banks (NC), District of Columbia, Mexico City, Rio de Janeiro and Mumbai. Within the first year of imposing a fee, Ireland's plastic bag use dropped 90%. Eventually, all governments and people will realize how economically wasteful and environmentally damaging single-use plastic bags are. Will our state be a leader or a latecomer in this movement?

The Hawaii Chapters are supporting HB2125 because Surfrider's mission is to preserve the health of our oceans and the quality of our beaches. Plastic bags that end up in the ocean or on our coastlines not only endanger sea turtles, seabirds, and marine mammals, but they also adversely affect the entire marine food web. Because plastic does not biodegrade, plastic waste never truly disappears; it only breaks down into smaller and smaller pieces. These "microplastics" attract toxic chemicals and pollutants in the water and are often consumed by fish and filter feeders that mistake them for food. Because plastics cannot be digested, they concentrate these pollutants in the fish as they make their way up the food chain and into our seafood. So this is a human health issue as well as an environmental hazard.

Single-use plastic bags also have hidden costs that hit our wallets, and everyone pays for these so-called "free" bags. Taxpayers spend as much as \$0.17 on each plastic bag they receive because they have to subsidize the recycling, collection, and disposal of these toxic plastic bags. Retailers spend as much as \$0.05 per bag (a price which is incorporated into the price of food and goods, then passed on to consumers) when they provide a consumer with a "free" plastic bag. States, cities, and counties together spend about \$4.41 per capita, per year on general litter abatement. By reducing the amount of plastic bags, this money will be better spent.

We ask that you remove the preemption section from the bill because the people of Kauai and Maui worked hard to ban disposable plastic checkout bags, and we should not interfere with their positive actions. With the fee bill, most consumers will quickly transition to using reusable bags, and our environment will benefit tremendously. Some consumers will continue to use disposable plastic bags, and the State will reap the rewards of the fees, which will more than pay for the program; so it's a win-win situation. Testimony of Zero Waste Kauai Zero Waste Kauai, a local, grassroots, community action group promoting sustainable waste management practices, and representing over 70 active recycling advocates, and hundreds of citizens in our information and education network, has major concerns regarding the latest version of HB 2559.

Following the lead of their constituents the elected representatives of both Maui and Kauai County have passed County ordinances banning single use plastic bags, now, at the request of the Retail Food Industry the legislature is trying to overturn the public's wishes. The preemption clause should be deleted.

While the intent of the proposed legislation is to significantly reduce the use of single use plastic bags, the fee is inadequate to stimulate the needed change. When a bag full of groceries costs \$10 to \$20 adding 5 cents to the price will not result in a significant reduction in plastic bags ending up in our environment. The fee should be set, at a minimum, at 15 cents per bag - 20 cents would be much better.

In addition, "fees" are supposed to be targeted surcharges, used to fund programs dealing with the inherent problem. None of the money collected is earmarked for expanding recycling, litter control or marine clean-up efforts. In fact the bulk of the fee would remain with the Retailer with the balance going to the General Fund. In fact no funds are even earmarked to cover the costs of implementing and managing an expensive monitoring and regulatory program. At least 50% of the "fee" should be directed to support County recycling efforts, litter clean-up and marine pollution mitigation programs.

A ban is a simple, straight forward, logical solution. Kauai and Maui have enacted bans. If the legislature can't enact a statewide ban, nor establish a fee program that is adequate to address the problems with plastic bags, then they should shelve this bill and try again later.

1. Amend the bill to change to:

§342H-E Preemption. The provisions of this part shall **not** preempt the powers of any county to regulate the use of disposable checkout bags.

2. Amend the bill to change to:

§342H-B Distribution of disposable checkout bags; offset fee. (a) Beginning January 1, 2011, all businesses in the State shall charge and collect an offset fee of ten cents for each disposable checkout bag that is provided to customers ...

This as much as doubles the revenue to the State, will actually reduce single-use bag use, and respects the Counties that have already passed ordinances dealing with single use bags; otherwise without these changes, this bill should be deferred.
