RE: S.B. 2662; RELATING TO PORNOGRAPHY OFFENSES AGAINST CHILDREN.

Chair Chun Oakland and members of the Senate Committee on Human Services, the Department of the Prosecuting Attorney submits the following testimony in support of S.B. 2662.

The purpose of this bill is to amend the class C felony offense of promoting pornography for minors to make it part of the offense to disseminate pornographic material to persons who represent themselves to be under the age of eighteen. In addition, this bill adds the offense of promoting child abuse in the third degree to the list of offenses which may be initiated by information charging.

With the advent of widespread access to the internet and the ease it facilitates communication, pedophiles have had another tool they can use to meet and groom children. One common method is to expose the child to pornographic images to accustom the child to sexual conduct. To investigate and prevent this type of grooming conduct, law enforcement officers often go online and pose as minors. The amendment proposed by S.B. 2662 will allow for the prosecution of these pedophiles who fully intended to send pornography to a minor.

In addition, we support the addition of the offense of promoting child abuse to the list of information charging offenses. Use of information charging will spare the victim, police and civilian witnesses the necessity of having to appear before a grand jury or at a preliminary hearing, promotes efficiency and allows the investigating officers to continue working on cases instead of waiting at court to testify.

For these reasons, we support the passage of S.B. 2662 and thank you for the opportunity to testify.

The Honorable Chairpersons and Committee Members:

The Department of the Prosecuting Attorney for the County of Maui strongly supports S.B. 2662, Relating to Pornography Offenses Against Children.

This bill seeks to amend the offense of Promoting Child Abuse in the Third Degree by prohibiting anyone from disseminating pornographic material to another person who represents themselves to be under the age of eighteen.

Through experience in investigating sexual offenses committed against children, law enforcement officials have learned that child predators often send pornographic images to minors in an effort to gain the trust and lower the inhibitions of their minor victims. Here, the ultimate objective of the child predator is to meet with and sexually assault the minor. Tragically, sometimes the child predator murders the minor.

This bill will provide law enforcement with another tool in which to combat the despicable behavior of these child predators. Law enforcement officers sorely need this weapon in its arsenal in the war against online child predators. Indeed, the ultimate goal is to provide greater protection to our children.

In addition, this bill will give law enforcement the ability to utilize the information charging process for the offense of Promoting Child Abuse in the Third Degree. This will undoubtedly result in the conservation of judicial, prosecutorial, and police resources.

Accordingly, our Department strongly supports S.B. 2662. Thank you for the opportunity to testify.

RE: Support for SB2662, Relating to Pornography Offenses Against Children

Please help to strengthen the law against child pornography by passing this measure. Like domestic violence, child pornography is a HUGE problem that goes unnoticed until substantial harm has been caused. In her book "*And Justice For Some*" New England School of Law professor, Wendy Murphy, said the following in her chapter entitled "*Calling Child pornography Harmless*":

"Child pornography is a multibillion-dollar business run by people who are destroying innocent children's lives for money. They know that law enforcement will never have enough resources to stop them completely."

"According to a 2005 study funded by Congress, <u>80% of child pornography depicts children being penetrated</u>. This is what you would think of as rape and sodomy. A full 21% also involved sadism such as bondage, whips, chains, and ligatures wrapped around little arms, legs, and necks while body parts and objects are inserted into tiny private areas. <u>Something like 83% of child pornography depicts children between ages 6 and 12</u>... Sadly and maybe most disturbing, according to Attorney General Gonzales, it's often parents taking the pictures."

"Dr. Andres E. Hernandez, in his capacity as the director of a Federal Sex Offender Treatment Program, found that among federal prisoners who were incarcerated on child-pornography charges, approximately two-thirds had molested children. Even more shocking, the prisoners reported having sexually assaulted an average of more than 30 children each without ever having been detected."

Thank you for this opportunity to provide testimony on this matter and please do all you can to stop this particular form of child abuse.
