S.B. 2704 RELATING TO PUBLIC CHARTER SCHOOLS

Chair Sakamoto, Vice Chair Kidani, and members of the Committee:

The Administration <u>strongly supports</u> S.B. 2704 and recommends that the Committee adopt the technical amendments proposed by the Office of the Attorney General.

Current state laws hinder public charter schools' success by:

- (1) Artificially restraining the growth of public charter schools by restricting the number of public charter schools that can operate within the State;
- (2) Limiting charter authorization powers to a single entity; and
- (3) Inequitably funding public charter schools students in comparison to their peers at conventional public schools.

This Administration-sponsored bill seeks to address these challenges and improve the public charter school system by:

- (1) Repealing the cap on the number of charter schools allowed to operate within the state. Currently, Hawaii is limited to starting one new public charter school for every two existing start-up charter schools that have been accredited for a minimum of three years; or for each start-up charter school whose charter is revoked. The total number of conversion charter schools is statutorily capped at 25.
- (2) Allowing nonprofit organizations located either in-state or out-of-state and higher educational institutions located in-state to become a charter authorizer. Currently only the Charter School Review Panel, with the oversight of the Board of

Education, can authorize a new charter school. The Charter School Review Panel is currently composed of twelve members, including two public charter school teachers, two educational officers employed at public charter schools, one member of a public charter school local school board, the chair of the Board of Education, one representative from a Hawaii culture-focused charter school, one member with a business background, one member with a background in building trades or real estate, and a representative from the Hawaii Association of Independent Schools.

(3) Setting the per pupil funding for charter schools at the same level as conventional schools in the annual Department of Education approved budget. The amount of the per pupil funding to the charter school students is \$6,258.02 for FY 2009-2010, whereas the per pupil funding to non-charter public school students is \$11,520.

The bill also creates a Deputy Superintendent of Public Charter Schools who will serve under a restructured Department of Education and a new Governor-appointed Superintendent of Education, as proposed in the Administration-sponsored bills S.B. 2706 and 2707.

In addition, Hawaii's ability to compete for more than \$4 billion in federal stimulus funds in the Race to the Top Fund will be improved by strengthening the State's public charter school law since the federal government will evaluate states' commitment to expanding successful, high-performing public charter schools and shutting down poor performing public charter schools.

Lastly, the Administration recommends that the Committee adopt the amendments proposed in the testimony submitted by the Attorney Generals' Office, which propose technical changes to the definition section in chapter 302B. Thank you for the opportunity to testify on this important measure.

Chair Sakamoto and Members of the Committee:

The Department of the Attorney General provides these comments to address potential legal problems that may arise with respect to this bill.

The purpose of this bill is to strengthen public education by repealing the statutory limit on the number of public charter schools, allowing multiple charter school authorizers, and ensuring that public charter school students receive funding equal to non-charter public school students.

Section 5 of the bill, which begins on page 7, contains amendments to Hawaii Revised Statutes (HRS) section 302B-1, "definitions." A definition of "charter authorizer" or "authorizer" has been added giving other entities in addition to the charter school review panel powers and duties to issue and revoke charters, approve detailed implementation plan revisions, and conduct public charter school evaluations. The amendments throughout the bill to other sections of HRS chapter 302B are consistent with this intent. There appears, however, to have been an oversight in not amending paragraphs (6) and (11) of the "organizational viability" definition under section 302B-1.

Testimony of the Department of the Attorney General Twenty-Fifth Legislature, 2010 Page 2 of 2

In order for a charter school to be deemed organizationally viable, the charter school must be in compliance with all eleven paragraphs contained in the definition of "organizational viability" in section 302B-1. Paragraphs (6) and (11) of the "organizational viability" definition currently reads as follows: "(6) Cooperates with board, panel, and office requirements in conducting its functions;" and "(11) Complies with all panel directives, policies, and procedures."

To fulfill what appears to be the intent of this bill, we recommend that the bill be amended to replace the term "panel" in paragraphs (6) and (11) under the definition of "organizational viability" with "authorizer." Without this amendment, a charter authorizer other than the panel would have no ability to require a charter school it has authorized to cooperate with the authorizer in conducting the authorizer's functions and would have no ability to require a charter school it has authorized to comply with the authorizer's directives, policies, and procedures. Thus, for an authorizer other than the charter school review panel, paragraphs (6) and (11) under the definition of "organizational viability" would have no force or effect.

Department's Position: The Department of Education opposes this bill. The issue of equitable

funding should be resolved as proposed in SB 2587, which creates a

charter schools funding task force to establish a consistent and equitable

of equity of funding is very complex and requires in-depth analysis. The

probability of reaching agreements regarding equitable funding is much

greater with the key decision-makers who would be members of this task

force.

The Office of Hawaiian Affairs (OHA) <u>supports</u> SB2704 with reservations. This act will improve the Stateÿs educational system, remove barriers to public charter school and innovation, and improve Hawaiÿiÿs ability to rigorously compete for new federal funding by:

- 1) Repealing the limit on the number of new start-up and conversion public charter schools allowed in the State;
- 2) Allowing multiple public charter school authorizers to operate within the State;
- 3) Establishing a public charter reauthorization process; and
- 4) Ensuring that public charter school students are funded at an equitable level to students at non-charter public schools.

OHA has reservations on language transferring the oversight of the charter school administrative office from an executive director to a deputy superintendent for public charter schools appointed by the superintendent of education. While this may streamline administrative functioning especially in relation to proposed changes in charter authorizers, the relationship between the CSAO director and the charter school community has been beneficial and advantageous to the charter school community. This aspect of the act deserves more public input.

In addition, OHA finds that there is insufficient attention paid to § 9 302B-5 (d) (3) and §10 302B-6 (d) (3), Hawaiÿi Revised Statutes, both of which refer to the application for start-up and conversion charters which state:

(d) (3) The curriculum and instructional framework to be used to achieve student outcomes, including an assessment plan;

These sections are key in addressing the success factors outlined in the American Recovery and Reinvestment Act (ARRA) of 2009. ARRA states under "Competition Priorities, Priority 1: Aboslute Priority -Comprehensive Approach to Educational Reform":

To meet this priority, the Stateÿs application must comprehensively and coherently address all of the four education reform areas specified in the ARRA as well as the State Success Factors Criteria in order to demonstrate that the State and participating LEAs are taking a systemic approach to The State must demonstrate in its education reform. sufficient LEAparticipation application and commitment to successfully implement and achieve plans; and it must describe how the goals in its the State, in collaboration with its participating LEAs, will use Race to the Top and other funds to increase achievement, decrease the achievement gaps across student subgroups, and increase rates at which students graduate from a high school prepared for college and careers.

The State of Hawaiÿiÿs Race to the Top application signed on January 15, 2010 by the Governor, the State Superintendent, and the Board of Education Chair falls short, for example, in its plan to decrease the achievement gap across student subgroups. In Section I: Selection Criteria: Progress and Plans in the Four Education Reform Areas, page 13, the application states:

The Stateÿs Native Hawaiian students and economically disadvantaged students experience the largest disparities in academic achievement as compared to "all students", and in order to meet its commitment to closing the achievement gaps, the HIDOE

must therefore analyzes student subgroup categories with a different lens than that which is used by the federal government.

The State cites 2009 HAS data for Native Hawaiian students for profiency in HAS math (-13%) and HAS Reading (-11%) as evidence of that disparity. In five years, the HIDOE hopes to change the Native Hawaiian proficiency levels as follows: HAS Math (- 8%) and HAS Reading (-7%). In order to "achieve ambitious targets" in statewide impact for Native Hawaiians the application states that "HIDOE will collaborate with the UH to provide data and information to meet these and other goals along the P20 continuum (p.13)." No other strategies are given in regards to rectifying this disparity. OHA maintains that this effort is less than minimum and is unacceptable. Given that the curriculum and instructional framework is not defined and that the plan to decrease the achievement gap is deferred to the

University of Hawaiÿi, the effort herein to improve Hawaiÿiÿs ability to rigorously compete for federal funding appears ineffective.

The Center for Education Reform recently gave Hawaiÿiÿs public charter school law a "D" grade in an evaluation of the stateÿs ability to compete for Race to the Top funding. The current limit on public charter schools, the lack of multiple public charter school authorizers, and the stateÿs ambiguous commitment to equitable funding for students at public charter schools are but some of the compelling reasons for the low grade. Some other reasons are suggested in OHAÿs reservations: 1) the need for public discourse on CSAO oversight; and, 2) lack of rigor in the HIDOEÿs plan to increase achievement and decrease the achievement gap for Native Hawaiians and other economically disadvantaged subgroups.

OHA supports SB2704 because it seeks to remove barriers to federal funding but recommends more rigorous language to address HIDOEÿs plan to increase achievement, decrease the achievement gaps across student subgroups, and increase the rates at which students graduate from a high school and are prepared for college and careers.


HCSN supports SB2704 which aligns very well with the Federal Race to the Top competition.

We also recognize that there are potential challenges and unintended consequences of certain far-reaching elements of this comprehensive bill. We also wonder whether certain premises are based on future changes in Board of Education governance, which as we understand would likely require Constitutional changes. Of main concern is converting CSAO's functions to a Deputy Superintendent in the DOE. Nationally, the public charter school authorizer generally retains such functions, but we withhold any judgment on what such a set up might look like.

We do acknowledge that an arrangement providing direct accountability to the Governor's Office is likely some time in the future.

We support this bill moving forward.

On behalf of the Hawaii Technology Academy (HTA), a public charter school which serves students in Oahu, Kauai, Hawaii Island and parts of Maui, thank you for the opportunity to offer testimony supporting the intent of this bill.

We support the repeal of the cap on public charter schools, having multiple public charter school authorizers, reauthorization of charter schools, funding equity for charter and non-charter schools, and improvements to enhance the state's ability to compete for federal funding under the Race to the Top (RTT) initiative.

We take no position on the provisions to allow the Governor to appoint a Charter School Review Panel (CSRP) with the advice and consent of the Senate and the transfer of the Charter School Administrative Office (CSAO) from an Executive Director to a Deputy Superintendent of Public Charter Schools. We defer to the CSRP and the CSAO on these matters.

HTA is one of Hawaii's 31 public charter schools that are part of the state public school system. Like Hawaii DOE schools, charter schools comply with federal and state education standards. We support efforts like this to improve Hawaii's public education system.

Most of all, we endorse changes that create equitable funding and a supportive environment for all DOE and public charter schools to better position Hawaii in competition for U.S. Department of Education's Race to the Top (RTT) initiative. States with policies in place supporting equitable funding for all public school students are at greater competitive advantage to qualify for RTT and other federal grant programs.
