SB 2729, SD2, HD1 RELATING TO IMMUNIZATION

Testimony of Chiyome Leinaala Fukino, M.D. Director of Health

March 25, 2010, 11:00 AM

- 1 **Department's Position:** The Department of Health strongly supports this administration bill.
- 2 Fiscal Implications: None. No state funds are required to implement this proposal. The Hawai'i
- 3 Immunization Registry (HIR) is supported via a federal Centers for Disease Control and Prevention
- 4 Immunizations and Vaccines for Children grant as well as a grant from the Hawaii Medical Services
- 5 Association Foundation.
- 6 Purpose and Justification: The intent of this proposal is to officially establish HIR in the Hawaii
- 7 Revised Statutes and grant the Department and other healthcare providers the authority to include patient
- 8 demographic and immunization information in HIR via implied patient or parent/guardian consent.
- 9 HIR is a secure, confidential, computerized system that has the capability to store immunization
- information for individuals of all ages in the State of Hawai'i. As individuals and families move or
- change health care providers, HIR will consolidate their immunization records, making them easily
- accessible to new immunization providers and ensuring that patients receive the immunizations that they
- 13 need while preventing the receipt of unnecessary doses of vaccines. In the event of an influenza
- pandemic or other public health emergency, HIR will provide the Department with the ability to record,
- 5 track, and monitor the administration of vaccinations as well as the distribution of antiviral and other
- 16 medications. This information is essential for the Department to rapidly assess who has been vaccinated

and identify under-immunized populations at risk for disease. This information is especially critical in

2 public health emergency situations to effectively direct scarce or otherwise limited Departmental

3 resources to the populations or areas most in need.

The Department strongly believes that an individual's right to privacy and the protection of confidential information contained in HIR are critically important; therefore, rigorous safeguards to ensure the confidentiality of the information have been engineered into the Registry system.

Confidentiality provisions have also been included in the proposed bill, and the Immunization Branch has developed the Hawaii Immunization Registry Confidentiality and Privacy Policy that has been reviewed and approved by the department's HIPAA Privacy Officer, Department of the Attorney General, and the Centers for Disease Control and Prevention Immunization Information Systems Support Branch. The Department has shared the HIR Confidentiality and Privacy Policy and other HIR privacy-related materials with the American Civil Liberties Union of Hawaii and has invited the group to participate in the Hawaii Immunization Registry Coalition to ensure that their input regarding HIR


Per the suggestion of a constituent stakeholder, the Department would like to request that the definition of "Health care provider" (page one), be amended to include pharmacies. The suggested definition would read:

confidentiality and privacy practices and policies can be received on an ongoing basis.

"Health care provider" means a program, agency, clinic, health care center, <u>pharmacy</u>, physician licensed under the provisions of chapter 453, advanced practice registered nurse recognized under the provisions of chapter 457, pharmacist licensed under the provisions of chapter 461, physician's assistant licensed under the provisions of chapter 453, or person authorized to practice medicine as a physician or physician's assistant, or nursing as an advanced practice registered nurse, in federal facilities located in the State, that administers immunizations in Hawaii.



Chair Oshiro, Vice Chair Lee and Members of the Committee:

My name is Robert Witt and I am executive director of the Hawaii Association of Independent Schools (HAIS), which represents 99 private and independent schools in Hawaii and educates over 33,000 students statewide.

The Association is in support of Senate Bill 2729, SD2, HD1 – Relating to Immunization which authorizes the Department of Health to establish and maintain a single repository of immunization records to be designated as the "Hawaii Immunization Registry" in order to aid, coordinate, and help promote efficient and cost-effective screening, prevention, and control of vaccine preventable diseases, including pandemic influenza.

The Hawaii Immunization Registry (HIR) will help to ensure that all of Hawaii's people are protected from vaccine-preventable diseases. HIR has the capability to store and track immunization information, consolidate immunizations given by multiple providers into one record and make them available to authorized immunization providers.

The Registry will not require any additional reporting by schools; it will reduce school personnel workloads by allowing authorized school personnel access to student immunization information to quickly and easily determine a student's compliance with Hawaii's mandatory student immunization requirements.

HAIS believes that establishment of the Hawaii Immunization Registry will protect the health and safety of the public as well as an individual's right to privacy and the protection of confidential information.

Kaiser Permanente recognizes that nationwide, immunization registries like the Registry have proven to be valuable tools for the management and reporting of immunization information for health care providers.

In particular, Kaiser Permanente agrees that patient immunization information is available in the Registry without requiring prior patient authorizations for inclusion, and that any preference for exclusion needs to be expressed in writing, to facilitate the transferring of the most accurate and complete information to authorized immunization providers.

Aloha,

Been waiting for this a long time. Started practicing Pediatrics at Kalihi-Palama Health Center over twenty years ago. For the underserved children who needed medical care, holding onto that "yellow card" never was a priority amongst all the other issues that had to be dealt with. Calling other doctors for shot records, waiting for the faxes and checking with the hospitals didn't seem particularly efficient or effective.

In this age of Electronic Medical Records, it is critical to have the Hawaii Immunization Registry. Without the ready transfer of vaccination information between providers, the system is basically crippled. The functionality of the registry and the trust from the very providers that will benefit is dependent on how well the system works. This is critical from a public health standpoint in order to prevent serious illness.

SB2729 is a move towards a better way to access immunization information in Hawaii.
