#### SB 2729, RELATING TO IMMUNIZATION

Testimony of Chiyome Leinaala Fukino, M.D. Director of Health

Department's Position: The Department of Health strongly supports this administration bill. 1 2 **Fiscal Implications:** None. No state funds are required to implement this proposal. The Hawai'i 3 Immunization Registry (HIR) is supported via a federal Centers for Disease Control and Prevention Immunizations and Vaccines for Children grant as well as a grant from the Hawaii Medical Services 4 Association Foundation. 5 6 **Purpose and Justification:** The intent of this proposal is to officially establish HIR in the Hawaii 7 Revised Statutes and grant the Department and other healthcare providers the authority to include patient 8 demographic and immunization information in HIR via implied patient or parent/guardian consent. 9 HIR is a secure, confidential, computerized system that has the capability to store immunization information for individuals of all ages in the State of Hawai'i. As individuals and families move or 10 11 change health care providers, HIR will consolidate their immunization records, making them easily accessible to new immunization providers and ensuring that patients receive the immunizations that they 12 need while preventing the receipt of unnecessary doses of vaccines. In the event of an influenza 13 pandemic or other public health emergency, HIR will provide the Department with the ability to record, 14 15 track, and monitor the administration of vaccinations as well as the distribution of antiviral and other medications. This information is essential for the Department to rapidly assess who has been vaccinated 16

- 1 and identify under-immunized populations at risk for disease. This information is especially critical in
- 2 public health emergency situations to effectively direct scarce or otherwise limited Departmental
- 3 resources to the populations or areas most in need.

Our mission is to promote initiatives aimed at improving the overall health of Hawaii. We are also active participants in the legislative process. Before providing any testimony at a Legislative hearing, all HAHP member organizations must be in unanimous agreement of the statement or position.

HAHP appreciates the opportunity to testify in support of SB 2729 which would establish and maintain a repository of immunization records to assist in the control and prevention of vaccine-preventable diseases.

Many other states have implemented the use of an immunization registry as a means to track and monitor the administration and distribution of vaccinations and other antiviral medications. Information of this type is used during public health emergencies to ensure that scarce resources are directed to those most in need. The registry will also be used by the Department of Health to report to the Centers of Disease Control and Protection.

We believe that this is an extremely important initiative especially when considering new and emerging diseases such as the H1N1 flu. An immunization registry will assist in the protection of Hawaii's residents in the case of a public health emergency. As such, we urge the Committee to pass SB 2729.

Health care for children and youth has long been a priority of the House and you, chair Yamane, know as well as I do, that prevention and early intervention not only saves money but saves lengthy and expensive treatment costs when children develop chronic illnesses. It is far better to prevent the illness rather than providing the treatment and cure. This registry, along with other registries that track immunizations, treatment and prevalence related to childhood diseases, will provide valuable information and data regarding effective prevention, intervention and treatment strategies, especially when dealing with pandemic diseases. Aloha,

Been waiting for this a long time. Started practicing Pediatrics at Kalihi-Palama Health Center over twenty years ago. For the underserved children who needed medical care, holding onto that "yellow card" never was a priority amongst all the other issues that had to be dealt with. Calling other doctors for shot records, waiting for the faxes and checking with the hospitals didn't seem particularly efficient or effective.

The concept of "implied consent" is critical to the Hawaii Immunization Registry. Without the ready transfer of vaccination information between providers, the system is basically crippled from the start. The two areas most harmed include the functionality of the registry and the trust from the very providers that should benefit the most. If parents or guardians must "Opt-In" the information becomes piecemeal where the system can no longer "Connect the Dots".

SB2729 is a move towards a better way to access immunization information in Hawaii.

#### RE: SB 2729 – Relating to Immunization

Dear Chair Ige, Vice Chair Green, and Members of the Committee:

My name is Robert Witt and I am executive director of the Hawaii Association of Independent Schools (HAIS), which represents 99 private and independent schools in Hawaii and educates over 33,000 students statewide.

The Association is in support of Senate Bill 2729 – Relating to Immunization which authorizes the Department of Health to establish and maintain a single repository of immunization records to be designated as the "Hawaii Immunization Registry" in order to aid, coordinate, and help promote efficient and cost-effective screening, prevention, and control of vaccine preventable diseases, including pandemic influenza.

The Hawaii Immunization Registry (HIR) will help to ensure that all of Hawaii's people are protected from vaccine-preventable diseases. HIR has the capability to store and track immunization information, consolidate immunizations given by multiple providers into one record and make them available to authorized immunization providers.

The Registry will not require any additional reporting by schools; it will reduce school personnel workloads by allowing authorized school personnel access to student immunization information to quickly and easily determine a student's compliance with Hawaii's mandatory student immunization requirements.

HAIS believes that establishment of the Hawaii Immunization Registry will protect the health and safety of the public as well as an individual's right to privacy and the protection of confidential information.
