#### SENATE BILL NO. 2780 RELATING TO AGRICULTURAL LANDS

Chair Hee, Vice Chair Tokuda, and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 2780. The Department of Agriculture offers comments.

The proposed amendments to statutes relating to real property leases and the State land use district boundary amendment process appear to be in response to concern that prime agricultural lands and bona fide farming activities are being inadequately protected, and that the counties are not fulfilling their role as described in Act 183. County identification of potential IAL is fundamental to protecting agricultural land as intended in the IAL Act. To date, only Kauai County has begun a process to identify potential IAL in consonance with the process described in the IAL Act.

The purpose of this bill is to carry out Article XI, Section 3 of the Hawaii Constitution but limits the effect of the amendments to Oahu. As the constitutional mandate is statewide, so should the effect of the proposed amendments.

The bill amends Chapter 519 (real property leases) by mandating an extension of an existing lease if it already provides for renegotiation and the lessee has made or plans to make substantial improvements to the leased land. The extension of the existing lease in this situation is to be no less than 75 percent of the original lease term. This raises three concerns:

- Does this requirement result in an unconstitutional impairment of existing contracts?
- 2. It appears this amendment would not apply to those leasehold farms such as truck farms that have no substantial improvements other than irrigated and planted fields (what is substantial?)
- 3. This amendment may have the adverse unintended consequence of causing owners of agricultural lands with "A" and "B" soils to not offer leases with a provision for renegotiation, or not allow substantial improvements to the leased land.

This bill amends Section 205-3.1 by repealing the counties authority to approve boundary amendment petitions for agricultural parcels less than 15 acres and containing "A" and "B" rated soils. The amendment to Section 205-4 prevents the Land Use Com mission (LUC) from reclassifying agricultural lands with "A" and "B" ratings if it meets four criteria selected to protect agricultural activities and resources from urbanization. We will defer judgment on these two amendments until we have an opportunity to confer with the counties and the LUC on the effect of these proposed changes.

In the past year, nearly 31,000 acres of highly productive agricultural land on the islands of Kauai and Maui have been voluntarily identified by a private landowner and designated by the Land Use Commission (LUC) as IAL. This represents 31 percent of the approximately 100 thousand acres of agricultural land in active crop production in Hawaii (excluding cattle ranching). Farmers who lease their crop production land may also seek IAL designation, with the consent of the landowner. We are hopeful that other landowners and farmers will follow suit in a timely manner.

Aloha, 'ano'ai, Chairman Hee and members of the Committee,

Thank you for allowing me the opportunity to present testimony this afternoon, and ask that you concur with me in support of this bill that protects all prime agriculture lands, namely all classified A and B lands on O'ahu. Mr. chairman, I cannot stress more the importance of preserving these prime agriculture lands.

My name is Glenn Oamilda, born and raised in Waipahu on the O'ahu sugar plantation, now residing in nearby 'Ewa Beach, where for the last twenty-five (25) years I have remained active and continue to be involved in community organizations and activities, political, social and cultural, with greater concerns over development issues and problems that have directly impacted my community and the greater 'Ewa region.

Mr. Chairman, the land, the 'aina, is our most important commodity we will ever own. Early Hawaiians thrived as an agriculture society; then Westerners came to Hawai'i and found cash in pineapple and sugar; proven not profitable, now tourism has replaced agriculture. However lately, tourism has fallen on lean times. I think we have learned from these experiences. We should be diligent, cognizant and aware that one day we will have no other choice but look toward and rely highly on agricultural lands for subsistence.

For nearly three generations my family lived on the sugar plantation that supported, sustained and maintained my family of eight children. The accumulative years of service totaled over a century, who toiled and worked those sugar fields, starting with my grandfather, my father (each retired after forty-eight years), and lastly, my brother. My wife's family, too, lived on the sugar plantation. Her father and grandfather worked for the 'Ewa plantation, bother each retired after forty



years of service.

So you see Mr. Chairman, I think agriculture lands will be the economic engine that will drive our subsistence and survival. Vote to pass this Bill.

My name is Dr. Kioni Dudley. I am the president of the Friends of Makakilo. We have more than 500 members. I am authorized to speak for those members.

I was also an intervenor at the Land Use Commission hearings when the Ho'opili project was discussed and their petition was declared to be deficient.

I speak in support of this bill. It is necessary because we have lost too much of our agricultural land already. If we don't preserve what we have left, we will not be able to survive on this island.

All of the A and B lands in Waianae, Kunia, the North Shore, and Waimanalo are taken.

All of the A and B lands in the central area are covered over with Miliani, Waipio Gentry, Waikele, Village Park, and Royal Kunia.

Much of the good land on the Ewa plain is covered over with Kapolei, Ewa by Gentry, and other Jevelopments.

The north shore can only grow things that don't touch the ground because of the water from Lake Wilson – sewer water for decades.

What is left? Ho'opili Koa Ridge Waiawa Some Castle and Cooke and by Dole tourist shops.

DOH forbids growing vegetables on land irrigated by Lake Wilson water.

If these lands go, we will lose about 1/2 of the fresh vegetables grown in Hawaii.

The State Constitution gives the legislature the task of preserving our agricultural lands. Aloha Chair Hee, Vice Chair Tokuda and Members of the Committee

<u>Description</u>: SB 2780 protects agriculturally suitable lands on Oahu (lands with productivity ratings of "A" or "B"). Provides for mandatory extension of agricultural leases

<u>Life of the Land</u> is Hawai'i's own energy, environmental and community action group advocating for the people and 'aina for four decades. Our mission is to preserve and protect the life of the land through sound energy and land use policies and to promote open government through research, education, advocacy and, when necessary, litigation.

Analysis: According to the bill the acres of class A&B lands in Hawaii has decreased from 360,000 (1960) to 172,000 (2007), a decrease of 186,000 acres in 37 years or an average of 5000 acres/years. Projecting forward, with the same loss rate, we will have no A&B land left in 35 years (2042).

According to the bill the acres of cultivation land on Oahu declined from 125,000 (1982) to 70,000 (2005), a decrease of 55,000 acres over a 23 year period, or 2400/year. Projecting forward, with the same loss rate, Oahu will have no land under cultivation in 29 years (2034)

#### **TESTIMONY IN SUPPORT FOR SB 2780**

Aloha Chair Hee and Members of the Committees:

The Hawai'i Chapter of the Sierra Club supports SB 2780, which could be considered a required moratorium on the development of O'ahu's dwindling supply of agricultural land.

As development pressure continues to increase, and lands needed to provide our people with food and energy are being lost to speculation, we need to start taking unprecedented steps -- like this measure -- to protect our remaining agricultural land. We have to stop giving away the farm.

Agricultural lands currently in use or with excellent potential for agricultural productions are a finite and irreplaceable resource in Hawai`i. There has been a steady decline in the number of acres in Agricultural District statewide and on Oʻahu. Since 1991, approximately 3,297 acres of "A" and "B" rated lands have been lost on Oʻahu alone. Approximately 10,900 acres of farm land of this quality are estimated to remain on Oʻahu.¹ Two large development proposals are currently planning to develop large portions of this remaining agricultural land (Koa Ridge would be equivalent to 5% of the remaining land alone).

As you may be aware, Hawai'i imports close to 90% of its food supply. As the cost of oil increases, we must prepare for the day when it may no longer be economical to ship in our food. That type of tragedy would dwarf the small economic potential of developing parking spots and urban sprawl on this land today.

Thank you for this opportunity to provide testimony.

- > In addition Hawaii is unique among the fifty states in that more than 90 percent of its
- > energy comes from oil. Because we are isolated geographically, Hawaii cannot
- > draw power from neighboring states and also must import every
- > barrel of oil and ton of coal it uses. This lack fuel independence makes the preservation of AG lands for biomass fuels as well as food all the more urgent.

> Global warming is not going away and neither is it's effects on weather conditions, making the threat of extreme weather of all kinds more likely. We as a State are not prepared for a major disaster. Like Haiti we are an island State. Unlike Haiti we are even more remote from help.

>

> We have already paved much of paradise and put up many parking lots. The developers and real estate moguls have argued that residential development in Central Oahu, the Leeward Coast and the North Shore will create jobs, provide affordable homes for future generations and be "green."

>

> These arguments are a sleight of hand designed to direct your/our attention away from the dire consequences of continuing down the beaten path. First, the jobs that would be created will dry up when residential project development is over, which must happen at some point as land here is a very finite resource. Secondly, try and get the developers to give you a price for an "affordable" three bedroom home. They will hedge and try to avoid the question. By my calculations these so-called affordable homes will range from \$400,000 to \$600,000. So I ask for whom are these homes affordable? Certainly not those most in need of housing. Third - green communities - really? Not when the mere existence of these communities takes away agricultural land forever.

> I believe we must stop urban sprawl on this island. The plan should be to build up in the already urbanized areas, not out into what is left of our open spaces and agricultural lands. It is said that when tribal native American elders met to consider matters of importance they weighed the results of their decisions out to the seventh generation. We must do likewise and consider the future of our fragile and beautiful islands.



Opposition to SB 2780 Relating to Agricultural Lands (Alteration of agricultural leases and boundary amendment prohibition)

LURF's OBJECTIONS to Mandatory Extension of Agricultural leases and prohibition on amendment of land use district boundary). SB 2780 changes the terms of existing Agricultural leases by mandating the extension of leases on Class A or B agricultural lands for a period not less than 75% of the original lease term if the lessee has made improvements, or is seeking to make improvements. The bill also prohibits the landowner from amending the land use district boundary of such lands under certain criteria.

LURF respectfully **opposes SB 2780**, based on, among other things, the following:

- Unintended negative consequences for farmers prohibition on construction of farm improvements and revocation of long-term agricultural leases. LURF supports the conservation and protection of important agricultural lands and supports the IAL law, however, this bill is unconstitutional, unfair, and will likely cause unintended negative consequences for farmers - In order to avoid the mandatory lease extensions, some landowners may prohibit farm improvements, cancel existing long-term agricultural leases, or require month-to-month revocable licenses for all of their A and B agricultural lands.
- ➤ Unintended negative consequences for farmers Limitation of active farming operations. LURF supports and encourages active farming operations on IAL, however, Part II of this bill is unconstitutional, unfair and will likely cause unintended negative consequences for farmers In order to retain the flexibility to file a future district boundary amendment, some landowners others may cease active farming operations on much of their A and B agricultural lands.
- > Unconstitutional violation of the Contracts Clause of the U.S. Constitution. SB 27680 illegally impairs existing Agricultural lease contracts, because it <u>alters the terms of existing leases</u> by creating a new right, requiring new conditions favorable to lessees and imposing different liabilities (lease extension for not less than 75% of the original term).
