TESTIMONY IN OPPOSITION OF SENATE BILL 2843 SD2 RELATING TO FLAGS

Aloha Representatives Angus L.K. McKelvey, Chair, Isaac W. Choy, Vice Chair, and members of the Committee. My name is Fred Ballard, President Oahu Veterans Council. The Oahu Veterans Council is comprised of over 35 Oahu veteran organizations that in turn represent over 80,000 veterans and their families.

The Council strongly supported SB 2843 that stated "If a building is under jurisdiction of the State, including the state department of defense state headquarters building... the POW/MIA flag shall be flown under the flag of the United States of America." SB 2843 SD2 modified the bill to include <u>only</u> state department of defense (DoD) buildings. The Council believes that the POW/MIA flag should fly over <u>all</u> state buildings including DoD buildings. The Council also believes that if passed, the take effect date should be July 1, 2011, not 30 years later on 2040.

The flag is a symbol of those who have not returned. The possibility of becoming a prisoner of war, or missing in action is ever present as our troops continue to serve our country. In the words of the Pearl Harbor Survivors, "We will never forget," the same can be said for our POW's and Missing in Action. The flag is a constant reminder of their sacrifice and hope that they will come home. That flag deserves to fly on state buildings now, not 30 years from now. The Oahu Veterans Council opposes SB 2843 SD2 in its present form; however, would support it if amended to include all state building and an effective date of 2011.

RE: Senate Bill SB 2843 SD2, RELATING TO FLAGS (POW/MIA Flag)

Aloha Chairman McKelvey and Vice Chair Choy, and Members of the Committee.

The Johnson Family, Bob, Billy, Betty and Eleanor appreciate your interest and continued discussion about the requirement of flying the **POW/MIA Fag** in Hawaii. However, we <u>do not</u> support the <u>content</u> of SB 2843, sd2 that restricts the flying of the **POW/MIA** Flag to only buildings under the jurisdiction of the State Department of Defense (DoD).

This limitation is contrary to the bill's intent to appropriately honor and give tribute to American Prisoners of War and military personnel who are Missing in Action. Hawaii is home to the Pacific Command, the front line of defense for the Asia-Pacific Region. Few or no other State can claim that it is supported by four component commands: U.S. Pacific Fleet, U.S. Pacific Air Forces, U.S. Army Pacific, and U.S. Marine Forces Pacific. These commands are headquartered in Hawai'i and have forces stationed and deployed throughout the region that spans the waters off the west coast of the U.S. to the western border of India, and from Antarctica to the North Pole. Hawaii's general public as well as visitors and the military community have good reason to see the **POW/MIA Flag** flown at the Hawaii State Capitol and other State buildings, and the DoD Headquarters.

Records support there is approximately 118,000+ Veterans in Hawaii; an estimated 54,528 military personnel and 59,606 military dependents for a total of 168,662 living in Hawaii. Hawaii's economy relies significantly on the military. Thousands of Hawaii's families such as ours have loved ones and friends who sacrificed their life for our Country and have never returned home.

Hawaii should be mindful and considerate of what we owe our **POW/MIAs** and their loved ones. It should be done in affirmation of our strongest belief as a people; that every life is precious. It would be heartening and respectful to those who are currently serving in our military who put their life in harm's way each day and to their families to witness the **POW/MIA Flag** flying at the Hawaii State Capitol Building and knowing that they will never be forgotten.

The **POW/MIA Flag** conveys to the World that Hawaii remembers the sacrifices and service of our loved ones and trust that they will return home. The Flag's presence is an unwavering reminder of the thousands of courageous Americans who were officially captured and interred as Prisoners of War and those who remain missing and unaccounted for and held captive against their will by our enemies of Freedom. Those brave American men and women sacrificed their freedom to defend liberty for all of us.

The **POW/MIA Flag** does not represent any State, military branch, or any other specific group. The Flag belongs to everyone; it is a meaningful symbol that powerfully reminds; "YOU ARE NOT FORGOTTEN".

Betty and Bob have been married for 61 years. Bob a former Marine; Billy a former Marine, decorated 100%DAV; Betty a former Hollywood USO Volunteer; three of Bob's brother-in-laws (all decorated) served in the Marine Corps, 2 were DAV's and 1 MIA; his only brother sustained serious combat wounds, was a decorated POW. Bob's uncle Marine Corps MIA. Betty's sister was a USO Hollywood volunteer during World War II. Betty's brother was a decorated fighter pilot (Ace) and her brother-in-law was a decorated Marine Corps DAV. In the younger generation there are 2 DAV's. The Johnson Family is proud of their military service.

The Johnson Family respectfully request that this bill be amended to reflect that the <u>original</u> language in SB 2843 and HB 2383, which states that "if a building is under the jurisdiction of the State, including the state department of defense state headquarters building, and the Hawaiian flag is flown under the same or a separate halyard as the flag of the United States of America, the Prisoner of War/Missing In Action Flag shall be flown under the flag of the United States of America."
