Dear Committee Members,

Mahalo for allowing additional comments to your decision of whether The National Tissue and Organ Donor Registry Known as UNOS would provide HIV positive patients with a chance to RECEIVE the gift of life.

I have been sending in articles as well as being in contact with UNOS and come to the conclusion that there is no Rule or Law that stops States from allowing transplants of organs or tissue into an HIV recipient. I have seen at

least 2000 Cases reporting successful transplants since 2005. I got my information from John Hopkins University, Drexel University College of Medicine, The New England Journal Of Medicine, POZ Magazine, and Dept of Health and Welfare in Idaho, among others.

As you have said Senator Ige in stand committee report 2206, "Thanks to ground breaking research HIV infections is no longer an impenetrable barrier to a successful transplant. Given these developments, your health committee found that this measure will save lives and further prevent discrimination against those living with HIV."
