## Re: SB411, SD1, Relating to Ka'ena Point State Park

## **Testimony in Opposition**

Chair Ito and Vice Chair Har, and members of the Committee on Land, Water, & Ocean Resources. My name is George Massengale and I am a long time member of the Hawai'i Audubon Society and during session I serve as their legislative analyst. We're happy to be here today to offer testimony in opposition of SB411, SD1, which would permit overnight camping at Ka'ena Point State Park

The Hawai'i Audubon Society was founded in 1939, and it is Hawai'i's oldest conservation organization. The primary missions of the society is to foster community values that result in the protection and restoration of native ecosystems and conservation of natural resources through education, science and advocacy in Hawaii and the Pacific

The Ka'ena Point Natural Area Reserve protects a vital sand dune and boulder slope ecosystem that harbors many native Hawaiian plant species. In addition seabirds, such as the wedge-tailed shearwater, both the red-footed & brown boobies, and the brown noddy can be seen off shore at Ka'ena. The reserve provides refuge and a nesting area for the Laysan albatross, and is a potential nesting site for the green sea turtle and Hawaiian monk seal. During the winter breeding season, humpback whales will frequent the waters surrounding the point.

One of the Reserve's greatest success stories has been the U.S. Fish & Wildlife Service funded Ecosystem Restoration Project that has focused on alien species removal and native plant reintroduction. This has resulted in the recovery of the endangered "Moli" or Laysan albatross.



Ka'ena Point is an excellent example of the type of ecosystem that can be found in Northwestern Hawaiian Islands. The difference is that anyone on O'ahu can drive to Ka'ena Point to see the spectacular display of plants and animals.

Ka'ena Point is also a cultural resource for many of our residents who can trace their ancestors to this special place. Within the reserve is leina a ka'uhane (Spirit Leap) which is considered to be a wahi pana, a legendary place. Early Hawaiians used Ka'ena Point for fishing and feather collecting.

The Audubon Society, which strongly believes in stewardship, has concerns that allowing unregulated overnight camping would have a deleterious impact on the preserve and the many endangered wildlife species. We have additional concerns, especially given our state's economic situation, that DLNR would be **unable to adequately enforce rules prohibiting interference** with endangered marine and bird species and the destruction of critical habitat. Let's not jeopardize what has taken so long to accomplish.

We respectfully request that SB411, SD1, be deferred. Sincerely,
