In consideration of SENATE BILL 638, SENATE DRAFT 2 RELATING TO PUBLIC LANDS

Senate Bill Number 638, Senate Draft 2 proposes to establish a two-year moratorium on evictions and establish a master plan advisory committee for Kahana Valley (Valley).

As the Legislature considers a variety of ideas for Kahana, the Department of Land and Natural Resources is asking that the solution be guided by the original purpose for which the Valley was purchased, as a public park. The Valley was acquired for the benefit and enjoyment of all, and it is important that, as a public park, Kahana should provide a welcoming environment for all who visit. The Valley was purchased to protect it from development, and any solution should limit future development.

The Office of Hawaiian Affairs <u>SUPPORTS</u> SB 638, SD2, which would establish a two-year moratorium on evictions of residents from Kahana Valley State Park, and would establish a planning council to create a living park master plan for Kahana Valley State Park.

OHA recognizes the unique opportunity presented at Kahana Valley, where an entire ahupua'a is under the sole ownership of the State of Hawai'i. Thus, the resources within this ahupua'a can be comprehensively managed from the mountains to the sea, ensuring that they will be available for generations to come. OHA also supports the residents of Kahana Valley, who have faithfully and respectfully worked to preserve and restore the area's resources, and shared the history and traditions of this special place with the larger community.

The completion of a living park master plan by an advisory committee, consisting of members who represent all of those who have an interest in protecting Kahana Valley, will be especially critical in providing the community with the opportunity to effectively manage this ahupua'a into the future.

Chair Ito and Members of the Committee:

The Department of Attorney General has concerns with this bill. This bill establishes a two-year moratorium on evictions of persons who have resided in Kahana Valley State Park continuously since before 1987 and who have participated in interpretative programs for This bill implicates Article XI, section 5, of the Hawaii Constitution, which provides that:

> The legislative power over the lands owned by or under the control of the State and its political subdivisions shall be exercised only by general laws, except in respect to transfers to or for the use of the State, or a political subdivision, or any department or agency thereof.

The bill involves land owned by the State, singles out one parcel of land in a specific locale, and allows only certain identifiable persons who meet qualifications uniquely applicable to them to continue to reside on park lands at least during a two-year moratorium on evictions, thus allowing these persons to use lands under the control of the State. The bill is vulnerable to challenge because the bill only contemplates applicability to a certain group of persons who because of their past circumstances are allowed to use state lands. other persons are included as possible beneficiaries of the bill.

classification of persons allowed to benefit from the moratorium is factually limited to those already benefitting from the use of the state lands; the moratorium has no potential applicability to persons other than those who already qualify. For these reasons, we believe that this bill is vulnerable to challenge as being special legislation. See Sierra Club v. Dept. of Transportation, S.C. No. 29035 (March 16, 2009).

We also have concern with section 3(b) of the bill, which establishes a planning council. The council appears to be an executive branch board inasmuch as it is placed within the Department of Land and Natural Resources for administrative purposes. However, with the exception of the chairperson of the Board of Land and Natural Resources, none of the other members is an appointee of the Governor.
