Aloha Representatives,

Thank you for this opportunity to testify regarding SCR 76, which requests the state Department of Transportation to coordinate a study and recommend changes to laws to accommodate the safe and proper operation of bicycles, segways and mopeds.

Bicycling is an effective and fun way to commute, do errands and get exercise. According to the League of American Bicyclists, bicycle commuting in Honolulu increased 23% from 2000 to 2008. As mentioned in the American Bicyclist January/February 2010 issue, examples of successful laws and policies in other U.S. locations include:

- Arizona all state employees who drive a state vehicle must complete driver training on the legal and safe ways of interacting on roadways;
- San Francisco, CA the city partners with San Francisco Bicycle Coalition's education program for various professional drivers including taxi, USPS and other delivery drivers;
- Austin, TX Municipal court mandates the League Cycling Instructor motor course to motorists cited for illegal behavior toward cyclists;
- San Luis Obispo, CA all major intersections are equipped with bike-sensitive loop or camera detection systems; and
- Tempe, Arizona special emphasis is placed on a traffic calming policy with a
 goal to move more people at the same time rather than to add motor vehicle
 capacity.
